



In reply to the request of your office, the following report is submitted on the enrolled enactment S. 435 "To amend Section 301(b)(7) of the Agricultural Adjustment Act of 1938, as amended, to change the marketing year for wheat from July 1-June 30, to June 1-May 31."

This Department recommends that the President approve the bill.

Technology associated with wheat production has greatly advanced the time of wheat harvest; in some years as much as 40 percent of the winter wheat crop is harvested prior to July 1. The shift of the marketing year to begin June 1 is a rational change which has the active support of the Department's data users. Upon enactment of this bill, the Department plans to shift the date of its summer quarter grain stocks survey to June 1 from July 1 for all commodities, beginning in 1976.

The Committee on Agriculture, to whom was referred the bill (S. 435), to amend section 301(b)(7) of the Agricultural Adjustment Act of 1938, as amended, to change the marketing year for wheat from July 1-June 30, to June 1-May 31, having considered the same, report favorably thereon without amendment and recommend that the bill do pass.

Purpose

S. 435 changes the marketing year for wheat to the period June 1 through May 31 from July 1 through June 30, as currently provided for in the Agricultural Adjustment Act of 1938, as amended.

NEED FOR THE LEGISLATION

The marketing year for wheat is changed in the bill to reflect changes that have occurred in wheat production over the course of the last number of years. Technology associated with wheat production has greatly advanced the time of wheat harvest with as much as 40 percent of the winter wheat crop harvested in some years prior to July 1.

The marketing year is used by the Department in relating wheat statistics to the harvesting and marketing of the annual crop and in making supply and demand estimates for wheat. The change in the beginning of the marketing year would make the U.S. Department of Agriculture's statistical summary of the wheat situation more accurate, particularly it would make its estimates of year-end wheat carryover stocks more representative of actual market conditions. Under the existing July-June marketing year, the statistical summary often presents an inaccurate statement of the supply availability since a significant amount of the new crop is processed and exported prior to July 1.

The Committee does not believe that the change in the marketing year would have an adverse effect on deficiency and disaster payments for wheat under the Agricultural Act of 1949. Payments are related to the difference between the target price for wheat of \$2.05 per bushel (as adjusted for the 1976 and 1977 crops) and the market prices during the first 5 months of the marketing year—July thru November under the current law, June thru October under S. 435. The bill would have the effect of substituting the month of June for the month of November in the formula. The price of wheat has been lower more frequently in June in the past than in November. However, it is believed in the future the price could go either way depending on supply and demand situations.

COMMITTEE CONSIDERATION

The Subcommittee on Livestock and Grains met to consider S. 435 on May 20 and June 13, 1975. Testimony was received in support of the bill from a spokesman for the U.S. Department of Agriculture. Statements were also submitted in support of the bill by the American Farm Bureau Federation and the National Association of Wheat Growers. In its consideration of the bill a question was raised concerning the effect that the change in the marketing year would have on the rate of payments which may be received by wheat producers as deficiency payments under the wheat program. A compilation was obtained of the average prices received by farmers for wheat for the 20-year period, 1955 through 1974. During this period the November price was higher than the June price in 16 years and the June price was higher than the November price in only 4 of the years involved. Thus, if the market price for wheat should fall below the target price of \$2.05 per bushel (as adjusted for 1976 and 1977), it appears unlikely that the deficiency payments would be reduced as a result of the change in the marketing year, as provided for in S. 435.

The Committee considered making the bill effective on June 1, 1976, but decided to report the bill without amendment, since it was determined that it would not cause any difficulties in administration of the wheat program if S. 435 were to become effective with the marketing year beginning June 1, 1975.

The bill was ordered favorably reported by the Subcommittee by a unanimous vote and similarly was ordered reported by the full Committee on June 26 by a unanimous voice vote, both actions having been taken in the presence of a quorum.

Administration Position

On May 19, 1975, Richard A. Ashworth, Deputy Under Secretary of Agriculture, submitted the following letter in support of S. 435:

DEAR MR. CHAIRMAN: This will reply to your request of May 2, 1975 for a report on S. 435, a bill "To amend section 301(b)(7) of the Agricultural Adjustment Act of 1938, as amended, to change the marketing year for wheat from July 1-June 30, to June 1-May 31."

The Department supports the passage of the bill.

The proposed change has a great deal of merit. Technology associated with wheat production has greatly advanced the time of wheat harvest with as much as 40 percent of the winter wheat crop harvested in some years prior to July 1. In most years, a significant amount of new crop wheat is processed or exported prior to July 1, and this creates serious unknowns as to the utilization of the grain for individual crop years. The shift of the marketing year to begin June 1 would minimize the utilization unknowns associated with individual crop years. The harvest of durum wheat and other spring wheat does not present similar problems because of the timing of spring wheat harvest.

The designation of June 1 as the beginning of the marketing year for wheat would require the conduct of a wheat stocks survey as of June 1. This survey is now conducted as of July 1 as an integral part of the stocks survey for the other grain and oilseed commodities for which stocks data are provided. As soon as feasible after enactment of the bill, it is proposed to shift the date of the stocks survey for all commodities concerned to June 1. A shift to June 1 should present no additional problems in the collection of farm and off-farm stocks, as the same basic survey procedures followed on July 1 would also be used for a June 1 survey. The shift of all commodities would not involve additional costs to the Department.

It will not be practical at this date to shift all commodities to the June 1 date in 1975. If the legislation is passed, it is proposed to maintain the July 1 stocks survey date for wheat and all other commodities in 1975 and to shift all commodities to a June 1 date in 1976 at no additional cost.

The Office of Management and Budget advises that there is no objection to the presentation of this report from the standpoint of the Administration's program.

CURRENT AND FIVE SUBSEQUENT FISCAL YEAR COST ESTIMATE

Pursuant to clause 7 of Rule XIII of the Rules of the House of Representatives, the Committee estimates that there should not be any additional cost incurred by the Federal Government during the current and the five subsequent fiscal years as a result of the enactment of S. 435. A shift in the date for the beginning of the marketing year should not result in additional costs in the collection of statistics for the computation needed to make supply and demand estimates. The Committee is unable to determine whether the bill will result in any increase in deficiency payments since market prices are currently above the level of target prices and it is not clear to what extent, if any, market prices might fall below target prices, in the future and if so whether the price of wheat in June would be different than the price of wheat in November.

The same cost estimate was submitted to the Committee by the Department of Agriculture.

INFLATIONARY IMPACT STATEMENT

Pursuant to clause 2(1)(4), Rule XI of the Rules of the House of Representatives, the Committee estimates that enactment of S. 435 will have no inflationary impact on the national economy.

BUDGET ACT COMPLIANCE (SECTION 208 AND SECTION 403)

The provisions of clause 1(3)(B) and clause 1(3)(C) of Rule XI of the House of Representatives and section 308(a) and section 403 of the Congressional Budget Act of 1974 (relating to estimates of new budget authority or new or increased tax expenditures and the estimate and comparison prepared by the Director of the Congressional Budget Office), are not considered applicable because the bill should have no effect on existing spending estimates for fiscal year 1976.

OVERSIGHT STATEMENT

No summary of oversight findings and recommendations made by the Committee on Government Operations under clause 2(b)(2) of Rule X of the Rules of the House of Representatives was available to the Committee with reference to the subject matter specifically addressed by S. 435.

No specific oversight activities, other than the hearings accompanying the Committee's consideration of S. 435 and related bills, were made by the Committee, within the definition of Rule XI of the House of Representatives.


