Reference is made to your request for the views of the Department of Defense with respect to the enrolled enactment of H.R. 8151, 94th Congress, a bill "To authorize the President of the United States to present in the name of Congress, a Medal to Brigadier General Charles E. Yeager, USAF (Retired)." The Secretary of Defense has delegated to the Department of the Air Force the responsibility for expressing the views of the Department of Defense.

The Department of the Air Force, on behalf of the Department of Defense, recommends that this bill be signed by the President. REPORT

[To accompany H.R. 8151]

The Committee on Banking, Housing and Urban Affairs, to which was referred the bill (H.R. 8151) to authorize the President of the United States to present in the name of Congress a medal to Brig. Gen. Charles E. Yeager, having considered the same, reports favorably thereon without amendment and recommends that the bill do pass.

GENERAL STATEMENT

Introduced in the House of Representatives on June 23, 1975, H.R. 8151 was passed by the House on October 20, 1975. A total of nineteen similar bills honoring Brig. Gen. Charles E. Yeager were proposed in the House of Representatives. The House Committee on Banking, Currency and Housing held hearings on H.R. 8151 on September 23, 1975 and reported the bill out, without amendment, shortly thereafter.

The bill would authorize the President to present a silver medal, equivalent to a noncombat Medal of Honor, to Brig. Gen. Charles E. Yeager for his accomplishments with the XS-1 research airplane and for being the first man to fly an aircraft faster than the speed of sound. The legislation would authorize and direct the Secretary of the Treasury to cause the medal to be struck and furnished to the President. The medal's emblems, devices and inscriptions are to be determined by the Secretary of the Air Force with the approval of the Secretary of the Treasury. For the purpose of designing and manufacturing this medal, the bill would authorize the sum of \$5,500 to be appropriated. It would also authorize the Secretary to manufacture and sell to the general public bronze duplicates of the medal at a price sufficient to cover the cost of manufacture. The facilities of the Bureau of the Mint would be utilized for the purpose of designing and striking this medal. 2

For the purpose of designing and manufacturing the medal, which would be equivalent to a noncombat Medal of Honor, the bill would authorize the sum of \$5,500 to be appropriated. It would also authorize the Secretary to manufacture and sell to the general public bronze duplicates of the medal at a price sufficient to cover the cost of manufacture, including labor.

The Department has no comments to make on the merits of H.R. 8151. The facilities of the Bureau of the Minte would be made available for the purpose of designing and striking this medal. The appropriation of \$5,500, which would be authorized by the bill, would be sufficient to cover the cost of the medal, including the preparation of designs, models and master dies. The Department would have no objection to adding this medal to those regularly struck for sale to the public, as provided in section 2 of the bill.

The Department was advised by the Office of Management and Budget that there was no objection from the standpoint of the administration's program to the submission to the House Committee on Banking, Currency and Housing of an identical report on H.R. 8051, an identical bill.

Yeager, United States Air Force, an appropriate silver medal, equivalent to a noncombat Medal of Honor, for contributing immeasurably to aerospace science by risking his life in piloting the XS-1 research airplane faster than the speed of sound on October 14, 1947. For such purpose the Secretary of the Treasury is authorized and directed to cause to be struck a silver medal with suitable emblems, devices, and inscriptions to be determined by the Secretary of the Air Force subject to the approval of the Secretary of the Treasury. There is hereby authorized to be appropriated the sum of \$5,500 for this purpose.

SEC. 2. The Secretary of the Treasury shall cause duplicates in bronze of such medal to be coined and sold, under such regulations as he may prescribe, at a price sufficient to cover the cost thereof (including labor), and the appropriations used in carrying out the provisions of this section shall be reimbursed out of the proceeds of such sale.
