SUBJECT: H.R. 10555 - Relief of Mrika Mrnacaj

Attached for your consideration is H.R. 10555, sponsored by Representative Biaggi, which would make a special grant of eligibility for naturalization as a United States citizen to the beneficiary, an 111 year old native and citizen of Albania. The enrolled bill would waive the time consuming requirements of the Immigration and Nationality Act for naturalization of permanent resident aliens.

Additional information is provided in OMB's enrolled bill at Tab A.

To make a special grant of eligibility for naturalization as a United States citizen to an aged permanent resident alien.

Discussion

The enrolled bill declares that the beneficiary has satisfied the naturalization requirements of the Immigration and Nationality Act relating to understanding of the English language, history, principles and form of government of the United States, as well as periods of residence and physical presence within the United States. Mrs. Mrnacaj is, therefore, eligible for naturalization as a United States citizen.

Mrs. Mrika Mrnacaj is an 111 year old native and citizen of Albania, who was admitted to the United States on September 10, 1974 and was granted permanent residence status on November 3, 1975. She presently resides with her son, a naturalized United



States citizen, in New York City. Because Mrs. Mrnacaj's life expectancy is short and in recognition of her desire to vote in a national election prior to her death, the enrolled bill waives, in her behalf, the time consuming requirements of the Immigration and Nationality Act for naturalization of permanent resident aliens.



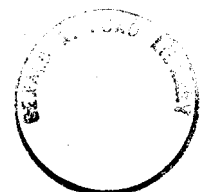
H. R. 10555 - Private Bill
Relief for Mrika Mrnacaj

Our office received a call from Peter Ilchuk of Rep. Mario Biaggi's office (D-N. Y.), urging that the President sign Private Bill H. R. 10555 as soon as possible. The bill was passed by the House on December 16th and by the Senate on December 17th but has not reached the White House as yet.

This bill is an immigration matter; the woman is 111 years old and wants to become an American Citizen before she dies. We advised Mr. Ilchuk that we would pass the word on to the proper staff in order that quick action might be considered.

Subsequent to dictating this memorandum, Mr. Biaggi called Vern Loen personally to request that the President initiate a telephone call to Mrs. Mrnacaj as soon as the bill is signed. She is an Albanian who has lived in several countries in order to flee communism. This phone call also is recommended by Rep. Jack Wydler, a close friend of Biaggi. Mr. Biaggi has supported us on a number of key issues this year, including three override attempts.

If you think the phone call is worth pursuing, I will be glad to obtain further details and prepare a recommended telephone proposal.



An Act

For the relief of Mrika Mrnacaj.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That Mrika Mrnacaj shall be held and considered to have satisfied the requirements of sections 312 and 316 of the Immigration and Nationality Act relating to requirements as to understanding the English language, history, principles, and form of government of the United States and requirements as to periods of residence and physical presence within the United States, and, notwithstanding the provisions of section 310(d) of that Act, she may be naturalized at any time after the date of the enactment of this Act is she is otherwise eligible for naturalization under the Immigration and Nationality Act.
