#### Purpose

Amends the Canaveral National Seashore Act of 1975 to increase from five to six the membership of the Canaveral National Seashore Advisory Commission.

#### Agency Recommendations

Office of Management and Budget Approval

Department of the Interior Approval

#### Discussion

The Canaveral National Seashore Act of 1975 provided for a five-member advisory commission to be appointed by the Secretary of the Interior. The advisory commission has no administrative authority, but does consult with and advise the National Park Service with respect to the Canaveral National Seashore.

To date, the Secretary has appointed four members, two on the recommendation of the Governor of Florida and two members representing the two counties (Brevard and Volusia) in which the

seashore is located. However, Interior has informally advised that appointment of a fifth member representing the general public has been delayed because both Congressmen Chappell and Frey have sought to have their own candidates appointed to the advisory commission (the seashore is contained within their congressional districts).

The enrolled bill would resolve the problem cited above by increasing the commission's membership from five to six, and by stipulating that a representative of the general public be included from each county in which the seashore is located. As a practical matter, this will enable the Secretary to appoint a general public member from each congressional district.

This responds to your request for the views of this Department on H.R. 10370, "To amend the Act of January 3, 1975, establishing the Canaveral National Seashore."

We recommend that the President approve the bill.

#### AMENDING THE ACT OF JANUARY 3, 1975, ESTABLISHING THE CANAVERAL NATIONAL SEASHORE

JANUARY 30, 1976.—Committed to the Committee of the Whole House on the State of the Union and ordered to be printed

Mr. HALEY, from the Committee on Interior and Insular Affairs, submitted the following

#### REPORT

#### [To accompany H.R. 10370]

The Committee on Interior and Insular Affairs, to whom was referred the bill (H.R. 10370) to amend the Act of January 3, 1975, establishing the Canaveral National Seashore, having considered the same, report favorably thereon without amendment and recommend that the bill do pass.

#### PURPOSE

H.R. 10370<sup>1</sup> would amend the Act which established the Canaveral National Seashore in the State of Florida by adding a sixth member to the Advisory Commission for the seashore, and by specifying that the two members representing the general public be selected on the basis of one resident from each of the two affected counties.

#### BACKGROUND

The Canaveral National Seashore was established by Public Law 93-626, and among other things, provided for a five-member advisory commission for the seashore. The advisory commission has no administrative authority, but simply consults with and advises the National Park Service with respect to the National Seashore.

Although the advisory commission was chartered in March 1975, followed by the appointment of two members recommended by the Governor of Florida and two members representing the two counties in which the seashore is located (Brevard and Volusia), the fifth member who was to represent the "general public" has not been named. In order to facilitate activation of the commission, the sponsor of this

legislation and the Secretary of the Interior have recommended (1) that a sixth member be added to represent the general public, and (2) that the new member and the other member remaining to be designated be appointed one each from the two counties involved.

#### SECTION-BY-SECTION ANALYSIS

Section 1 of the bill amends the act establishing the Canaveral National Seashore to include a sixth member on the advisory commission. The act is further amended so that there would now be four members selected from within the two counties involved, and two members selected from within the State of Florida.

#### LEGISLATIVE HISTORY

The Subcommittee on National Parks and Recreation conducted hearings on H.R. 10370 on November 17, 1975. Representative Chappell explained the desire on the part of the residents in the vicinity of the National Seashore to have the two locally affected counties equally represented on the advisory commission. The Director of the National Park Service also testified at the hearing, and stated that there was no objection to the passage of H.R. 10370 by the Department of the Interior. The subcommittee ordered the bill reported without amendment on December 12, 1975.

#### COST AND BUDGET ACT COMPLIANCE

No additional authorization of funds is made by H.R. 10370. Members of the advisory commission serve without compensation, but do receive reimbursement for reasonable expenses incurred by Commission members in connection with their responsibilities. In this case, since the additional member is to be a local resident, such expenses should be minimal; consequently, there will be no significant impact made on the budget by H.R. 10370.

#### INFLATIONARY IMPACT

Passage of the legislation will have no inflationary impact.

#### OVERSIGHT STATEMENT

No recommendations were submitted to the committee pursuant to rule I, clause 2(b)(2).

#### COMMITTEE RECOMMENDATION

The Committee on Interior and Insular Affairs, meeting in open session on January 27, 1976, by voice vote, ordered H.R. 10370 to be favorably reported without amendment for the consideration of the House of Representatives.

(c) Members of the Commission shall serve without compensation, as such, but the Secretary may pay, upon vouchers signed by the Chairman, the expenses reasonably incurred by the Commission and its members in carrying out their responsibilities under this section.

The Committee on Interior and Insular Affairs, to which was referred the bill (H.R. 10370) to amend the act of January 3, 1975, establishing the Canaveral National Seashore, having considered the same, reports favorably thereon without amendment and recommends that the bill do pass.

#### PURPOSE OF THE MEASURE

H.R. 10370 would increase the membership of the Advisory Commission from the present five members, to six so that one member of the general public can be selected from each of the two counties in which the Seashore is located.

#### BACKGROUND

The Canaveral National Seashore was established by Public Law 93-626 which, among other things, provided for a five-member advisory commission for the seashore. The advisory commission has no administrative authority, but simply consults with and advises the National Park Service with respect to the National Seashore.

Although the advisory commission was chartered in March, 1975, followed by the appointment of two members recommended by the Governor of Florida and two members representing the two counties in which the seashore is located (Brevard and Volusia), the fifth member who was to represent the "general public" has not been named. In order to facilitate activation of the commission, the sponsor of this legislation and the Secretary of the Interior have recommended (1) that a sixth member be added to represent the general public, and (2) that the new member and the other member remaining to be designated by appointed one each from the two counties involved.

#### LEGISLATIVE HISTORY

This measure was passed by the House of Representatives on February 2, 1976 and was introduced in the Senate on February 3, 1976. The Subcommittee on Parks and Recreation conducted a hearing on July 27, 1976.

#### COMMITTEE RECOMMENDATION AND TABULATION OF VOTES

The Senate Committee on Interior and Insular Affairs, in open business session on August 5, 1976, by unanimous vote of a quorum present recommends that the Senate pass H.R. 10370 without amendment.

COST AND BUDGETARY CONSIDERATIONS

No additional authorization of funds is made by H.R. 10370.
