

Congressional Status Report

Shortly before the 1974 Congressional elections, the Presidential Personnel Office established a system by which the defeated and retiring Members of Congress and their staffs could be referred to federal agencies which might be interested in their employment. When a Member of Congress was referred to this office by the Congressional Liaison staff, they were interviewed by either Brad Patterson or Alan Woods. In that interview their specific interests as to department or agency were determined and their preference as to full time or part time employment was established. Following the interviews, it was established if vacancies existed in the relevant agencies commensurate to positions which might interest former Members of Congress. If such was the case, the Congressmen were put in touch with the proper individuals at these agencies and interviewed for the positions available. If any interest was expressed either on the part of the agency or the Members, we attempted to firm up a position as soon as possible.

As you will note from reading through the attached rundown of the status of individual Members of Congress, we were generally successful in at least being able to offer them a position, even if they were not interested in the particular position offered. We are making continuing efforts to assist those former Members who we were not able to help earlier, and are hopeful that most of them will be placed in the days ahead.

The following will give you the breakdown on the individuals who were referred to us as being interested in federal employment and the status of their request.

Les Arends. He desires a part time position and has been offered membership on the President's Foreign Intelligence Advisory Board.

Lamar Baker. Has accepted a six months consultancy with the Department of Transportation.

<u>Wallace Bennett.</u> Is being proposed for membership on the Board of the Overseas Private Investment Corporation (OPIC).

<u>William Bray.</u> Wants to be a member of the President's Foreign Intelligence Advisory Board. He has turned down offers for membership on the American Battle Monuments Commission, the Board of the Armed Forces Museum and the Board of Visitors for West Point.

Donald Brotzman. Will be nominated as Assistant Secretary of the Army for Manpower and Reserve Affairs.

Marlow Cook. Wanted a Federal judgeship but there are no Kentucky vacancies. He has announced he is going to practice law.

<u>Paul Cronin</u>. Prior to running again, he would like to serve as Chairman of the International Joint Commission, U.S. and Canada. Both he and Henry P. Smith will be proposed to the President to fill this vacancy.

<u>Charles Chamberlain</u>. Wants to be named a member of the St. Lawrence Seaway Advisory Board but it has no vacancy. Its Michigan member being an Independent, substituting Chamberlain for him would violate the statute prescribing that not more than three of its members can be of one political party. Chamberlain is considering the possibility of other alternatives and will be back in touch with us.

John Dellenback. Possibilities for him are being discussed with State and Defense.

<u>David Dennis</u>. Wanted a Federal judgeship but there was none in his immediate district. He is going back to Indiana to practice law.

Peter Dominick. Will be nominated as Ambassador to Switzerland.

<u>Harold Froelich</u>. Wants to be a member of the Federal Elections Commission, no decision has been made on this.

<u>Robert Hanrahan</u>. Has been offered and has accepted the post of Deputy Assistant Secretary of Education in HEW.

Orval Hansen. Wants a position in ERDA but certain legal questions must be resolved.

Larry Hogan. Will be proposed to the President as one of the candidates for the Board of Governors of the Postal Rate Commission.

Dan Kuykendall. Will be a consultant at Transportation.

<u>Richard Mallary</u>. Wants to be on the Domestic Council staff; a decision on this is pending the selection of a new Director for the Domestic Council.

<u>David Martin</u>. Was interested in a part time Commission, such as the UNESCO Advisory Board, but he has just left on a round-the-world trip; action delayed until after his return.

<u>Bob Mathias</u>. Decided not to join the staff of the President's Council on Physical Fitness and is exploring opportunities in the prviate sector.

<u>Wilmer Mizell</u>. One of the candidates whom I will propose to the President as Assistant Secretary of Commerce for Economic Development.

<u>Stan Parris</u>. He is interested in something in ERDA or ARBA. We are exploring possibilities.

<u>Robert Price</u>. Will be proposed as one of the candidates for Chairmanship of the Commodity Futures Trading Commission.

Earl Ruth. Is Secretary Morton's choice as Governor of American Samoa.

Bill Scherle. Is being offered a post in the Department of Agriculture.

<u>Dick Shoup</u>. Is campaigning to be Federal Railway Administrator. There is nothing definite for him at this time.

<u>Henry P. Smith</u>. Will be proposed, along with Paul Cronin, to be Chairman of the International Joint Commission, U.S. and Canada.

<u>Robert Steele</u>. Turned down our offer to nomimate him as Federal Fire Prevention and Safety Administrator. He has indicated he would like an Ambassadorship. This is still being explored.

<u>Vernon Thomson</u>. It is our understanding that he will be John Rhodes' nominee as a Republican member of the Federal Elections Commission.

<u>David Towell</u>. Secretary Morton is in touch with him about possibilities in Interior or the energy area.



<u>Victor Veysey</u>. Is interested primarily in ERDA; Seamans has little interest. We are arranging some interviews in FEA and Army.

<u>William Widnall.</u> Will be included among our candidates for nomination to the Commission on Electronic Fund Transfers.

Lawrence Williams. Has been interviewed unsuccessfully in Transportation and HUD. We are checking to see whether Commerce has any regional positions available.

Louis Wyman. We have indicated we will help him if he eventually loses his recount battle.

<u>Roger Zion</u>. Morton has recommended that Zarb offer Zion a consultancy in FEA.

The following is an updating of my memorandum to you of January 2 summarizing the placements we have been able to effect for the Republican Congressmen defeated in the 1974 Primaries or General Elections:

If a man's name is not listed, that means we had no contact or request from him -- and we have gone into action only in response to initiatives from the former Members themselves.

Peter Dominick	Will be nominated as Ambassador to Switzerland.
Wallace Bennett	Has been offered membership on the Board of the Overseas Private Investment Corporation (OPIC).

Les Arends	Has been offered Membership on the President's Foreign Intelligence Advisory Board.
LaMar Baker	Has accepted a six-months consultancy with the Department of Transportation.
William Bray	Has turned down offers for membership on the American Battle Monuments Commission, the Board of the Armed Forces Museum and the Board of Visitors for West Point.

Donald Brotzman	Will be nominated as Assistant Secretary of the Army for Manpower and Reserve Affairs.
Charles Chamberlain	Expressed an interest in the St. Lawrence Seaway Advisory Board but it has no vacancy. Has joined a Washington law firm.
Paul Cronin	Under consideration as Chairman of the International Joint Commission, U. S. and Canada.
John Dellenback	Is under serious consideration as the top international affairs officer of ACTION, i.e. head of the Peace Corps.
David Dennis	Wanted a Federal judgeship but there was none in his immediate district; is going back to Indiana to practice law.
Harold Froelich	Wants to be a member of the Federal Elections Commission; no decision has been made on this. If he does not get this, he is expected to return to Wisconsin to practice law.
Robert Hanrahan	Will be appointed Deputy Assistant Secretary of Education in HEW.
Larry Hogan	Will be proposed to the President as one of the candidates for the Board of Governors of the Postal Service; is practicing law also.
John Hunt	Has had casual conversations with Frances Knight of State and Roudebush of VA, but no commitments made. Hunt is 67: an advisory commission would be more appropriate than a full-time position.
Dan Kuykendall	Is a consultant at the Department of Transportation.
Richard Mallary	Wants to be on the Domestic Council staff; a decision on this is pending the selection of a new Director for the Domestic Council.

Lawrence Williams	Has accepted a GS-15 position as Assistant to the Federal Co-Chairman of the Ozarks Regional Commission; will serve at first in Washington, later in Little Rock, Arkansas.
Louis Wyman	We have indicated we will help him if he eventually loses his recount battle.
Roger Zion	May be offered a consultancy by Frank Zarb of FEA.
