LADIES AND GENTLEMEN, GOOD MORNING.

IN A FEW, VERY SIMPLE WORDS, THE TIME FOR ACTION IS

NOW. WE MUST START THE COUNTRY IN A NEW DIRECTION.

THE TRANSITION, THE HONEYMOON, THE TIME FOR DELIBERATION --

WHATEVER ONE MIGHT WISH TO CALL IT -- IS OVER.

THE PROBLEMS WE CONFRONT, THE QUESTIONS WE MUST ANSWER,

ARE IMMEDIATE. THE AMERICAN PEOPLE WANT ANSWERS NOW.

THAT IS OUR JOB. AND THAT IS WHY WE ARE HERE TODAY --

TO START IN A NEW DIRECTION.

WE HAVE A GOOD PROGRAM BASED ON SOUND PRINCIPLES.

AS YOU KNOW, I HAVE RECOMMENDED A TAX REDUCTION

OF APPROXIMATELY SIXTEEN BILLION DOLLARS. THIS IS NOT AN

UNDER-REACTION AND IT IS NOT AN OVER-REACTION. IT IS AS

FINE-TUNED, UNDER THE CIRCUMSTANCES, AS WE CAN MAKE IT.

THIS WILL STIMULATE THE ECONOMY WITHOUT OVERHEATING IT.

IT WILL MEAN JOBS -- DIGNITY FOR THE WORKER. IT WILL MEAN

SALES OF PRODUCTS. IT WILL MEAN A COUNTRY WITH NEW CONFIDENCE

IN THE FUTURE. AND FOR YOU, IT WILL MEAN OPPORTUNITY FOR

LEADERSHIP -- TO CONTRIBUTE TO THE RESTORATION OF CONFIDENCE

IN THE ECONOMY AND IN YOUR ADMINISTRATION OF THE GOVERNMENT.

OUR BUDGET. THE CHOICES I HAVE CONFRONTED HAVE NOT BEEN

EASY ONES -- BUT I HAVE MADE THEM. TOGETHER, I BELIEVE,

WE HAVE FASHIONED A PROGRAM THAT MAKES SENSE FOR THE COUNTRY.

EVEN THOUGH FEDERAL SPENDING WILL TOTAL MORE THAN

THREE HUNDRED FORTY-FIVE BILLION DOLLARS NEXT YEAR, MANY

OF YOUR CONSTITUENTS WILL BE DISAPPOINTED. THIS IS WHERE

YOU CAN PLAY A SPECIAL ROLE -- TRANSLATING THE NECESSARY

PRIORITY CHOICES IN WAYS THAT THE ORGANIZATIONS YOU DEAL

BENEFIT OF THE WHOLE COUNTRY.

OUR FIRST CONCERN IS JOBS AND PRODUCTION. WE NEED MORE PEOPLE AT WORK AND BETTER TOOLS WITH WHICH TO WORK.

EVERY SINGLE RECOMMENDATION THAT THIS ADMINISTRATION HAS MADE WILL TAKE THESE TWO GOALS INTO ACCOUNT -- MORE JOBS AND GREATER PRODUCTIVITY.

WE HAVE ALREADY PROVIDED FOR EMERGENCY PUBLIC SERVICE

JOBS AND ADDITIONAL ASSISTANCE. WE ARE OFFERING BROAD-BASED

HELP TO ALL LOW-INCOME GROUPS. WE -- YOU AND I, ALL OF

US -- MUST DO ALL THAT IS NECESSARY TO HELP THOSE WHO ARE HURT

THE MOST.

FOR THAT REASON AMONG OTHER OBVIOUS ONES, I HAVE

RECOMMENDED THAT FEDERAL PAY INCREASES BE HELD TO FIVE PERCENT.

WE MUST SET AN EXAMPLE FOR WHAT WE SEEK BY STARTING AT HOME.

AS I TOLD THE CONGRESS YESTERDAY, AS FAR AS I AM

CONCERNED, THERE IS A MORATORIUM ON NEW SPENDING PROGRAMS.

WE WILL NOT ASK FOR ANY NEW SPENDING PROGRAMS -- EXCEPT

FOR ENERGY.

THE LEGISLATION I HAVE PROPOSED IS AN EXPRESSION OF

CONFIDENCE -- NOT ONLY IN THE AMERICAN PEOPLE BUT IN BUSINESS

PEOPLE AS WELL. THE INVESTMENT TAX CREDIT WILL GET BUSINESS

MOVING AGAIN. THE CREDITS WILL BE UP TO TWELVE PERCENT

FOR ONE YEAR. NOW IT IS UP TO THE BUSINESS COMMUNITY TO

EXPRESS SOME CONFIDENCE IN THE GOVERNMENT AND IN THE ECONOMY -
AND MOST IMPORTANTLY -- IN THE COUNTRY -- BY JOINING IN THIS

MASSIVE EFFORT TO RESTORE ACROSS-THE-BOARD PROSPERITY.

NEW TAXES ON ENERGY HAVE BEEN REQUESTED, BUT WE WILL
RETURN ABOUT THIRTY BILLION DOLLARS TO THE ECONOMY IN THE FORM

OF ADDITIONAL PAYMENTS AND CREDITS TO INDIVIDUALS AND BUSINESSES

AS WELL AS STATE AND LOCAL GOVERNMENTS.

ALTOGETHER, FORTY-SIX BILLION DOLLARS WILL BE RETURNED TO HELP THE ECONOMY. THAT IS THIRTY BILLION DOLLARS IN RETURNED ENERGY TAX REVENUES TO COMPENSATE FOR HIGHER FUEL COSTS -- AND SIXTEEN BILLION DOLLARS IN 1974 TAX CUTS. AND REMEMBER; ENERGY CONSERVATION TAX REVENUES WILL CONTINUE TO BE PUT BACK IN THE ECONOMY AS LONG AS THE CURRENT EMERGENCY LASTS.

AS YOU KNOW, I AM INCREASING IMPORT FEES ON EACH BARREL OF FOREIGN CRUDE OIL FROM ONE TO THREE DOLLARS OVER THE NEXT FEW MONTHS. A MORE COMPREHENSIVE PROGRAM -- COVERING NATURAL GAS AS WELL AS OIL -- MUST BE ENACTED BY THE CONGRESS. THESE ACTIONS WILL HELP TO REDUCE CONSUMPTION SUBSTANTIALLY. OUR GOAL IS TO REDUCE FOREIGN OIL IMPORTS BY ONE MILLION BARRELS A DAY BY THE END OF THIS YEAR, AND BY TWO MILLION BARRELS PER DAY BY THE END OF 1977.

WE NEED EVEN STRONGER MEASURES TO HURRY THE DEVELOPMENT

OF ADDITIONAL DOMESTIC ENERGY RESOURCES -- SUCH AS COAL,

GEOTHERMAL, SOLAR, AND NUCLEAR POWER. OUR PROGRAM

ENVISAGES ALL THIS.

I HAVE DISCUSSED OUR ENERGY NEEDS AND GOALS TO 1985 AND BEYOND. I BELIEVE THEY ARE BOTH REASONABLE AND FAR-SIGHTED. WE HAVE A PROGRAM THAT WILL MAKE THIS COUNTRY INDEPENDENT ONCE AGAIN. IT WILL FREE OUR ECONOMY FROM THE THREAT OF SEVERE DISRUPTION. IT WILL GIVE US -- AS WELL AS OUR CHILDREN AND GRANDCHILDREN -- AN ADEQUATE SURPLUS OF ENERGY AT FAIR PRICES. AND IT WILL BRING ENERGY STABILITY TO OTHER CONSUMING NATIONS. BUT WE WILL NOT ACHIEVE THESE OBJECTIVES UNLESS THE AMERICAN PEOPLE UNDERSTAND AND SUPPORT THEM.

THAT IS WHERE YOU COME INTO THE PICTURE. I WANT TO

MAKE SURE THIS PROGRAM IS EXPLAINED TO THE COUNTRY IN DETAIL

BY YOU AND ME -- THE MEN AND WOMEN WHO MUST IMPLEMENT IT.

THE AMERICAN PEOPLE MUST BE MADE AWARE THAT THESE PROPOSALS ARE

SOLUTIONS -- NOT SUPPOSITIONS. THAT THESE ARE ANSWERS

TO THE PROBLEMS OF THE FUTURE -- NOT AGONIZING REAPPRAISALS

OF THE PAST.

BY THE AMERICAN PEOPLE BECAUSE THEY ARE WELL AWARE OF ITS NECESSITY

AND URGENCY AND THEY KNOW THAT WE ARE COMMITTED TO IT. THAT

COMMITMENT IS TOTAL AND COMPLETE ON MY PART. IT MUST ALSO

BE SO ON YOURS.

OUR PEOPLE MUST ALSO UNDERSTAND THE UNACCEPTABLE RISK

OF INACTION AND REJECT THAT AS FIRMLY AS THEY REJECT ALTERNATIVES

THAT WILL DO MORE HARM THAN GOOD. WE MUST, FOR EXAMPLE,

REJECT RATIONING WHICH TAKES FROM THE PEOPLE THEIR RIGHT TO MAKE

THE DECISIONS ON HOW THEY WILL REDUCE ENERGY CONSUMPTION.


