OCTOBER 15, 1976

IT IS MY GREAT PLEASURE TODAY TO BE ABLE TO SIGN THIS BILL

WHICH EXTENDS THE EMERGENCY LIVESTOCK CREDIT ACT THROUGH

SEPTEMBER 30, 1978.

AMERICAN AGRICULTURE - AND OUR LIVESTOCK INDUSTRY

IN PARTICULAR - IS THE ENVY OF THE WORLD.

I WANT TO KEEP THIS INDUSTRY STRONG SO THAT OUR FARMERS

AND RANCHERS CAN CONTINUE TO PROVIDE THE FOOD AMERICA NEEDS.

THIS LEGISLATION PROVIDES A USEFUL AND NECESSARY PROGRAM
TO ASSURE THAT THE LIVESTOCK INDUSTRY CAN OBTAIN THE CREDIT
IT NEEDS IN ORDER TO RETURN TO A HEALTHY AND STABLE POSITION.

THIS ACTION AND OTHER RECENT ACTIONS I HAVE TAKEN
SUCH AS SIGNING THE MUCH NEEDED PACKER BONDING LEGISLATION
AND THE IMPOSITION OF QUOTAS ON MEAT IMPORTS -- WILL HELP
AND STRENGTHEN THE AMERICAN LIVESTOCK INDUSTRY.
