As a result of our meeting with the First Lady, I can provide you with additional guidance regarding her forthcoming trip to Chicago.

The present plan is for her to accompany the President to Detroit and probably some participation in the President's Detroit events. The extent of that participation will determine the time of our split-off to Chicago, and will have to be determined after you have come up with a schedule for the President's Detroit visit. The First Lady and her party will fly by separate military aircraft from Detroit to Chicago arriving sometime during the afternoon on September 23. The First Lady and party will be housed at the Conrad Hilton, where the events of the 24th will take place.

The First Lady has acceded to the following events during her visit to Chicago:

- 1. a tape interview with Irv Kupcinet of approximately
 15 minutes duration during late afternoon, September 23.
 Helen Smith has made the initial contact with Kupcinet on
 this matter, and has indicated that the specific time will
 be determined as we develop the schedule. In any event,
 Kupcinet has agreed to taping at the Conrad Hilton, either
 in Mrs. Ford's or another suite.
- 2. a private dinner party offered by Mrs. Hope McCormick at her residence the evening of September 23 for approximately twelve people.
- 3. A reception at the Conrad Hilton for Mrs. Ford hosted by Hope McCormick and the RNC prior to the luncheon on September 24. This reception we understand will commence approximately 11:30 AM and Mrs. Ford has no objection to either a receiving line or individual pictures with candidates.

4. The principle luncheon event with Mrs. McCormick and the RNC at approximately 12:30 PM on September 24. We are preparing remarks for Mrs. Ford to make sometime during that luncheon.

The only other event during the Chicago trip which Mrs. Ford has agreed to is a drop-by to the home in which she resided as a child in the Chicago area. This residence is located at 1252 West Columbia Avenue and the contact is Mrs. Ruth Rotman. Again, Helen Smith is making the initial contact on this. Depending on location of the house in relation to the Conrad Hilton, a determination should be made whether it would be better to have the drop-by following lunch and on the way to the airport, or prior to the reception and luncheon on the morning of September 24. There will be photo and press play during the visit itself, including a possible commentary by Mrs. Ford after she has toured the house.

Mrs. Ford does not wish to commit herself to any events beyond those outlined above. I can discuss the particulars of these events with you as the advancing unfolds and convey her desires where appropriate. Both Nancy Howe and Helen Smith will indicate to Hope McCormick, who will be your principle contact for the dinner and RNC events, that your office will coordinate the advance.

Illinois Political Briefing

I attach your briefing on the highlights of the most significant elections in Illinois this fall as well as a general overview of the state's political scene.

Sources have indicated that there are no major issues (such as busing is in Boston) in the forefront of voter interest. The Equal Rights Amendment has not yet passed the state legislature.

Barbara Burditt is the wife of GOP Senate candidate George Burditt. While major state constitutional officers are not up for election this year, the State Treasurer is up. The Republican candidate is Harry Page and his wife's name is Lorraine.

Finally, Republican Congressional Campaign Committee Chairman Bob Michel represents Illinois' 18th District and is not anticipated to have any major difficulty in gaining re-election.

ILLINOIS POLITICAL BRIEFING

September 20, 1974

Richard Daley

This April Mayor Daley was unanimously elected Chairman of the Democratic Central Committee of Cook County for the 12th successive time, thereby continuing a custom that began in August, 1953 when he successfully challenged former Democratic National Committeeman Jacob Arvey.

Daley underwent extensive medical tests in early May, the results of which showed that he was afflicted with high blood pressure and a mild case of diabetes. Subsequent to the original press announcement over the Mayor's condition, it was learned that Daley had also suffered a stroke. After several months of absence from City Hall, the Mayor returned to a full schedule approximately two weeks ago.

The Mayor's problem with corruption in Chicago continues. Last May, the Chicago <u>Tribune</u> had a long article on the City Council and reported that it is the first Council in modern history to have an incumbent alderman indicted or convicted. Approximately 12% of its members (Republicans included) have been indicted by Federal or county grand juries, 6% of them have been convicted and 4% acquitted with two indictments still pending. The <u>Tribune</u> also claimed that it is the first Council to have a court order requiring a special election because of Federal findings of racial gerrymandering. It was just little more than three years ago that the new 50 member City Council was seated in what was to begin a new era of democratic and responsible legislative government.

Charles Percy

Earlier this year, Senator Percy announced the formation of an "exploratory committee" to pursue the feasibility of his obtaining the GOP presidential nomination in 1976. Chicago attorney Tom Houser, CRP State Chairman in 1972, was chosen to chair this committee. In a somewhat surprising announcement on May 11, former GOP Governor Richard Ogilvie announced he was joining Percy's presidential campaign effort by chairing

a businessmen's and lawyer's division of the Senator's "exploratory committee". Previously, Ogilvie is reported to have told friends he favored Nelson Rockefeller for the '76 nomination, but felt that for practical reasons he would publicly line up behind Percy.

Illinois' senior Senator has stated that he will have to "seriously re-evaluate" his national ambitions for '76 as a result of Richard Nixon's resignation.

1974 Congressional Elections

Illinois became the first state to hold its party primaries this election year (March 19) however, there was no earthshaking news in the election outcomes. All Republican incumbents were retained and LaGrange attorney George Burditt received the GOP nomination to oppose Adlai Stevenson III in November. A victory in this Senate race this fall is generally considered a longshot due largely to the candidate's fundraising deficiencies.

In the House, the Congressional split is currently 14 Republicans to 10 Democrats. Three Democrats will not face GOP opposition in November: Morgan Murphy in the 2nd, Cardiss Collins in the 7th and Melvin Price in the 23rd. Moreover, two Republican incumbents (Les Arends and Harold Collier) will be retiring as compared to one Democrat (Ken Gray).

Arends' 15th District seat will be fought over by former GOP Congressman and wealthy manufacturer Clifford Carlson and Arends' 1972 Democrat opponent Tim Hall. Redistricting reduced Arends' margin of victory two years ago as the District received a generous infusion of Democrat precincts. The Carlson-Hall race is considered a toss-up with several sources giving Democrat Hall the edge.

In Collier's 6th District, conservative GOP State Representative Henry Hyde will face former Cook County State's Attorney Edward Hanrahan. The latter was indicted and then acquitted on charges of obstruction of justice stemming from a 1969 police raid in which two Black Panthers were killed. Hyde is a former majority leader (and a blunt one) in the state house. This contest could be one of the most fiercely fought Congressional races this year.

Gray's 24th District is expected to remain in the Democrat column. Republican Val Oshel, a former Harrisburg Mayor, will be opposing former Lt. Governor Paul Simon. Simon was defeated in 1972 for the gubernatorial nomination by Dan Walker, however the Governor has publicly endorsed Simon's House candidacy this year.

GOP "first-termer" Sam Young is faced with a stiff challenge to his hold on the 10th District seat by former liberal Congressman (and ADA Vice Chairman) Abner Mikva. In 1972, Young was successful in tying Mikva to McGovern and the Democrats left wing, but barely won the race with a 52% margin (only 7,000 votes out of more than 230,000 ballots cast). Liberal groups are expected to rally to Mikva's cause in even greater numbers this year and GOP officials are fearful of Republican voters staying home because of Watergate disillusionment.

1974 State Elections

The Governor and similar constitutional offices will not be up until 1976. Republican Attorney General Bill Scott was considering a challenge against Adlai Stevenson, but then decided to sit this year out. Scott remains the state GOP's brightest star for the future according to informed sources.

This November one-third of the state senate (30 R and 29 D) will be seeking re-election. Of those seats up, 12 are currently Republican and 8 Democrat. In the lower house, all seats (89 R, 87 D and 1 Ind) are up.

Control of the state legislature will be a major political qual of Illinois Republicans this fall.

1972 Presidential Election

Former President Nixon received 59.0% of all votes in 1972 (up from 47.1% in '68 and 49.8% in '60) and Illinois ranked 7th of all states in terms of RMN plurality (+874.700).

Long considered a Democrat bastion, Cook County carried for RMN in '72 with 53.5% of the votes. In fact, 44.3% of RMN's total statewide vote came from Mayor Daley's powerbase.

STATUS REPORT ON THE EQUAL RIGHTS AMENDMENT IN ILLINOIS

The Equal Rights Amendment has been ratified by 33 states as of this date.

Under the United States Constitution, 3/4 of the states must ratify an amendment for it to become part of the Constitution. Illinois is one of the five states which the organizations in the ERA Coalition have established as targets for ratification in 1975. The Illinois legislature has considered the ERA three times, in 1972, 1973, and 1974. Under the Illinois State Constitution, a 3/5 majority of each house is necessary for passage. However, a lawsuit has been filed against the 3/5 majority ruling, challenging its application to federal constitutional amendments. The suit was filed on April 4, 1973 and is presently before a three-judge federal panel which has heard arguments but has not announced a decision.

In 1974, the Illinois Senate voted by a simple majority to bypass the Executive Committee of the Senate, which opposed the amendment, and bring the ERA to a floor vote. The full Senate floor vote was 30 yeas, 24 nays, 1 present and 4 absent, a clear majority, but 6 short of the 36 votes needed for passage under the 3/5 rule. The vote broke down by parties as follows: yeas — 19 Democrats, 11 Republicans; nays — 7 Democrats, 17 Republicans; present — 1 Democrat; absent — 2 Democrats, 2 Republicans.

In the Illinois House in '74, the ERA was reported out of the Human Resources

Committee by a 16-1 vote in favor of passage. However, its supporters did not

press for a House floor vote because the Senate defeat came late in the legislative

session, and it was the political consensus that a Senate reversal was not possible in

the remainder of the '74 session and that in the House the pro-ERA forces were 14-15

votes short of the 107 votes needed for a 3/5 majority of the full House.

The chief sponsor of the ERA in the Illinois Senate is Esther Saperstein, a

Democrat from Chicago. The chief ERA leaders in the House are Giddy Dwyer, a

Republican from suburban Chicago, and Eugenia Chapman, a Democrat from suburban

Chicago. Both of these women are plaintiffs in the lawsuit referred to above.

House Speaker Blair, a Republican from Park Forest, a suburb of Chicago, is a sponsor of the ERA ratification bill. However, Senator Harris from Pontiac, the Republican President of the Senate, is a leader of the opposition to ERA. Also in the leadership of the Senate opposition is a Black, Democratic Senator from the Hyde Park section of Chicago, Richard Newhouse. It is reported that Newhouse has announced his candidacy for the Democratic mayoralty nomination. On the state executive level, Governor Walker, a Democrat, has stated that he supports ratification of the ERA.

It is the feeling of the ERA coalition groups in Illinois that the support of Governor Walker and Speaker Blair is rather thin, consisting mainly of verbal endorsements and lacking the willingness to put political muscle and weight behind them. Speaker Blair made the ruling that a federal amendment required a 3/5 majority vote for state ratification. He strongly contends that his ruling was not an anti-ERA move and was required by the language of the state constitution.

Phyllis Schlafly, the most effective nationwide spokesperson for the opponents of ERA, resides in Alton, Illinois, which is in the southern part of the state. As Illinois is her home state, Schlafly has had a devastating impact there and has turned her supporters out in full force at the legislative sessions in the capital at Springfield. The heart of the ERA opposition is in the downstate areas of which Springfield is a part. Schlafly

has used her full complement of arguments in Illinois and has centered them around the specter of the "destruction of the home" which she asserts the ERA will force on American society.

The pro-ERA coalition in Illinois is called ERA Central. Unfortunately, there has been a great deal of in-fighting within ERA Central, while Schlafly's women have remained united and very organized. The basic tension within ERA Central seems to be between the Business & Professional Women's Organization on the one hand and the National Organization for Women and League of Women Voters on the other. A few weeks ago, NOW and the League left an ERA Central meeting and informed Central the next day that they were considering setting up a separate office in Springfield that would cooperate with ERA Central in Chicago but would be independent. Part of NOW's and the League's dissatisfaction stemmed from the location of the ERA Central's office and operations in Chicago while the action was taking place in the legislature located in Springfield. NOW and the League felt it was inefficient and detrimental to have decisions being made in Chicago by individuals who were not at the legislative location. They felt that valuable reacting time was lost and that good political judgments and trade offs could not be made at a distance. The other members of ERA Central feel that good judgments were made in 1974 and that while improvements are always sought, the League's and NOW's separation is unjustified and perhaps divisive.

Despite the problems within ERA Central, it is the consensus of the ERA watchers in Washington that there is a good chance of passage in Illinois in 1975.

The most frequent reasons given for the optimism are:

- 1. the small vote margins needed for the 3/5 majority in each house: 6 more votes in the Senate and 14-15 more votes in the House;
- 2. the changing attitude of the AFL-CIO in Illinois. The national AFL-CIO convention in October 1973 reversed its previous stand in opposition to the ERA and voted in favor of supporting its ratification. However, the AFL-CIO in Illinois did not assist the ratification effort in the 1974 legislative session, stating that ERA was not one of their priority issues. There are some expectations that the AFL-CIO will work for ERA ratification in Illinois in 1975, especially since the formation by union women of a national organization called CLUW, Coalition of Labor Union Women. CLUW was founded to promote the rights of union women and held its organizing convention in Chicago in the spring of this year; and
- 3. the national effort that will be directed at the 5 target states needed to reach the 38 state requirement. Illinois is a target state along with Florida, Indiana, North Carolina, and North Dakota. (Some individuals place Oklahoma in the top 5 over North Carolina, but the consensus remains that North Carolina is a better prospect.)

Per your request, I have prepared for you and Mrs. Ford a status report on the ERA effort in Illinois. Please find it attached at Tab A.

I also have enclosed, at Tab B, a four-page analysis of the legal effect of ERA ratification which was published by the National Federation of Business & Professional Women's Clubs. It is an excellent, quick summary of the basic substantive arguments in favor of passage of the ERA. Please note that the legal analysis presented under the section "Don't Women Have Equal Rights Under the Constitution Now?" has been somewhat outdated by two recent Supreme Court cases. The general points, however, are still valid, and I would be pleased to prepare a detailed and current legal memorandum if you think that would be useful.

At Tab C, I have enclosed some of the anti-ERA literature that has been distributed by the "Stop ERA" and the "Homemakers' United Efforts" organizations. In addition, at that Tab you will find an article from the "Phyllis Schlafly Report" which delineates the basic anti-ERA arguments which she uses. Schlafly's article is full of inaccuracies, distortions and semi-truths; but she has been very effective in exploiting a philosophy of fear and it has been very difficult to correct her statements after she publicizes them as the "truth". Schlafly is a Republican and she frequently has tried to wrap herself in the banner of the Party on the ERA issue. We have been semieffective in derailing her efforts in that regard.

At Tab D, I have enclosed a copy of the Common Cause ERA Status Report.

Common Cause maintains the best up-to-date information bank on ERA progress in the various states.

At Tab E, I have enclosed a two-page list of national organizations which have declared their support for the ERA. The list was prepared in May 1973 by the Citizen's Advisory Council on the Status of Women, whose members are appointed by the President. The list is incomplete by this time, but it should give Mrs. Ford a good idea of the range of groups in favor of ERA ratification.

I have found that in trying to digest new knowledge about a particular subject matter, it is advantageous to have an oral discussion of the topic after reviewing the material. If Mrs. Ford would have an interest in proceeding in that manner, I would be happy to discuss the ERA arguments with her. Or, you might wish to ask Pat Lindh and Karen Keesling from Anne Armstrong's staff to orally brief Mrs. Ford. Pat Lindh, as you know, is Special Assistant to the Counselor for Women's Programs and Karen is Director of Women's Programs. Both are very knowledgeable in the area. I realize that you are facing a Monday deadline for the Chicago trip, but if Mrs. Ford is interested in speaking about the ERA in other states, an oral briefing might be a useful thing to do within the next few months and before the start of the 1975 legislative sessions.

Republican Women Power Luncheon, Chicago, Sept. 24

Good afternoon, and thank you for such a nice welcome. It's nice to be back.

Some of you may know I was born in Chicago. My family moved to Grand Rapids when I was about three, but both my husband and I have been back here many times. In fact, it's kind of a politican's town, isn't it. I noticed Senator Brock and Senator Bentsen were in town last night, and I've heard so many political speeches here myself that I think I know where you got the name 'Windy City...'

Well, this is obviously one political luncheon that's going to be different. Whoever heard of a candidate's luncheon in which none of the candidates make speeches? And I've seen candidates use pictures of themselves that were not quite up-to-date... but this is ridiculous! And whoever heard of a political luncheon in which there were absolutely no free lunches ... for the luncheon committee, or the press, or anyone. Hope McCormick, you're a hard woman. But just to show you that I'm in the spirit of the thing, I have here a check for my lunch that I want to present to you personally. I have inscribed it on the back — "To Hope McCormick, who exemplifies better than anyone I know that there's no such thing as a free lunch." Hope? (presentation)

Well, a little more on the serious side, I want you to know how 100 per cent I am behind what you are doing today. I like what I see of Republican Women Power, Illinois Style. You have 14 outstanding candidates who would do an outstanding job for the people of Illinois. They deserve our support. But more than that, the people of Illinois deserve the quality that these women offer.

We have come a long way, there's no doubt about it. But we've got a way to go as well. And we can only do it through continual hard work, like that which has gone into this luncheon.

Well, so do I. We've got 14 winners for the Republican Party in this room today. Let's elect them to office and make them winners for the state of Illinois.

BACKGROUNDER on Republican Women Power luncheon and related events

I. Hope McCormick's dinner Monday night

- Mrs. McCormick is especially proud of her Goya in the living room and her Sargent in the hall.
- There is a portrait over the fireplace in her den of a young woman and a young child. It is Mrs. McCormick and her daughter, painted at their "farm" about 45 minutes from Chicago. (Her great line, after she and her husband bought the estate and made improvements, was "It's a wonder what a bucket of paint and a half-a-million dollars will do."
- The McCormicks live in the old Gold Coast zone of the city, which in just the past year-year-and-a-half has seen dozens of high rise buildings go up in place of the old brownstones and townhouses. The McCormicks have lived in the neighborhood 20 years and are, of course, very upset about the changing tenor of the neighborhood.

II. Reception Tuesday morning at 11:30 a.m.

Guests include the 14 candidates being honored, and a woman candidate from Indiana, who the luncheon people were happy to include because it meant another \$100 for their Illinois candidates. The only photographers with free access are the luncheon photographer and the White House photographer. A pool of White House and Chicago writing press will be permitted in the room throughout the reception, and a pool of photographers will be brought in for a couple minutes around noontime.

III. The luncheon

About 650 guests have purchased the \$20 tickets, some kind of a record for political events in Illinois this year (they've had a very difficult time with fund raisers of any kind.)

Almost all the guests will be women, mostly 50-ish in age. You will be speaking from a podium, so if you wish to use notes or cards, the situation lends itself to that easier than most of your recent standing-mike situations.

The slide show, which you'll be previewing at the dinner — gives quick sketch of your career, mentioning modeling, then says ...'still a size 10...' But it was on tape, completely done and we did not feel you would have wanted us to make a big deal of it... so we didn't. It says... "She's a champion of womens rights, a firm believer in equal opportunity.

And ... she leaves notes about legislation and criticisms of bills on her husband's bureau at night. She is characterized by a quiet grace and is described as representing what is best about America. Of course, she's our First Lady ... Betty Ford."

Regarding your remarks, Mrs. McCormick recommended you stay away from the subject of ERA when you speak at the luncheon because of the divided feeling among the women. She suggested light, humorous remarks with a serious thought tossed in might be most fitting with the mood of the luncheon.

FYI — regarding your visit to your childhood home, in response to any questions, we've justsaid that while you'd like to do it at some future time, we couldn't work it into the schedule this trip.

Mr. Kupcinet's show is aired at 10:30 p.m. in Chicago—later picked up by other major cities during late show hours. So if you care to wear the long casual dress you'll be wearing to Mrs. McCormick's, it would be appropriate.
