



WASHINGTON (UPI) -- THE CHIEF LOBBYIST FOR U.S. STEEL SAID HE PERSONALLY PAID FOR GOLFING WEEKENDS FOR GERALD R. FORD AT A COUNTRY CLUB BETWEEN 1964 AND 1971 WHEN THE PRESIDENT WAS STILL A MEMBER OF THE HOUSE OF REPRESENTATIVES.

WILLIAM WHYTE, WHO WAS RECENTLY PROMOTED TO BE A U.S. STEEL VICE PRESIDENT, MADE THE ADMISSION TO UNITED PRESS INTERNATIONAL AFTER FORMER EMPLOYES OF THE STEEL FIRM SAID FORD "FREQUENTLY" WAS TREATED TO VACATIONS AT PINE VALLEY GOLF CLUB NEAR CLEMENTON, N.J.

WHYTE SAID FORD HAD NOT VACATIONED AT THE LODGE SINCE HE LEFT CONGRESS AND THAT U.S. STEEL NO LONGER USES IT FOR VIP PURPOSES. FORD WAS NOMINATED BY RICHARD NIXON TO BE VICE PRESIDENT, SUCCEEDING SPIRO AGNEW, IN OCTOBER, 1973, AND BECAME PRESIDENT WHEN NIXON RESIGNED AUG. 9, 1974.

WHITE HOUSE PRESS SECRETARY RON NESSEN, ASKED FOR A RESPONSE TO WHYTE'S REMARKS, QUOTED FORD AS SAYING: "I'VE BEEN A FRIEND OF BILL WHYTE FOR 28 YEARS. I'VE BEEN THERE TWICE AS HIS FRIEND TO PLAY GOLF."

NESSEN SAID FORD RECALLED PLAYING THERE IN 1964 AND ABOUT FIVE YEARS AGO.

"HE FEELS BILL WHYTE IS A PERSONAL FRIEND WHO ASKED HIM TO GO UP AND PLAY GOLF," NESSEN SAID, NOTING ALSO THAT FORD AND WHYTE ARE FREQUENT GOLF PARTNERS AT THE BURNING TREE COUNTRY CLUB IN SUBURBAN MARYLAND.

SYNDICATED COLUMNIST JACK ANDERSON, IN REMARKS PREPARED FOR BROADCAST TODAY -- IN ABC-TV'S GOOD MORNING AMERICA -- SAID WHYTE CLAIMED U.S. STEEL PAID FOR FORD'S TRIPS.

WHYTE SAID FORD'S FIRST VISIT TO THE LODGE WAS IN THE FALL OF 1964. AT THAT TIME, THERE WAS NO LAW OR CONGRESSIONAL RULE AGAINST A MEMBER OF CONGRESS ACCEPTING GIFTS OR FAVORS FROM LOBBYISTS.

IN 1968, THE HOUSE ADOPTED A CODE OF ETHICS STATING THAT "A MEMBER, OFFICER OR EMPLOYE OF THE HOUSE OF REPRESENTATIVES SHALL ACCEPT NO GIFT OF SUBSTANTIAL VALUE, DIRECTLY OR INDIRECTLY, FROM ANY PERSON ORGANIZATION OR CORPORATION HAVING A DIRECT INTEREST IN LEGISLATION BEFORE THE CONGRESS."

THE IRS SAID IT IS NOT AGAINST THE LAW FOR A CONGRESSMAN TO ACCEPT A GIFT, BUT THAT THE GIVER MUST FILE AN INCOME TAX REPORT FOR GIFTS OF SUBSTANTIAL VALUE.

WHYTE SAID THAT SINCE FORD'S VISITS TO THE LODGE WERE CONSIDERED PERSONAL GIFTS AND NOT CAMPAIGN DONATIONS, THEY WERE NOT INCLUDED IN AN INTERNAL COMPANY AUDIT THIS SUMMER ON IMPROPER PAYMENTS. HE SAID THE AUDIT LISTED ONLY ONE \$100 CONTRIBUTION BY A U.S. STEEL SUBSIDIARY.

U.S. STEEL SPOKESMEN IN PITTSBURGH AND WASHINGTON TOLD UPI, HOWEVER, THAT THEY COULD FIND NO RECORD OF ANY SUCH AUDIT . A CHECK AT THE SEC ALSO FAILED TO TURN UP THE REPORT.

AFTER FORMER U.S. STEEL EMPLOYES SAID FORD WAS TREATED "FREQUENTLY" TO EXPENSE PAID VACATIONS AT PINE VALLEY, UPI PHONED THE NEW JERSEY LODGE IN JULY. A HOUSEMAN ANSWERED, SAYING "I WAS TOLD NOT TO TALK AND YOU'LL HAVE TO CALL WASHINGTON."

UPI THEN CONTACTED THE FIRM'S WASHINGTON PUBLIC RELATIONS OFFICE WHERE A SPOKESMAN SAID HE CALLED WHYTE FROM A MEETING IN PITTSBURGH TO ASK HIM ABOUT THE MATTER. THE SPOKESMAN CALLED BACK TO SAY THAT WHYTE RECALLED ONLY ONE FORD VISIT "ABOUT FIVE OR SIX YEARS AGO". UPI 09-21 09:05 AED WASHINGTON (UPI) -- THE WATERGATE SPECIAL PROSECUTOR IS CONDUCTING AN INVESTIGATION OF POLITICAL CONTRIBUTIONS THAT MAY INVOLVE PRESIDENT FORD'S PAST CAMPAIGNS, THE WALL STREET JOURNAL REPORTED TODAY.

THE NEWSPAPER SAID SPECIAL PROSECUTOR CHARLES RUFF HAS SUBFOENAED RECORDS FROM KENT COUNTY, MICH., REPUBLICAN OFFICIALS AND FROM A NEW YORK-BASED MARITIME UNION, THE MARITIME ENGINEERS BENEFICIAL ASSOCIATION.

KENT COUNTY INCLUDES THE PRESIDENT'S HOMETOWN OF GRAND RAPIDS. THE UNION, ACCORDING TO THE NEWSPAPER, WAS FORD'S BIGGEST FINANCIAL BACKER WHEN HE LAST RAN FOR CONGRESS FROM MICHIGAN IN 1972.

RUFF DECLINED COMMENT ON THE REPORT, BUT THE JOURNAL REPORTED THAT WHITE HOUSE PRESS SECRETARY RON NESSEN SAID HE KNEW NOTHING ABOUT ANY SUBPOENAS.

THE NEWSPAPER SAID IT DID NOT KNOW IF THE TWO SUBPOENAS ARE RELATED BUT REPORTED BOTH GOP OFFICIALS IN GRAND RAPIDS AND UNION SPOKESMEN CONFIRMED THE SUBPOENAS. UP-036

WHYTE SAID HIS FIRM PAID "ROOM AND BOARD" FOR AT LEAST TWO VISITS BY FORD TO THE COMPANY'S COUNTRY CLUB LODGE IN NEW JERSEY WHEN FORD WAS A CONGRESSMAN.

IN A TELEPHONE INTERVIEW TODAY, WHYTE SAID HE HAD REFRESHED HIS MEMORY AND NOW RECALLED THAT U.S. STEEL PICKED UP THE TAB FOR FORD'S "ROOM AND BOARD" AT THE PINE VALLEY GOLF CLUB NEAR CLEMENTON, N.J.

"I PICKED UP CADDY FEES ON THE GREENS AND THINGS LIKE THAT," WHYTE SAID.

WHYTE ALSO CONFIRMED A REPORT THAT U.S. STEEL HAS A COMPLETE LISTING OF GUESTS WHO HAVE STAYED AT THE LODGE SINCE 1969. THOSE RECORDS, HE SAID, ARE KEPT IN A LIMESTONE MINE IN ANNANDALE, PA.

SEN. ROBERT GRIFFIN, R-MICH., TOLD A NEWS CONFERENCE THE FORDS AND WHYTES "HAVE BEEN VERY CLOSE FRIENDS FOR LONGER THAN I'VE KNOWN THEM."

"I COULDN'T SEE ANYTHING WRONG WITH IT (THE TRIPS) UNLESS THERE'S SOME ALLEGATION THAT CORPORATE FUNDS WERE USED AND I UNDERSTAND THAT'S NOT THE CASE," GRIFFIN ADDED.

WASHINGTON (AP) -- PRESIDENT FORD ACCEPTED FREE GOLF OUTINGS FROM A U.S. STEEL CORP. LOBBYIST AT A NEW JERSEY COUNTRY CLUB WHILE HE WAS A CONGRESSMAN, THE PRESIDENT'S SPOKESMAN ACKNOWLEDGED TODAY.

"THE PRESIDENT HAS BEEN A PERSONAL FRIEND OF BILL WHYTE FOR 28 YEARS AND TWICE, ON TWO WEEKENDS, HE WAS A GUEST OF WHYTE AT THE NEW JERSEY GOLF COURSE WHILE HE WAS A MEMBER OF CONGRESS," SAID WHITE HOUSE PRESS SECRETARY RON NESSEN.

WHYTE IS NOW A VICE PRESIDENT OF U.S. STEEL. HE COULD NOT BE REACHED IMMEDIATELY FOR COMENT.

NESSEN WAS ASKED IF HIS STATEMENT WAS AN ADMISSION THAT FORD HAD ACCEPTED A FREE WEEKEND PAID FOR BY WHYTE. THE PRESS SECRETARY REPLIED, 'YES.''

NESSEN MADE THE STATEMENT AFTER COLUMNIST JACK ANDERSON SAID WHYTE HOSTED FORD AT THE PINE VALLEY GOLF CLUB NEAR CLEMENTON, N.J., BETWEEN 1964 AND 1971 WHILE FORD WAS IN THE HOUSE OF REPRESENTATIVES.

ANDERSON SAID WHYTE CONCEDED THAT U.S. STEEL PAID FOR THE GOLF OUTINGS. WHYTE COULD NOT RECALL WHICH WEEKENDS WERE SPENT AT PINE VALLEY, THE COLUMNIST SAID ON ABC-TV'S 'GOOD MORNING AMERICA.''

THE HOUSE ADOPTED A CODE OF ETHICS IN 1968 PROBHIBITING MEMBERS FROM ACCEPTING A "GIFT OF SUBSTANTIAL VALUE, DIRECTLY OR INDIRECTLY, FROM ANY PERSON, ORGANIZATION OR CORPORTION HAVING A DIRECT INTEREST IN LEGISLATION BEFORE THE CONGRESS."

THE RULE DOES NOT CITE A SPECIFIC DOLLAR FIGURE CONSIDERED TO BE "SUBSTANTIAL." BUT A HOUSE ETHICS COMMITTEE SPOKESMAN SAYS IT ANSWERS HOUSE MEMBERS' QUERIES BY CITING THE STATE DEPARTMENT INTERPRETATION OF THE FOREIGN GIFTS AND DECLARATION ACT, WHICH PROHIBITS GOVERNMENT EMPLOYES FROM ACCEPTING GIFTS WITH A RETAIL VALUE OF MORE THAN \$50 FROM FOREIGN GOVERNMENTS.

NEITHER NESSEN NOR ANDERSON SPECIFIED THE AMOUNT OF MONEY WHYTE SPENT TO ENTERTAIN FORD.

"THE SUBPOENAS REQUESTED A NUMBER OF DOCUMENTS, FINANCIAL AND OTHERWISE, FROM THE KENT COUNTY REPUBLICAN COMMITTEE AND THE REPUBLICAN FINANCE COMMITTE, " ELEVELD SAID . "THERE WAS NO INDICATION ON THE SUBPOENAS EXACTLY WHAT THEY WERE LOOKING FOR OR EXACTLY WHAT THEY WERE INVESTIGATING ."

ELEVELD SAID THE FBI, THE GENERAL ACCOUNTING OFFICE AND A NUMBER OF OTHER FEDERAL INVETIGATIVE BODIES LOOKED OVER THE SAME RECORDS IN 1973 AND IN 1974 WHEN FORD WAS BEING CONSIDERED FOR THE VICE PRE SIDE NT IAL APPO INT MENT .

RW CARTER-PLAYBOY

WASHINGTON (AP) -- ACTING SENATE DEMOCRATIC LEADER ROBERT C. BYRD SAID TODAY HE WISHED JIMMY CARTER'S INTERVIEW WITH PLAYBOY MAGAZINE ''HAD NOT OCCURRED.''

"'OH, I DON'T THINK IT'S TERMINAL BY ANY STRETCH OF THE IMAGINATION," BYRD SAID OF CARTER'S REMARKS ON SEX AND SIN IN THE MAGAZINE. BUT HE ADDED: "I DON'T THINK THIS PARTICULAR INTERVIEW SHOULD HAVE BEEN GIVEN TO THIS PARTICULAR PUBLICATION. THERE WAS NOTHING TO BE GAINED BY IT."

"MANY, IF NOT ALL, OF THESE PRE-DEBATE COMMENTS COULD BE WIPED OUT BY THE DEBATES," BYRD SAID, REFERRING TO THE FORD-CARTER CONFRONTATION SCHEDULED FOR THURSDAY NIGHT IN PHILADELPHIA.

WHEN ASKED FOR HIS REACTION TO THE CARTER INTERVIEW, BYRD'S REPUBLICAN COUNTERPART, SEN. HUGH SCOTT OF PENNSYLVANIA, QUIPPED: ''I THINK A FLUFF A DAY MAKES PLENTY OF HAY.''

WHITE HOUSE PRESS SECRETARY RON NESSEN, RESPONDING TO THE REMARKS, QUOTED THE PRESIDENT AS SAYING. "I'VE BEEN A FRIEND OF BILL WHYTE FOR 28 YEARS. I'VE BEEN THERE TWICE AS HIS FRIEND TO PLAY GOLF."

SCOTT SAID CARTER ""HAS CHOSEN A RATHER EXOTIC SPRINGBOARD FOR HIS CANDID VIEWS OF MORALITY WHICH WILL PROBABLY GAIN HIM SOME SYMPATHY AMONG THE ULTRA TOLERANT AND SHOCK THE GENERALITY OF THE GOOD PEOPLE OF THIS COUNTRY."

SCOTT SAID THAT, IN ADDITION TO A QUESTION OF CARTER'S CREDIBILITY ON TAXES, "'HE IS TAXING CREDIBILITY IN THE PLAYBOY ARTICLE. WHEN HE SAYS WHAT HE REALLY THINKS, HE COMES OUT PRETTY SCARY."

IN ONE EXCERPT FROM THE LENGTHY INTERVIEW TO BE PUBLISHED IN PLAYBOY'S NOVEMBER ISSUE, CARTER WAS QUOTED AS SAYING:

"'I'VE LOOKED ON A LOT OF WOMEN WITH LUST. I'VE COMMITTED ADULTERY IN MY HEART MANY TIMES. THIS IS SOMETHING THAT GOD RECOGNIZES I WILL DO -- AND I HAVE DONE IT -- AND GOD FORGIVES ME FOR IT. BUT THAT DOESN'T MEAN THAT I CONDEMN SOMEONE WHO NOT ONLY LOOKS ON A WOMAN WITH LUST BUT WHO LEAVES HIS WIFE AND SHACKS UP WITH SOMEBODY OUT OF WEDLOCK."

A DEMOCRATIC CONGRESSMAN, MEANWHILE, CRITICIZED HIS PARTY'S FLAGBEARER FOR ANOTHER SECTION OF THE INTERVIEW IN WHICH CARTER LUMPED FORMER PRESIDENTS LYNDON B. JOHNSON AND RICHARD M. NIXON TOGETHER.

THE MAGAZINE QUOTED CARTER AS SAYING THAT BECAUSE OF HIS RELIGIOUS BELIEFS, "I DON'T THINK I WOULD EVER TAKE ON THE SAME FRAME OF MIND THAT NIXON OR JOHNSON DID -- LYING, CHEATING AND DISTORTNG THE TRUTH."

REP. JIM WRIGHT, D-TEXAS, SAID IN AN INTERVIEW THAT CARTER WAS QUOTED AS INVEIGHING AGAINST BEING SMUG OR SELF-RIGHTEOUS, "AND THEN HE PUTS LYNDON JOHNSON IN THE SAME CATEGORY AS RICHARD NIXON IN LYING AND CHEATING. NOW HE'S GOT TO STRAIGHTEN THAT OUT WITH MY FOLKS IN TEXAS."

LEGISLATION WAS NEVER DISCUSSED ON THE LINKS BECAUSE THAT WOULD HAVE BEEN EMBARRASSING, ANDERSON QUOTED WHYTE AS SAYING.

ANDERSON SAID WHYTE DESCRIBED THE PINE VALLEY GOLF COURSE AS ONE OF THE ROUGHEST IN THE COUNTRY AND THOUGHT FORD WOULD ENJOY THE CHALLENGE.IT IS COMMON FOR MEMBERS OF COUNTRY CLUBS WITH DIFFICULT COURSES TO INVITE FRIENDS TO PLAY THERE.

THOMPSON WAS ASKED TO COMMENT AFTER THE WHITE HOUSE CONFIRMED THAT FORD IN 1964 AND 1971 WENT TO THE PINE VALLEY COUNTRY CLUB IN NEW JERSEY WITH WILLIAM WHYTE, AN OLD FRIEND AND CHIEF WASHINGTON LOBBYIST FOR U.S. STEEL. WHYTE HAS SAID THE CORPORATION PAID THE BILL FOR THE TWO OUTINGS.

THOMPSON GAVE NO INDICATION HE HAD DISCUSSED THE MATTER WITH FORD. HE SAID HE CAME TO THE WHITE HOUSE TO TALK ABOUT ILLINOIS POLITICS, THAT FORD MADE CLEAR HE WOULD CAMPAIGN IN THE STATE "AT LEAST TWICE," AND "I THINK THE PRESIDENT CAN CARRY THIS STATE" IF HE DOES THAT.

THOMPSON, WHO WON THE GUBERNATORIAL NOMINATION AFTER SERVING AS U.S. ATTORNEY AND PROSECUTING MANY MEMBERS OF CHICAGO MAYOR RICHARD DALEY'S DEMOCRATIC MACHINE, SPOKE AT LENGTH ABOUT THE QUESTIONS RAISED BY FORD'S ACQUAINTANCE WITH WHYTE AND THE VACATIONS THEY TOOK AT U.S. STEEL'S EXPENSE.

"I DON'T SEE ANYTHING ILLEGAL OR IMPROPER ABOUT IT, ESPECIALLY IF THEY ARE LONG-TIME FRIENDS," HE SAID. "THESE ARE MATTERS OF INDIVIDUAL DISCRETION. EVERYBODY IN PUBLIC LIFE HAS TO AT ONE TIME OR ANOTHER MAKE MANY OF THOSE DECISIONS.

"UNLESS YOU COMPELETELY CUT YOUR SELF OFF FROM ALL YOUR PRIOR FRIENDSHIPS AND ASSOCIATIONS AND ARE WILLING TO GO BEHIND THE 12-FOOT WALLS OF A MONASTERY, AT SOME POINT YOU ARE GOING TO HAVE TO ACCEPT HOSPITALITY FROM PEOPLE WHO MAY HAVE SOME ASSOCIATION WITH GOVERNMENT."

"EVERYBODY IN PUBLIC LIFE FACES THAT DILEMMA BECAUSE THERE ARE FEW PEOPLE THESE DAYS WHO DON'T HAVE ANYTHING TO DO WITH GOVERNMENT," THOMPSON SAID.

"SO LONG AS A MAN'S OWN CONSCIENCE IS CLEAR, SO LONG AS WHAT HE DOES IS NOT ON THE SURFACE CLEARLY APPARENTLY WRONG TO EVERYBODY, SO LONG AS THERE IS NO EVIDENCE THAT CAN BE FOUND TO SHOW A QUID-PRO-QUO, THEN I THINK MATTERS LIKE THAT ARE ALMOST ENTIRELY UNAVOIDABLE.

"THERE'S REALLY NO WAY TO DRAW A LINE UNLESS YOU DRAW A LINE, LET'S SAY, IN TERMS OF A \$3 PRESENT AND NOTHING ABOVE IT."

SPEAKING SPECIFICALLY ABOUT FORD'S VISITS TO THE COUNTRY CLUB, THOMPSON SAID: "OH, HELL, I'VE BEEN THE GUEST OF A LOT OF PEOPLE AT THEIR COUNTRY CLUBS BECAUSE I DON'T BELONG TO ONE."

ASKED IF THDSE WERE PEOPLE DEALING WITH THE GOVERNMENT, HE SAID, "OH, SURE."

WHITE HOUSE PRESS SECRETARY BON NESSEN SAID FORD DECLINED FURTHER CORPORATE HOSPITALITY AS VICE PRESIDENT EVEN THOUGH HE SAW NOTHING WRONG AND STILL FEELS HE HAS "LIVED UP TO THE SPIRIT" OF A CONGRESSIONAL ETHICS CODE PASSED IN 1963.

NESSEN SAID HE HAD NO DETAILS OF THE FINANCIAL ARRANGEMENTS BUT INDICATED THAT THE OUTINGS WERE NOT IN THE WASHINGTON AREA.

ACCORDING TO MESSEN, FORD, WHILE A CONGRESSMAN, PLAYED GOLF AT THE FXPENSE OF THE BETHLEHEM STEEL CO., THE ALUMINUM CORP. OF AMERICA AND THE FIRESTONE RUBBER CORP. IN ADDITION TO PREVIOUSLY REPORTED OUTINGS PAID FOR BY UNITED STATES STEEL CORP.

U.S. STEEL'S CHIEF LOBBYIST, WILLIAM WHYTE, SAID LAST WEEK HE PAID FOR FORD TRIPS TO HIS FIRM'S LODGE AT PINE VALLEY COLF CLUP IN NEW JERSEY IN 1964, 1969 AND 1973. THE WHITE HOUSE SAID FORD WAS WHYTE'S GUEST FOR WEEKENDS IN 1964 AND 1971.

WHYTE ALSO CONFIRMED REPORTS HE HAD PAID FOR TWO FORD STAYS AT U.S. STEEL LODGINGS MEAR DISNEY WORLD IN 1972 AND 1974. THE WHITE HOUGE DECLINED TO COMMENT ON THOSE TRIPS.

NESSEN SAID THAT "AS AN AVID GOLFER, THE PRESIDENT OVER THE YEARS HAS ACCEPTED INVITATIONS TO PLAY WITH FRIENDS AT DIFFERENT CLUES AROUND THE COUNTRY AND HAS INVITED FRIENDS TO PLAY AT HIS CLUE," THE PURNING TREE COURSE IN SUBURBAN BETHESDA, MD.

BUT NESSEN SAID THE EXCHANGE OF HOSPITALITY STRETCHED BACK OVER FORD'S LONG SERVICE IN THE HOUSE OF REPRESENTATIVES AND "IT IS TRULY DIFFICULT TO GO BACK 26 YEARS AND RECONSTRUCT EACH AND EVERY GOLF GAME."

HE SAID "THERE ARE NO RECORDS" READILY AVAILABLE AND THAT "THE PRESIDENT CAN'T JUST COME FORTH AND SAY, BEGINNING IN 1948, 'I PLAYED HERE AND HERE AND HERE.'"

(AP) -- PRESIDENT FORD'S SPECIAL COUNSEL SAYS THE TIMING OF THE WATERGATE PROSECUTOR'S REPORTED INVESTIGATION INTO UNION POLITICAL CONTRIBUTIONS ALLEGEDLY DIVERTED TO FORD'S PERSONAL USE WHILE FORD WAS A CONGRESSMAN IS 'DEPLORABLE' BECAUSE IT COMES LITTLE MORE THAN A MONTH BEFORE THE ELECTION.

PHILIP BUCHEN, SPECIAL COUNSEL TO THE PRESIDENT AND HIS FORMER LAW PARTNER, ALSO SAID THE RECORDS UNDER STUDY BY THE PROSECUTOR "ARE THE SAME ONES WHICH WERE EXAMINED THOROUGHLY IN 1973 BY 350 AGENTS OF THE FEDERAL BUREAU OF INVESTIGATION."

CHARLES RUFF, THE WATERGATE SPECIAL PROSECUTOR, REPORTEDLY HAS SUBPOENAED RECORDS OF THE SEAFARERS INTERNATIONAL UNION. RUFF IS REPORTEDLY PROBING REPORTS THAT CAMPAIGN CONTRIBUTIONS FROM THE UNION AND FROM THE MARITIME ENGINEERS BENEFICIAL ASSOCIATION WERE DIVERTED TO FORD'S PERSONAL USE -- WHILE HE WAS A CONGRESSMAN -- AFTER PASSING THROUGH REPUBLICAN COMMITTEES IN HIS HOME DISTRICT.

OFFICIALS OF THE MARITIME ENGINEERS CONFIRMED THAT THEIR RECORDS WERE SUBPOENED, BUT RUFF HAS NOT CONFIRMED THAT ANY SUBPOENAS WERE ISSUED.

BUCHEN SAID HE IS CERTAIN THE PRESIDENT IS NOT UNDER INVESTIGATION SINCE "'HIS CAMPAIGN FINANCES WERE CARRIED ON BY PEOPLE OF INTEGRITY, AND THE ACCOUNTS OF THOSE CAMPAIGN COMMITTEES WERE AUDITED EVERY YEAR."

MEANWHILE, WHITE HOUSE STAFF CHIEF RICHARD CHENEY, SPEAKING TO REPORTERS SUNDAY NIGHT ABOARD AIR FORCE ONE FLYING TO MIAMI, SAID THERE ARE NO PLANS TO ASK THE SPECIAL PROSECUTOR WHETHER THE PRESIDENT IS THE TARGET OF THE INVESTIGATION.

TO ASK THE QUESTION ''WOULD ASSUME THE QUESTION NEEDS TO BE ASKED. I DON'T THINK IT DOES.'' HE SAID.

CHENEY ADDED THAT NOBODY IN THE PROSECUTOR'S OFFICE HAS CONTACTED THE WHITE HOUSE FOR INFORMATION ON THE MATTER.


