WASHINGTON (UPI) -- ADJOURNMENT OF THE FIRST SESSION OF THE 94TH CONGRESS REMAINED IN JEOPARDY FRIDAY AS A SENATE-HOUSE FEUD EXPLODED OVER TAX CUT LEGISLATION.

AFTER CONFRONTATIONS WITH PRESIDENT FORD SEEMED SETTLED AND THE WAY CLEARED FOR ADJOURNMENT BEFORE THE END OF THE DAY, CONGRESS WAS STYMIED BY A SQUABBLE AMONG CONGRESSIONAL DEMOCRATS.

BUT THE EXPECTATION REMAINED THE SENATE AND HOUSE WOULD PATCH UP THEIR RIFT, APPROVE AN EXTENSION OF TAX CUTS ACCEPTABLE TO FORD, ADJOURN, AND HEAD HOME FOR A 30-DAY HOLIDAY.

THE MOOD WAS IN SHARP CONTRAST TO THE YESTERDAY'S NEAR-DESPAIR WHEN FORD AND CONGRESS APPEARED AT AN IMPASSE ON TWO MAJOR ISSUES --TAX CUTS AND ANGOLA -- AND CONGRESSIONAL LEADERS SPOKE GRIMLY OF CONTINUING THE SESSION THROUGH THE HOLIDAYS.

ONE MAJOR ROADBLOCK WAS SETTLED SWIFTLY, WHEN THE SENATE --BLOCKED BY AN ADMINISTRATION-ORDERED FILIBUSTER -- PUT OFF EFFORTS TO HALT COVERT AID TO AN GOLA UNTIL CONGRESS RETURNS IN JANUARY.

"THERE IS A FILIBUSTER," SEN. HUBERT HUMPRHEY, D-MINN., SAID. "WE ARE REALISTS. I CAN COUNT. SO CAN YOU. THERE AIN'T NO BILL."

A BREAK IN THE IMPASSE OVER TAX CUT LEGISLATION ALSO APPEARED IN THE WORKS WHEN THE SENATE AND FORD STRUCK A COMPROMISE. BUT ANGRY HOUSE DEMOCRATS REFUSED TO GO ALONG WITH THE SENATE LANGUAGE WHICH PROMISED TO CUT GOVERNMENT SPENDING BY THE SAME AMOUNT AS TAX CUTS.

DEMOCRATIC LEADER THOMAS O'NEILL BLUNTLY SAID, "WE ARE NOT GOING TO RECOGNIZE THE SENATE CONSIDERATION." HE SAID THE SENATE COULD ACCEPT THAT OR NOTHING.

"THERE'S NO WAY WE ARE ACCEPTING THIS ONE," O'NEILL SAID OF THE COMPROMISE DRAFTED BY SENS. RUSSELL LONG, D-LA., AND WILLIAM ROTH, R-DEL., AND ACCEPTED BY THE WHITE HOUSE.

FORD TRIGGERED THE LONG DAY BY VETOING THE \$45 BILLION HEW APPROPRIATIONS BILL WHICH EXCEEDED HIS REQUESTS BY ABOUT \$1 BILLION BUT ALSO CONTAINED STRONG ANTI-BUSING LANGUAGE. IT WAS FORD'S 42ND VETO, OF WHICH CONGRESS HAS OVERRIDEN ONLY SEVEN.

A RESOLUTION -- PASSED EARLIER -- PROVIDES CONTINUING FUNDS FOR HEW AND OTHER AGENCIES AND PROGRAMS WHICH HAVE NOT RECEIVED FISCAL 1976 APPROPRIATIONS. THEY INCLUDE DEFENSE, FOREIGN MILITARY AID, AND THE DISTRICT OF COLUMBIA. THE HOUSE VOTED TO PUT OFF UNTIL JAN. 27 A DECISION ON WHETHER TO TRY TO OVERRIDE THE VETO.

BETWEEN BREAKS, THE SENATE AND HOUSE PUSHED THROUGH ROUTINE, UNOPPOSED BILLS.

THE SENATE ALSO CONFIRMED ALL THE PENDING NOMINATIONS EXCEPT THAT OF GEORGE BUSH TO BE CIA DIRECTOR. HIS NOMINATION WILL BE CONSIDERED WHEN CONGRESS RETURNS.

WASHINGTON (UPI) -- A MOVE DEVELOPED IN THE SENATE TODAY TO MAKE ONE LAST EFFORT TO REVIVE A TAX CUT BILL. BUT HOUSE DEMOCRATIC LEADERS SAID IT WAS UNLIKELY ANYTHING COULD BE DONE TO PREVENT TAXES FROM RISING, AT LEAST TEMPORARILY, EARLY NEXT YEAR.

SPEAKER CARL ALBERT SAID THE DEMOCRATS WERE STICKING TO THE POSITION THEY TOOK AFTER FORD'S VETO OF A SIX-MONTH TAX CUT EXTENSION WAS UPHELD THURSDAY: NO FURTHER EFFORTS WILL BE MADE TO PASS A TAX CUT BILL UNLESS FORD BACKS DOWN ON HIS DEMAND THAT A SPECIFIC BINDING CEILING ON FISCAL 1977 SPENDING BE ATTACHED.

SEN. RUSSELL LONG, D-LA., CALLED A MEETING OF HIS SENATE FINANCE COMMITTEE TO PUSH HIS PLAN TO PASS EXACTLY THE SAME BILL THAT FORD VETOED, BUT WITH SOME NONBINDING "CONCILIATORY LANGUAGE" PROMISING TO HOLD DOWN SPENDING.

THE LONG PLAN WOULD PLEDGE "IN PRINCIPLE" TO CUT A DOLLAR FROM THE BUDGET FOR EVERY DOLLAR TAX CUT. BUT CONGRESS WOULD HAVE THE RIGHT TO RAISE OR LOWER CEILINGS AT WILL, IN EFFECT IGNORING THEIR OWN PROMISE.

BUT ALBERT SAID NO ONE HAD ANY ASSURANCES THAT FORD WOULD ACCEPT SUCH A PLAN. HE SAID HE UNDERSTOOD SOME REPUBLICANS HAD TALKED WITH FORD ABOUT THE PLAN, BUT "THEY HAVEN'T SOLD IT TO THE PRESIDENT."

"THEY HAVEN'T SOLD ME AT ALL," ALBERT ADDED.

WASHINGTON (UPI) -- THE SENATE AND PRESIDENT FORD REACHED A LAST MINUTE COMPROMISE ON A TAX BILL TODAY, BUT HOUSE DEMOCRATIC LEADERS REFUSED TO GO ALONG WITH THE SENATE'S PROMISE TO CUT FUTURE GOVERNMENT SPENDING BY THE SAME AMOUNT AS FUTURE TAX CUTS.

HOUSE LEADERS SAID THEY WOULD PASS THEIR OWN TAX CUT BILL WITH THEIR OWN SPENDING LANGUAGE AND LET THE SENATE -- AND FORD -- TAKE IT OR LEAVE IT.

THE HOUSE LEADERSHIP'S REACTION TO THE SENATE-FORD COMPROMISE AT LEAST TEMPORARILY DERAILED A DEAL THAT WOULD PREVENT WITHHOLDING TAXES FROM RISING EARLY NEXT YEAR.

SEN. WILLIAM ROTH, R-DEL., SAID ON THE SENATE FLOOR, "I'M PLEASED TO SAY THEY (THE WHITE HOUSE) WILL ACCEPT THIS." SENATE REPUBLICAN LEADER HUGH SCOTT AGREED, SAYING HE HAD "GOOD REASON TO BELIEVE THIS WILL BE ACCEPTABLE TO THE PRESIDENT."

FORD THEN TELEPHONED HOUSE SPEAKER CARL ALBERT DURING A LEADERSHIP HUDDLE TO SAY HE WAS "IN AGREEMENT" WITH THE LONG COMPROMISE, BUT THE HOUSE LEADERSHIP TURNED IT DOWN.

"WE ARE NOT GOING TO RECOGNIZE THE SENATE CONSIDERATION," DEMOCRATIC LEADER THOMAS O'NEILL SAID AFTER THE MEETING. WAYS AND MEANS CHAIRMAN AL ULLMAN AND BUDGET CHAIRMAN BROCK ADAMS THEN HELD THEIR OWN MEETING TO WORK OUT A HOUSE COMPROMISE.

"THE PRESIDENT HAS INDICATED" HE WILL SIGN THE TAX-CUT BILL IF IT INCLUDES THE SENATE COMPROMISE LANGUAGE, RHODES SAID.

WASH NGTON (AP) -- HERE IS THE TEXT OF THE PROPOSED TAX CUT COMPROMISE:

"CONGRESS SHARES THE PRESIDENT'S DETERMINATION TO REDUCE SPENDING LEVELS IN ORDER TO REDUCE THE NATIONAL DEFICIT.

"CONGRESS AFFIRMS ITS COMMITMENTS TO THE PROCEDURES ESTABLISHED BY THE CONGRESSIONAL BUDGET AND IMPOUNDMENT CONTROL ACT OF 1974.

"IF THE CONGRESS RECOMMENDS A CONTINUATION OF THE TAX REDUCTION PROVIDED BY THIS MEASURE FOR THE REMAINDER OF THE CALENDAR YEAR 1976, CONGRESS SHALL PROVIDE FOR REDUCTIONS IN THE LEVEL OF SPENDING WHICH WOULD OTHERWISE OCCUR BY \$ FOR EACH \$ OF TAX REDUCTION (FROM THE 1974 TAX RATE LEVELS) PROVIDED IN THE FISCAL YEAR 1977;
