I. GENERAL RESOURCES FOR THE MENTALLY RETARDED

A. INTRODUCTION TO AGENCIES WHICH PROVIDE MR SERVICES

As a result of the implementation of the Mental Health and Mental Retardation Act of 1966, each county in Pennsylvania has created an Office of Mental Health and Mental Retardation to coordinate all MH/MR services in their locale.

Providing mental health and mental retardation services for all those who want and need them is a large responsibility. To facilitate the process, the State of Pennsylvania created the federally-required divisions in Philadelphia which are called Catchment Areas. Populations in these areas are between 75,000 and 200,000. Base Service Units (BSU's) -- planned one to a Catchment Area -- were designed by the State as having primary responsibility for the residents living within the area's boundries.

When service requests are channeled through the Base Service Units, their staffs diagnose the problems and guide persons to the proper service within the facility or make arrangements for the needed services with other agencies which specialize in offering the particular services. The BSU's maintain confidential records to help insure individuals receive the appropriate services.

B. TYPES OF SERVICES FOR THE MENTALLY RETARDED

Mental retardation services include diagnosis, evaluation, short-term treatment, day care, vocational training and referrals for residential placement.

Interim care residential services are provided for mentally retarded persons who have been accepted for admission to a State School and Hospital. These persons have been placed on a waiting list and are in urgent need of residential care.


Sheltered workshops are designed for mentally disabled persons who are capable of working in a structured setting. Vocational training helps move trainees into non-sheltered jobs. Socialization programs -- including parties and field trips -- also help teach positive ways to live in the community.

Day care for developmentally disabled children of pre-school age provides for education and training, social service, hot meals, health-psychological-speech-hearing and language services, transportation and parental involvement.

C. PHILADELPHIA COMMUNITY MENTAL HEALTH/MENTAL RETARDATION CENTERS AND BASE SERVICE UNITS

Base Service Units are responsible for coordinating services to all developmentally disabled individuals and their families. Each Base Service Unit is responsible for providing services within a geographical area called a Catchment Area.

You can find the Base Service Unit for a particular address in Philadelphia by checking the boundaries of the BSU's on the map below or you can call MU 6-4958 for information on which BSU services a particular address.

Parent Network is made up of parents from the Philadelphia, Delaware and Chester County Associations for Retarded Citizens, United Cerebral Palsy Association, Ken Crest Centers, Furhman Clinic School, Child Advocacy Project of the Philadelphia Urban League, Developmental Disabilities Day Care Center of the Philadelphia Psychiatric Center's Base Service Unit and several other organizations.

The goals of the parents participating in Parent Network are to offer emotional support to the families of newly diagnosed retarded children and to help increase the new parents awareness of the community services available for retarded children. On-going professional consultation is available to the parents from the professional staff of the participating organizations but the primary service is parents talking to parents about the reality of having a retarded child.

2. SPARC

(South Philadelphia Area Rehabilitation Center)

DESCRIPTION: New workshop being planned for South Philadelphia area by BSU's 2A (Hall-Mercer Center) and 2B (Jefferson MR Center) in conjunction with Sons of Italy Chapter. Contact BSU's for information on present plans.

VI. RESIDENTIAL SERVICES

A. GROUP HOMES

Philadelphia has begun to develop small group residences which provide a family style living within the community for mentally retarded persons. The purpose of the program is to bring Pennhurst residents back to their communities as well as to provide appropriate homes for community persons requiring placement away from their own families. Based on the principle of normalization, the mentally retarded are provided experiences similar to those available to other community residents and are helped to develop toward an optimal level of functioning.

The following group homes are now operating or are being developed in the Cat chment areas noted with others being planned for opening during the next twelve months. It is recommended that contacts be made directly with BSU's regarding eligibility and applications for group homes in their area.

B. INTERIM CARE PLACEMENT

Interim Care applies to mentally retarded persons who, having been placed on the waiting list of a regional State School and Hospital, are awaiting admission and are thereby eligible for placement in a private state-licensed residential placement facility.

The family of a retarded person who believes that residential placement is required should contact their local BSU to explore residential placement options or alternatives.

Families are also advised to check with their own BSU to become familiar with medical and dental resources affiliated with the Mental Retardation Center.

Families of the retarded seeking the above services should contact their local BSU to inquire about these services that are being provided through "family resource funds". These publicly supported services are available for the purchase and/or provision of such services to mentally retarded individuals and their families throughout the 13 Catchment areas. Priority is given to those services which are necessary to keep a retarded person in his own home.

B. RESPITE CARE SERVICES

DESCRIPTION: Respite care is a program designed to help families by providing a respite from the task of caring for a developmentally disabled individual in time of particular needs or stress (e.g. emotional or physical exhaustion of a family member responsible for the day-to-day caring for a disabled individual).

Services offered by a respite care program:

1. Temporary full-time care in a small residential setting. High staff-to-client ratio. Maintenance of the client's usual routine wherever possible. Relaxed homelife surroundings contribute to making a client's stay a pleasant one.

2. Services in a family's own home provided by professionally trained staff ranging from registered nurses to homemakers.

3. Auxiliary services might include information and referral, family counselling, training in care techniques.

C. SUPPLEMENTAL SECURITY INCOME (SSI)

Supplemental Security Income (SSI) is a new federal government financial aid program for aged persons who are disabled (both mentally and/or physically) or blind. Any retarded citizen, or a relative or guardian of a retarded person, who meets the following minimum elegibility requirements to receive SSI benefits should:

a) Go to their local Social Security Administration Office to make application for SSI benefits,

b) Call PARC's Community Referral Service (LO 3-7272) if they encounter difficulty in interpreting the distinctions cited in the following examples of categories of people eligible to receive SSI benefits.

1. Child living at home (under age 18 or between 18 and 22 years and in school). Note: School includes sheltered workshop or adult activities program.

Parents income is considered <u>deemed</u> to the child. In other words, the parents' income must be reviewed using the following formula and the child will be eligible only if the income falls within the below limits:

Total gross income (combined for both parents)

- \$65 deduction for wage earner (only one deduction if both parents work)
- \$130 deduction for one parent
- \$65 for each other dependent not including the applicant
- \$20 disregard from any earned or unearned income of the child.

The child's benefit will be the difference between the remainder of the income of the family and the \$93 maximum benefit for which the child is eligible.

\$400 father's gross earnings per month
<u>65</u> work expense
<u>335</u>

In this case the child would be eligible for a maximum of \$93 since he is living at home, deduct the remainder of the parents'income which is \$55, and the child would be eligible for \$38 a month SSI.

 A retarded adult living at home with parents. (Adult is over age 22 or over age 18 and not in any school or program.) Only the applicant's assets and earnings count (not the parents' earnings).

Income earned at sheltered workshop (for example)

- \$65 work expense

- Divide remainder by two

Example:

\$100 month earned at sheltered workshop

- 65 work expense
 - 35

- 17.50 \$35 divided by two

\$ 17.50 remainder to be deducted from maximum benefit

Note: \$20 disregard is allowed only once each month either from earned or unearned income. If this person had no unearned income (such as Social Security) the \$20 disregard would be deducted from the \$17.50 and there would be no "remainder" of income to be deducted from the maximum benefit.

To continue the example if there is unearned income, such as social security benefits, court order, bonds, etc., the unearned income must be figured separately:

- \$60 unearned income
- -20 disregard
- \$40 unearned income left to be deducted from maximum benefit

 - \$93.00 maximum SSI benefit
 - -57.50 total countable income
 - \$35.50 SSI monthly benefit for which applicant is eligible
- 3. While applicant is in institution. Persons in institutions are entitled to \$25 personal needs allowance if they are in a public institution where more than 50% of the costs are paid by Medicaid or in a private institution where more than 50% of the costs are paid by Medicaid.

If the costs are not paid by Medicaid, they are not entitled to any benefit if they are in a public institution but they are entitled to a full benefit of \$140 if they are in a private institution.

So far group homes have been determined to be private and not public. Check with the Social Security Administration regarding a case of this type as this is a difficult area.

- 4. Adults living by self or in group home. The income of the applicant is determined the same as in Example 2. The maximum benefit, however, would be \$140 instead of \$93.
- 5. Determination of Disability.

Determination of disability is made in the Disability Determination Section of the Bureau of Vocational Rehabilitation in Harrisburg. (This is the same unit that determines Social Security disability.)

Children under 18:

- I.Q. of under 59 applicant is automatically eligible.
- I.Q. between 60 and 69 applicant is eligible if another impairment is present such as emotional or physical handicap.
- If the child is too young to be tested for an I.Q. score, a developmental assessment is made. If the child has achieved developmental milestones at a level less than half of his or her chronological age, the child is eligible for SSI (assuming other eligibility factors are met such as those mentioned earlier).

Adult over age 18 or over age 22 (if between 18 and 22 and attending school, the person is considered a child).

- I.Q. of under 49 applicant is automatically eligible.
- I.Q. between 50 and 69 the applicant is eligible if another impairment is present such as emotional or physical handicap.

5. Determination of Disability continued

The determination of disability is considered to be permanent and not subject to later review unless the award letter to the family states otherwise. Some reasons why the determination might have to be remade at a later date are if several psychologicals have been done and each time the applicant showed higher scores, or if there is some other reason why improvement would be expected. Most determinations are permanent.

If the applicant's family does not agree with the original determination, they can ask for an appeal through their local Social Security office. The case will then go to the Reconsideration Unit within the Disability Determination Section. If the family is still not satisfied, further recourse is through the administrative law judge and civil court.

6. Pennsylvania State Supplement to SSI

Effective July 1, 1974 Pennsylvania has elected to pay \$20 more to an individual and \$30 more to a couple who gualify for the Federal SSI payment.

Effective July 1, 1974 the maximum amount for the Federal SSI payment will be raised to:

\$97 - Child living at home

\$97 - Adult living at home

- \$146 Adult living by self or in group home
- The following example uses the July 1, 1974 SSI maximum: In order to qualify for the State Supplement, the applicant must have less "countable" income than \$146. If If a person has "countable" income of \$147, he is not eligible for benefits from SSI or from the State Supplement. The State Supplement is given to people who qualify for SSI.

If a person has "countable" income of \$145 a month, he is eligible for the difference between the maximum SSI payment of \$145 and \$166 (the addition of the \$20 State Supplement to \$145) which is \$21 per month.

7. Medical Coverage for SSI Recipients

Anyone who receives SSI in any amount is eligible for a white medical card through the State of Pennsylvania. This card is the same as the card issued to recipients of public assistance and includes the cost of in-patient care, outpatient, drugs, etc.

7. Medical Coverage continued

These white cards are issued from the Pennsylvania Department of Welfare and there has been some delay in their issuance. People receiving SSI are eligible for this card. They do not have to apply for it -- it should be issued automatically.

If a person has been receiving Social Security disability payments (not SSI) for over two years, he is eligible for Medicare coverage as a disabled person even though he is not 65 or over. This Medicare coverage costs \$6.70 (effective July 1, 1974) and is deducted from their disability check every month. If this person is now eligible for SSI benefits, they should receive the <u>white</u> card from the Department of Welfare which is more comprehensive than Medicare and is free.



Profile on George Horowitz Prepared April 24, 1975

When George Horowitz, President of the Philadelphia Association for Retarded Citizens, speaks of PARC's purposes, he stresses above all as its prime goal to achieve the constitutional rights of persons who are retarded citizens - - the right to education, the right to work, the right to medical treatment, the right to first-class citizenship, the right to live in the community in sociability and fellowship.

In this context Mr. Horowitz explained that "The First Lady, by her gracious acceptance to be guest of honor on the occasion of PARC's 25th anniversary observance, May 12, 1975, is helping to give status to those citizens too long deprived of personhood and too long considered second-class citizens. Mrs. Ford is giving credence to the great strides that persons who are retarded are capable of making. Despite the fact that they are slower to learn, they become productive citizens when given adequate opportunities through specialized education, vocational training and other services which PARC and others have pioneered to create."

When Mr. Horowitz, a resident of Wyncote, presents PARC's Humanitarian Award to Mrs. Ford, his wife, Esther, will be there also. Their, two children are Dr. Harvey Horowitz, a resident of Wynnewood, and Mrs. Carol Ziev of Huntingdon Valley, wife of Dr. Michael Ziev.

Mr. Horowitz is also president of Yahn and McDonnell, Inc., wholesale distributors of tobacco, cigars and cigarettes. He has been president of PARC for more than four years.

Mr. Horowitz's commitments extend into many areas in addition to retardation. For example, he is first vice president of the Northwestern Institute of Psychiatry, past chancellor-commander of the Barbarossa Lodge of the Knights of Pythias, member of the board of trustees of the Emanu-El Congregation in Philadelphia, member of the board of governors of the Golden Slipper Club and Camp for Underprivileged Children, member of the Fellowship Commission, and member of the board of March of Dimes. He received the Israel Bond Award.

His business affiliations include; president of the Philadelphia Association of Tobacco and Confectionary Distributors, and vice president, Executive Management Division of National Association of Tobacco Distributors.

Add 1- Profile on George Horowitz

Mr. Horowitz's efforts on behalf of PARC's Work Training Center are typical examples of his social commitments to the community. He was instrumental in helping to convert this facility into a modern and model workshop for the vocational training of adolescents and adults who are retarded citizens. This center enables many of these persons to be trained to work in restaurants, banks, hospitals, post offices and other businesses, thus becoming taxpayers rather than taxburdens. When Mr. Horowitz became involved in the Work Training Center, it was located in a loft. Today, it occupies about 44,000 square feet and is accredited as one of the finest in the country by CARF (Commission on Accreditation of Rehabilitation Facilities) which is highly regarded in the field of hospital and rehabilitation facilities. This Center, founded in 1957, was the first in Philadelphia.

Inladelphia Association for Retarded Citizens

A new annex at the Center, still to be dedicated, includes a model apartment which makes it possible for trainees to learn and strengthen community and home-living skills. This can have special significance for those who have lived in institutions and are ready to embark on a new life.

In all instances of his community endeavors, Mr. Horowitz has volunteered his management expertise to non-profit organizations such as PARC. This knowledge is essential in an organization such as PARC where large contracts are made with business and industry for its sheltered workshop -- a division of the Work Training Center.

During Mr. Horowitz's terms of office as president, PARC has extended its philosophy from a direct-service agency to incorporation of the motivating-agency principle on a city-wide basis. Under this principle, PARC works to identify priorities, existing needs in services, helps to ameliorate difficult or crisis problems, serves as consultant to organizations in the region or city interested in improving services or creating new ones for 60,000 to 80,000 persons in Philadelphia who are retarded. As an umbrella agency, PARC will strive to motivate, to encourage or support all agencies interested in the field of retardation.
