on June 5, 1976

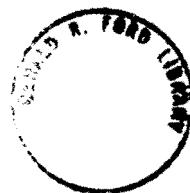
The "Marienda" is an annual celebration commemorating the establishment of the City of Monterey, California. On June 5, 1976 they will celebrate their 206th anniversary.

The event is sponsored by the Monterey History and Art Association, Mr. Raymond Smith, President (408-624-1593). Attendees will be only History and Art Association members - about 750.

The event will be held in the Pacific Building near Fisherman's Wharf (buildings belong to the State Parks and Fisheries Administration). It starts at 12:00 noon with a reception and barbeque. Among the special guests will be "La Favorita", the Queen of the event who comes from an old line California family, and her princesses and a Duena and Mayor Peter Coneiglio along with the Spanish Counsel General from San Francisco.

Following lunch there is a cake cutting ceremony and entertainment.

This is a colorful and festive occasion which has been in existence for about 25 years. It is not a Bicentennial event.



Rep. Paul (Pete) McCloskey, who represents California's 12th District, was first elected in 1967 to fill the seat left vacant by the death of Rep. Arthur Younger. The GOP primary attracted attention that year, because McCloskey defeated Shirley Temple Black. McCloskey has had tough primary fights either election since.

He first attracted national attention on the war issue, and in 1972 challenged President Nixon in the New Hampshire primary. He also spoke out early on Watergate.

The 12th (it has been redistricted since his first election) is basically a Democratic district, where George McGovern got 49 percent of the vote in 1972. The district includes high-income, liberal leaning Menlo Park, Palo Alto, where Stanford is located, and the suburbs of Portola Valley and Woodside. It also includes some middle-class factory suburbs. The ecology movement has been strong in this area.

In 1974, President Ford helped McCloskey's campaign, a favor he returned in New Hampshire.

He graduated from Stanford University and is a lawyer. He is the father of two sons and two daughters.

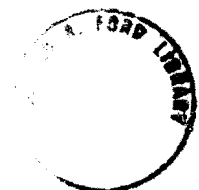


Rep. Burt Talcott, a Republican from California's 16 District, was first elected to Congress in 1962. The district is noted for its scenic beauty, including the Monterey cypresses at Carmel's Pebble Beach and the mountainous Big Sur coast. The 16th also contains some of the nation's richest farmland, including the lettuce fields of the Salinas Valley and the artichoke fields near Watsonville.

Talcott is from Salinas as was the late John Steinbeck. More than eight percent of the District's voters are college students from California State Polytechnic in San Luis Obispo or the University of California branch at Santa Cruz.

Talcott, considered by the Almanac of American Politics as one of the most strait-laced members of Congress, is a member of the Appropriations Committee. In 1972 and 1974, Talcott has had a tough fight with a Mexican-American candidate. In 1974, Talcott was the target of liberal and environmental groups, but won a narrow (2,000 vote) victory.

He is married and has one son, an Air Force Captain. He graduated from Stanford University and is a lawyer.

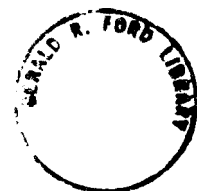




Rep. Shirley Pettis, who was elected to fill her husband's seat after his death in a plane crash, represents California's 37th District. The district is one of the largest geographically in the country. It includes all of San Bernardino County (20,000 Square Miles) and most of Riverside County. It stretches almost from the ocean to the Colorado River. The district includes upper-income parts of San Bernardino and its suburb of Redlands and Palm Springs and other desert towns with heavy populations of retired people.

Mrs. Pettis won more than 50 percent of the vote in a field of Democrats and Republicans in the special election, but it is expected she will have difficulty retaining the seat.

Mrs. Pettis, a 7th Day Adventist, had managed the family ranch and helped operate Magentic Tape Duplicators Co. and Audio Digest Foundation before her election to Congress. She has two children, a son and a daughter. She was active in the Congressional Wives Club and the Congressional Wives Prayer Group.





OAKLAND is divided between two Congressional districts, the 8th and the 9th. Both are represented by Democrats.

Rep. Ronald Dellums represents the 8th District, which includes ~~Oakland~~ the north Oakland black ghetto. Dellums, a former social worker and Berkley city councilman, was first elected in 1972.

Rep. Forney (Pete) Stark, who also was first elected in 1972, represents the 9th District. This district includes the suburbs of Oakland and the East Bay area across from San Francisco. Stark, a wealthy banker and former board member of Common Cause, is a member of the Ways and Means Committee.

The Oakland Tribune is still owned by the family of the late Republican Sen. William F. ~~Know~~ Knowland.

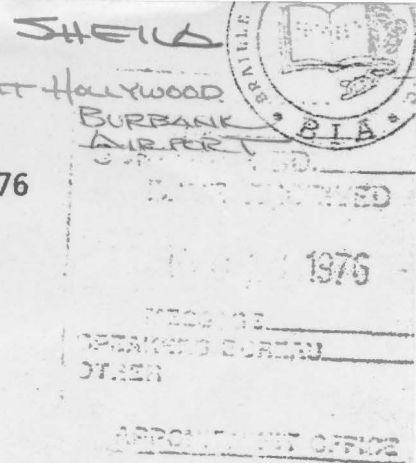
Mr. President:

Braille Institute of America, the nation's leading educational and service organization for the blind, is preparing to dedicate the central structure of its new Los Angeles campus. This \$5 million complex already is attracting international attention, because it will set a world standard in functional and beautiful facilities for rehabilitation of those with severe sight loss.

It would be an unforgettable occasion for Southern California and for the nation if you and Mrs. Ford would honor us with your participation in this historic event. We would like to schedule the dedication for May or June, but have delayed in specifying a date in the hope that you might include it on your schedule, perhaps in conjunction with other California appearances.

Since Braille Institute, a 56-year-old community service organization, so well expresses your own self-help philosophy, it would seem particularly appropriate for you and Mrs. Ford to participate in the formal dedication of this very special and purposeful structure. Braille Institute derives its entire support from gifts and bequests from private citizens, and thousands of community volunteers participate in an outstanding program which supplements the work of its professional staff.

Founded in 1919, Braille Institute has grown from a single braille press in a blind man's garage to a nationally-known organization which now offers a comprehensive program of counseling, rehabilitation, training, education and special services. Braille Institute is nonprofit and nonsectarian, and all of its services are offered without charge to any legally blind man, woman or child. In addition, the Braille Institute Library, a branch of the Library of Congress under its Division for the Blind and Physically Handicapped, provides services to the disabled of the Southwestern United States. The Braille Institute Press produces braille reading material and cassettes for the blind all across the nation.



At the time of our dedication, Betty Clark, an outstanding and charming young woman, an award-winning artist and a winner of Braille Institute's coveted Light Award for service to the blind, would like to present you with a handwoven American flag which has taken her two years to complete. Ms. Clark also happens to be blind. The flag is of museum quality, and she would like to make this appropriate gift to you in this Bicentennial year.

We await your reply with the hope that we will be welcoming you and Mrs. Ford as our special honor guests upon this significant date in Braille Institute's history.

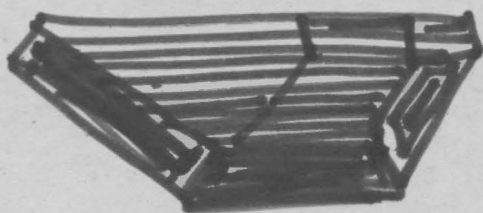

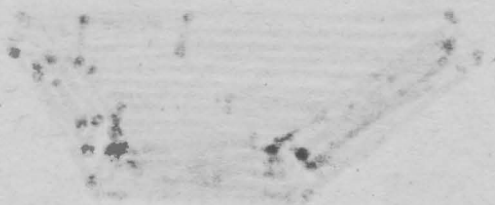

On the Republican side the primaries have disclosed the weight and seriousness of the Reagan challenge to President Ford. The former Governor of California has proved to be a powerful and effective campaigner backed by a lot of Republicans who clearly are less than eager to follow President Ford's banner into the fall campaign. Ford has set no political prairies afire. He has been an unimpressive campaigner. He has failed to take advantage of his incumbency. He has let Reagan divert attention from the Ford presidential record, which is perfectly respectable, to extraneous issues such as Panama. Reagan has dominated the debate and pushed Ford into a series of ignominious changes of White House policy, particularly on busing.

The above leaves a big question mark over the future of the Republican Party. Ford will not arrive at the Republican convention in Kansas City on Aug. 16 as the overwhelming and enthusiastic choice of his party. Nor is he likely to arrive with decisive delegate strength. Carter is the candidate-presumptive in the Democratic Party. Right now, there is no similar candidate-presumptive in the Republican Party. There is Ford who has done poorly in the primary campaign and is more or less a general second choice. There is Reagan who has done spectacularly well in the campaign, but could divide the party disastrously.

The above leaves wide open the possibility that between now and Aug. 16 there may be much rethinking going on throughout the rank and file of the Republican Party. Is there any third way out for them? Must they take either the nonspectacular Ford or face a bruising struggle at their convention between right and left wings of the party which could tear it apart again as it did in 1964?

There is no presently visible third way out of the Republican dilemma. If the Republicans use their time to best advantage they just might come up with something more promising. If they don't, then Carter will get a jump in rank from Democratic candidate-presumptive to presidential heir-apparent. -- (6/3/76)
