Dr. Theodore C. Marrs has been Special Assistant to the President since September 6, 1974. From 1970 to May 1974, he served as Deputy Assistant Secretary of Defense for Reserve Affairs.

From 1964 to 1970 he was Deputy for Reserve Affairs and Education in the Office of the Secretary of the Air Force. From 1963 to 1964 Dr. Marrs was Special Assistant to the Surgeon General of the Air Force. In 1953 he became a medical officer in the U.S. Air Force Reserve and for ten years was continuously involved in military medical administration. From 1945 to 1951 he was engaged in the general practice of medicine in Montgomery, Alabama, where he helped to organize and manage the Jackson Hospital and Clinic, the Pineview Manor for the Handicapped, and the Elks Clinic for the Handicapped; and served as national consultant to the United Cerebral Palsy Association.

He was born on August 29, 1918, in Rutherfordton, North Carolina. Dr. Marrs attended the University of Tennessee, completing the pre-med course in 1937 and receiving his M. D. degree in 1940. He completed his residency at Henry Ford Hospital, Detroit, Michigan, in 1944. In 1967 Dr. Marrs attended the Industrial College of the Armed Forces and the National War College. In 1968 he was promoted to Brigadier General in the U.S. Air Force Reserve.

Dr. Marrs is married and has five sons and two daughters.

NESSEN REPLIED THAT IT WOULD BE WRONG TO SUGGEST FORD IS ARRANGING HIS SCHEDULE ''IN SOME WAY TO COUNTER OR TOP THE DEMOCRATIC CONVENTION.''

ROGERS C. B. MORTON Biographical Data

Rogers C. B. Morton has been Secretary of the Interior since January 29, 1971. President Nixon announced his intention to nominate Mr. Morton to be Secretary of the Interior on November 25, 1970, and his nomination was submitted to the 92nd Congress when it convened in January 1971.

Until he assumed his Cabinet position, Mr. Morton has been Chairman of the Republican National Committee since April 1969 and a Member of Congress since January 1963. Mr. Morton was elected to the 88th Congress from Maryland's First District in 1962 and was subsequently elected to the 89th through 92nd Congresses.

While serving in the Congress, Mr. Morton was a member of the Committee on Interior and Insular Affairs (1963-68), the Committee on Merchant Marine and Fisheries (1963-68), the Select Committee on Small Business (1967-68) and from 1969 until he became Secretary of the Interior, Mr. Morton was a member of the Committee on Ways and Means.

Mr. Morton, while he was a Congressman, also was a member of the Public Land Law Review Commission (1965-66), the President's Commission on the Status of Puerto Rico (1965-66) and the Board of Visitors to the United States Naval Academy (1966-70).

Prior to his election to Congress, Mr. Morton was with Ballard and Ballard Company from 1939 to 1951, serving as President from 1947 to 1951, and was Vice President (1951-53) and a Director (1953-71) of the Pillsbury Company after the two firms merged.

Mr. Morton was born September 19, 1914, in Louisville, Kentucky, and received a B.A. degree from Yale University in 1937. He served with the U.S. Army from 1941 to 1945, attaining the rank of Captain.

Mr. Morton is married to the former Anne Jones. They reside in Easton, Maryland, and have two children.

HOWEVER, A SPOKESMAN FOR THE PRSIDENT FORD COMMITTEE SAID WHEN ASKED ABOUT THE CANDIDNESS QUESTION, "'IF THAT'S A FAULT I CAN THINK OF NO BETTER ONE.''

ASKED IF THERE WAS ANY LINK BETWEEN KAYE'S LEAVING AND THE RESIGNATION OF WHITE HOUSE TELEVISION ADVISER ROBERT MEADE, THE SPOKESMAN SAID, "PETER HAD A GOOD WORKING RELATIONSHIP WITH RON NESSEN."

A RIFT BETWEEN MEADE AND PRESIDENTIAL PRESS SECRETARY NESSEN WAS WIDELY REPORTED AS THE REASON FOR MEADE'S QUITTING.

FORMERLY A POLITICAL WRITER WITH THE SAN DIEGO UNION AND NEWS DIRECTOR OF A SAN DIEGO TELEVISION STATION, KAYE WON AN EMMY WHILE WORKING AS A CORRESPONDENT FOR THE NATIONAL PUBLIC AFFAIRS CENTER FOR TELEVISION FOR HIS REPORTING OF THE SENATE WATERGATE HEARINGS.

HE WAS PRESS AIDE IN THE 1952 PRESIDENTIAL CAMPAIGN OF DWIGHT EISENHOWER AND ASSISTANT PRESS SECRETARY IN THE 1960 CAMPAIGN OF RICHARD NIXON.

IN AN INTERVIEW LAST MAY, KAYE TALKED ABOUT THE LACK OF EXPERIENCE IN THE FORD CAMPAIGN:

"BECAUSE THE PRESIDENT HAS NEVER RUN NATIONALLY BEFORE AND HAD NO CADRE TO CALL ON, AND BECAUSE OF THE RESIDUAL EFFECTS OF WATERGATE AND THE LIKE, THERE SEEMS TO BE A SHORTAGE OF PROFESSIONAL CAMPAIGN EXPERIENCE," HE SAID.

"RON NESSEN BULLIES A YOUNG WOMAN

Jill Vig is a young reporter for the Vail Trail in Vail, Colorado, the ski center where President Ford often vacations.

Last August, Miss Vig, an attractive blonde, blue-eyed Norwegian, interviewed Mr. Ford's Press Secretary, Ron Nessen.

The interview was as pleasant as Ron Nessen can be--until Miss Vig asked about the daily White House press briefings.

"Do you feel there's a great deal of strife between yourself and the press?" she asked, to which Mr. Nessen replied:

"No, what makes you say that?" "Well, " she responded, "the general tone of the press briefings."

"Press relations have never been better. They've been steadily progressing," countered Nessen--whose furious battles with the press have been detailed by Time, Newsweek, wire services, and the networks.

Miss Vig selected 8 of the White House Press Corps to interview at random. One comment said Nessen was doing a reasonably good job. The other responses charged Nessen with lack of information, failing to obtain requested information, stupidity, and misleading the press.

Miss Vig was reading the 8th response when Nessen exploded:

"You had your story written before you ever came in here," he charged. "You picked out the people who would support your view. Well you can stop doing your knife job on me little lady. I don't have to stand for it."

When I asked Nessen about this, he replied it was old stuff and contained inaccuracies. I asked him if he could designate any and he refused--in his most arrogant style.

Susan Ford now works as a photographer for AP. Presumably the Secret Service will be a deterrent to anyone bullying her in the manner in which President Ford allows his press secretary to bully another young woman--who told WAVA: "I was on the verge of tears by the time the press secretary finished his beating."

Ron Nessen at one time worked for this radio station. Beginning today and everyday at 1:15 PM, my 2-minute broadcast, "TODAY IN THE WHITE HOUSE" will be subtitled, "THE RON NESSEN SHOW."

And Ron, there's no use tyring to get at me through WAVA's owner. You tried that, and failed. Miserably.
