
SUBJECT: American University of Beirut


In a meeting today with Dr. Charles Malik of Lebanon, I was impressed by his case for a one-time 8 million dollar supplement to ensure the survival of the American University of Beirut. The University has made substantial and influential contributions in the Middle East. Although it will receive some \$4.5 million from AID's Schools and Hospitals appropriation, it is in particularly difficult financial straits because of the current disruption in Lebanon.

The one-time infusion of additional money will allow the University to open and operate until next October. Reforms being taken should allow it to operate with more normal levels of support following that period.

Ensuring the survival of the University would have an uplifting effect on the morale of the Labanese people at this uncertain time. It would be an earnest of our interest in Lebanon and in intellectual endeavors and spiritual values.

Reportedly, key Congressmen are sympathetic and would be receptive to a supplemental for the American University if supported by the Administration. I recognize that this idea has already been given some consideration and that an addition would need most careful scrutiny by OMB and NSC (State/AID) in light of your overall budget priorities. Because of the unusual circumstances that exist in Lebanon today, I urge you to consider a second look at the University situation.
