### No Health Service for PCB--

The PCB has just been informed that they can no longer use the Health Unit at 2000 "M" Street except for acute medical emergencies. Approximately 50 PCB staff members have been visiting the nurse each month for minor aches and pains, but now HEW has terminated this service until the PCB pays their share of the expenses in funding the medical facility. OMB has not given the PCB money for this expenditure yet, but when and if they do, you will be notified immediately when the service is operational. It is hoped this will happen within the next week to ten days.

### The PCB Rip-Off

There is a person in the 2033 "M" Street building with a real problem. It seems this individual has stolen most of the staff's radios, clocks, pocket calculators and now is feeding on eyeglasses, pipes, and an occasional swimsuit. These are not exactly black market items. The profile of the office thief is quite often as not found in the upper end of the pay scale in the professional category. An investigation is underway, and we hope this person will soon be identified so that his/her problem can be treated. In the meantime, if you want to keep it, lock it up or take it home with you! And I am not referring to that cute little thing sitting next to you.

Why Do The Radiators Leak Water? or Once A Slum Landlord Not Always A Slum Landlord

Our highly qualified investigative reporters have found the radiators at 2033 'M' Street leak on all floors except the Ninth. Actually they leak on the Ninth Floor but the water draps through directly to the Eighth Floor since they are recessed into the floor (the privilege of power). They leak because the humidity in the air condenses on the radiator cooling coils. Aha! you say. What a stupid arangement. Today, yes -- ten years ago it was the most sought after system. Ten years ago they ran the system 24 hours per day. Once the humidity was removed from the building, the radiators no longer leaked. Today it costs \$700 per evening to run this system, so it is shut down at 8:00 each night. Before it is started again at 6:00 a.m., the building air is as humid as the outside air, and, therefore, there is a condensation build-up and then leaking. To correct the system will cost several hundred thousand dollars. To run the equipment 24 hours per day to keep the humidity down would cost millions in the long run. Since they will be trying to rent the building to new tenants in the coming months don't be surprised if they run the system 24 hours each day to eliminate this leaking problem and therefore make the building more presentable.

We are starting a very novel process in the world of bureaucracy: closing down. What was last fall an office of less than a score of people and briefly reached a zenith of some 600 will come full circle by mid-September. This will necessitate reorganizations, moves, and perhaps eventually giving up some or all of either 2033 M Street or 1206 New Hampshire, since the General Services Administration can (almost always) find a use for the smallest spare office. This phasing down is separate from and will accompany the shift in the nature of the workload, as the bulk of our cases travel from files to attorneys to docketing to the Board to the President and back to the files. I have been hoping for the past several weeks that another program, another crisis would arise, and that we could all stay together. It doesn't look that way; applications for the Presidential Clemency Board Alumni/ae Association are being accepted. Ave atque vale.

# I have a question...

For Charles Goodell from Cathy Russell

- Q. What is the story on the phase-out? Who's going back, when, how long will a clean-up operation be here and how many will be involved?
- A. Personnel on detail from other agencies will gradually be sent back to those agencies as the need for them diminishes. The President has asked that the Clemency Board complete its operations by September 15. It is likely that there will be some small continuing operation, probably attached to a permanent agency, to clean up whatever remains to be done after September 15. These plans are under discussion now.

For Charles Goodell from Scott Partridge

- Q. What is the Clemency Board's position on legislation pending before Congress to extend the life of the clemency program and broaden the eligibility requirements?
- A. The Clemency Board officially recommended extension of the program, but it is unlikely that the President will recommend further extension or that Congress will pass it.

For Larry Baskir from Scott Partridge

- Q. What is your latest prognosis as to the effect of a clemency discharge on an applicant's ability to obtain private employment, public employment and veteran's benefits, including medical benefits for veterans injured during their service in the military?
- A. We are not yet sure what the impact of a clemency discharge(or, for that matter, a pardon) will be. We expect that it will help an individual by demonstrating to employers his good faith in applying for clemency and performing alternative service. A study is under way in Pennsylvania to test its impact on employers, and we should get some results in a few weeks.

For Mary Liquid from Anonymous on the 9th Floor

- Q. Do you think it would be possible to have a PCB homecoming dance?
- A. Yes, as a matter of fact, a study is being undertaken to judge the feasability of such a project. If OMB approves financial backing, it will be held immediately following our homecoming softball game under the next full moon at Hungry Herman's.
