

Attached is a memorandum describing legal prohibitions that apply to any Board Member who is employed with or without compensation for a period exceeding 130 days during any period of 365 consecutive days. It was prepared by Robert Standard who has a special expertise in this area.

It appears that there is no provision in the law which permits a waiver. An alternative that might be explored, involves changing the status of the Board Members from temporary or special employees to contact.

Before doing so I would like a chance to talk to you.

All officers and employees of the United States in the executive, legislative, or judical branch are subject to the conflict-of-interest provisions contained in 18 U.S.C. 205, which reads in pertinent part as follows:

"Whoever, being an officer or employee of the United States in the executive, legislative, or judicial branch of the Government or in agency of the United States, including the District of Columbia, otherwise than in the proper discharge of his official duties-

- (1) acts as agent or attorney for prosecuting any claim against the United States, or receives any gratuity, or any share of or interest in any such claim in consideration of assistance in the prosecution of such claims, or
- (2) acts as agent or attorney for anyone before any department, agency, court, court-martial, officer, or any civil, military, or naval commission in connection with any proceeding, application, request for a ruling or other determination, contract, claim, controversy, charge, accusation, arrest, or other particular matter in which the United States is a party or has a direct and substantial interest--

shall be fined not more than \$10,000 or imprisoned for not more than two years, or both.

A special Government employee shall be subject to the preceding paragraphs only in relation to a particular matter involving a specific party or parties (1) in which he has at any time participated personally and substantially as a Government employee or as a special Government employee through decision, approval, disapproval, recommendation, the rendering of advice, investigation, or otherwise, or (2) which is pending in the department

or agency of the Government in which he is serving: <u>Provided</u>, that clause (2) shall not apply in the case of a special Government employee who has served in such department or agency no more than sixty days during the immediately preceding period of three hundred and sixty-five consecutive days."

As used in 18 U.S.C. 205, the term "special Government employee" means:

"an officer or employee of the executive or legislative branch of the United States Government, any independent agency of the United States or of the District of Columbia, who is retained, designated, appointed, or employed to perform, with or without compensation, for not to exceed one hundred and thirty days during any period of three hundred and sixty-five consecutive days, temporary duties either on a full-time or intermittent basis." (18 U.S.C. 202-Emphasis added)

From a reading of the above statute, it is clear that a "special Government employee" is not subject to the same limitations as a regular Government employee. A "special government employee" is only prohibited from representing individuals before a court or Government agency in a matter in which the United States is a party or has an interest if he has at any time participated personally and substantially for the Government on the same matter. However, after the elapse of 130 days, a "special Government employee" becomes a regular officer or employee. As such, he may not represent, while he is a Government employee, anyone before a court or Government agency in any matter in which the United States is a party or has an interest.

It is interesting to note that the conflict-of-interest provisions refer only to officers or employees of the U.S. Government. Technically, a contract employee, i.e., an individual who works for the U.S. Government as an independant contractor, is not considered to be an officer or employee of the U.S. Government, and therefore, is not subject to the above cited conflict-of-interest restrictions. For this reason, it is important to note that only officers and employees of the Presidential Clemency Board are subject to the conflict-of-interest provisions. An individual who works for the Clemency Board as an independant contractor is not. He is not prohibited from representing clients before a court or Government agency in a matter in which the U.S. is a party or has an interest.

Members of the Presidential Clemency Board hold their present positions by virtue of President Fords Executive Order dated September 16, 1974.

Section 1 of the Order reads as follows:

"There is hereby established in the Executive Office of the President a board of 9 members, which shall be known as the Presidential Clemency Board. The members of the Board shall be appointed by the President, who shall also designate its Chairman."

Section 5 of the Executive Order establishes the rate of pay these members are to receive:

"Each member of the Board, except any members who then receives other compensation from the United States, may receive compensation for each day he or she is engaged upon the work of the Board at not to exceed the daily rate now or hereafter prescribed by law for persons and positions in GS-18 as authorized by law (5 U.S.C. 3109), and may also receive travel expenses, including per diem in lieu of subsistence as authorized by law (5 U.S.C. 5703) for persons in the government service employed intermittently."

5 U.S.C. 3109, cited by section 5 of the President's Executive Order, authorizes the head of an agency to procure by contract, when authorized by an appropriation or other statute,

"the temporary (not in excess of 1 year) or intermittent services of experts or consultants or an organization thereof, including stenographic reporting services."

From a reading of section 5 of the President's Executive Order, and section 3109 of title 5, United States Code, it might have been possible to appoint Board members as independent contractors, and thus any outside legal work performed by them would not violate any of the above cited conflict-of-interest provisions. In practice, however, it should be noted that most members of Presidential Boards and Commissions are hired as Government employees, since a contract employee cannot supervise Government employees. Since members of the Presidential Clemency Board took an oath of office before they started their work at the Board, they would have to be considered Government employees. Accordingly, they are subject to the above cited prohibitions on conflict-of-interest. As to whether it would be possible to rescind these appointments in order to hire all Board members as contract employees, it would probably be necessary to amend President Fords Executive Order. This is a matter which needs additional consideration.

6. The employment of the typists eliminated the backlog in typing of finals. I have personally visited each of the teams at 1206 and Ray has seen those teams at 2033. It is our understanding that there are no more finals yet to be done from the previous accumulation thereof. We are, therefore, current.

* * * * * *

The use of the temporary clericals was a success in terms of eliminating the summary backlos. It was even a success in terms of the relative ease with which the process of getting summaries to the clericals, and back from them, was established and worked. This was largely because of the extremely competent work of Gwen Howard, from Hickman's team, who handled the process for me.

The problems we had stemmed from deficiencies in the system which we were not able to perceive until it was tested to the extent that it was.

Once a summary is typed in final, a whole administrative process with which none of us are adequately familiar, and which has not yet been adequately streamlined, comes into play.

Once summaries are typed, they must be proofread by the teams. They are then xeroxed, along with the BA forms and the Ag/Mits. These are then returned to the teams where they are collated (or if collated at the Xerox, assembled) and forwarded to D/D. There is a serious problem with the speed and efficiency with which we handle this part of the process. Xeroxing is time-consuming, though we have learned that with full-time operators of some skill, approximately 60 summaries, BAs and Ag/Mits can be done per hour (400 per eight hour day, assuming a steady flow of summaries to a Xeroxer). There is confusion in the Xerox room because of the different sizes of paper that are used, and the fact that a set of summaries must be typed, and then a set of the other, legal sized forms done. I RECCOM MEND THAT WE ALTER THE BA AND AG/MIT FORMS SO THAT THEY CAN ALL BE PLACED ON REGULAR SIZE PAPER.

Presently once the summaries are done in xerox, they go back to the various teams. This is so the original and several copies (generally three) can be extracted and placed in the case file. This apparently has to be done. As it stands now, the time between final xeroxing and presentation has become so short that if an attorney does not keep a copy with which to work, he will find himself before a panel without one! D/D does not return copies to teams (marked with date of mailing) in time.

Since this step appears necessary, we must do two things. First, we must increase supervision of the xerox process, to insure that it is more speedy, and more accurate than has been the case in the past. Second, we must insure that the delay between xeroxing, return to teams, and further shipping to D/D is reduced to an absolute minimum. This may mean that each team has an admin person who does this and nothing else when the need arises. It also means that frequent checks of the xerox room must be made to collect summaries once ready, or that the xerox room contacts teams when a pile of work to be done has been finished.

Once summaries are received at D/D, they are placed in packets and mailed to the applicant and any attorney involved. I have the suspicion that this portion of the process is the most understaffed for its crisis needs than anything else in the process. If we are trying to push this system into full gear, we are going to have to employ Olstens, or shift internal resources to this problem area. I think that employment of Olstens is the best, if a supervision and work distribution scheme can be worked out by Jay and Gretchen and Poole.

The point of all these comments is to note what we all know. Each time we put pressure on any part of the system, it exposes the structural weaknesses. It is imperative that we modify or mend the system from the time that summaries are proofread, to the time they are returned to the attorneys with the notice that they have been mailed.

LEAVE POLICY



As you all know and have heard many times, the PCB has the unusual and difficult responsibility of completing its assigned goal not later than September 15. This obligation presents us with personal burdens that ordinary government agency work doesn't have. In addition to the inconveniences and discomforts all of you must bear as detailees, I must impose yet another. The September 15 deadline means, quite obviously, that the normal leave practices and plans must defer to our work schedules. We simply can't finish if the staff disappears on leave during June, July and August. Therefore, all leave plans must be approved by your team-leader or PCB supervisor. I have asked the PCB supervisors to ensure that staff leave schedules not jeopardize our production, and they will not approve leave unless work will not suffer.

Attached to this memo is an order which CMB has sent to each agency detailing personnel to the Board. It ensures that no person will suffer any loss of leave or any other inconvenience because of being detailed here. This means at a minimum that if any of you are in the "use or lose" category of leave, you will not lose leave you cannot take.

If you have any difficulty with your home agency on the matter of leave, the appropriate provision of the FPM is Chapter 630, sub-chapter 3-4b, which states: "Annual leave provided by law is a benefit and accrues automatically. However, supervisors have the responsibility to decide when the leave may be taken. This decision will generally be made in the light of the needs of the service rather than solely on the desires of the employee."

You should quote this to your agency, as well as the OMB order. If you have any difficulties, please contact Charlie Mott or Rich Hunt in our Personnel Office for help (254-9787).

There are a few bright spots, to balance the strict leave limitations:

- (1) The PCB has been authorized a generous overtime policy for employees. We will continue to require overtime, and there should be no difficulty in getting your home agencies to approve it. If you have a problem, let Charlie Mott or Rick Hunt know promptly. Obviously, you must have it authorized by your PCB Supervisor.
- (2) Since you are now traveling to work outside your normal routes, you can be reimbursed for parking expenses while you are at the Board. See the OMB memo and our personnel office if you have any questions.
- (3) I personally want to make certain that nobody here is penalized in any way for working at the PCB. If you get any information that you may be jeopardized for a promotion or work assignement or any other job benefit because you are detailed here, please let us know, and we will take every necessary step we can to prevent it.

I want to thank all of you again for the fine job you are doing under these difficult circumstances. I hope you will let us know if there are problems we can solve, or things we can do to make working here more enjoyable.

MEMORANDUM TO AGENCY CONTACTS

Subject: Presidential Clemency Board: Personnel Policy

As you are aware, the detailees from your agency to the Presidential Clemency Board are participating in an intense effort to process clemency applications. The President personally places a high priority on this program and has asked the PCB to complete its work by September 15.

Currently, a high level interagency team led by the Deputy Administrator of the Law Enforcement Administration is reviewing PCB operations with a view to making recommendations to the President on alleviating the workload, administrative and resource problems faced by the PCB.

As a result of interim discussions with the interagency team prior to their final report, I ask your cooperation regarding certain personnel policy questions. Inasmuch as this priority program is only temporary in nature and is staffed by detailees of some 23 agencies, it is important as a matter of equity and productivity that all personnel detailed to the PCB be treated in as nearly a standard a manner as agency policies and regulations permit.

There are three specific personnel topics which I would call to your attention:

- Overtime compensation and compensatory time for detailed personnel.
- 2. Annual leave for detailed personnel.
- 3. Reimbursement for parking expenses.

1. Overtime Compensation and Compensatory Time.

Because of the heavy workload which the PCB staff must complete within the time frame established by the President, there will continue to be requirements for overtime work on the part of many personnel.

We request that the agencies detailing personnel provide overtime pay within available resources and in accordance with the provisions of Federal Personnel Manual Chapter 550 and agency regulations. In cases where agency policy requires the use of compensatory time in lieu of overtime pay for employees at levels above GS-10, we ask that agencies consider adjustments to the time limits within which compensatory time off is to be requested or taken. As indicated in FPM 550, the exigency of service at the PCB is a factor which agencies should consider in this regard.

2. Annual Leave.

Because of the intense workload of the PCB, some detailed employees may have to alter their scheduled annual leave plans. It is possible, of course, that some affected detailees may be able to rearrange their leave plans during the balance of the 1975 leave year once they have returned to their parent agencies, depending on the workload situation, discussions between the employee and the agency and other factors:

The provisions of Federal Personnel Manual Chapter 630 govern annual leave. Particular attention is drawn to FPM Letter 630-22 of January 11, 1974, providing guidance on the provisions of PL 93-181 which, among other things, provides for the suspension of leave forfeiture requirements under certain circumstances. Your agency has also developed policy to implement these provisions. In general, the law permits suspension of forfeiture under these conditions:

- a. To correct an administrative error.
- b. When annual leave was scheduled in advance but its use denied because of the exigencies of the public business.
- c. When the annual leave was scheduled in advance but its use was precluded because of illness or injury.

We request that you give detailees from your agency to the PCB every consideration in this regard should the exigencies of the PCB workload cause the alteration or cancellation of scheduled leave plans.

3. Reimbursement for Parking Expenses.

In some cases, detailees assigned to the PCB have faced disruptions in their normal means of traveling to and from their regular office locations. In certain instances, the parent agency of a detailee has paid for parking expenses. We would request that all agencies providing detailees to the PCB consider those cases in which a burden has been placed on an employee in this regard and provide for appropriate reimbursement in accordance with agency practice. In making such determinations, you may also wish to refer to two decisions of the Comptroller General, 32 Comp.Gen. 235 and 36 Comp.Gen. 795 which are applicable to this situation and indicate that such reimbursements are allowable under certain circumstances.

The PCB staff will continue to maintain information concerning attendance, overtime, etc.; however, the parent agency should maintain the official records concerning each detailee to the Clemency Board. In following up on these recommendations, please contact Ms. Sally Wells 254-9787 at the PCB to arrange whatever procedures are required by your agency.

Subject: Acquisition of Personnel Records for the Clemency

Board

On May 22, 1975, as recommended by PCB staff to the Interagency Survey Team, I forwarded a letter to DoD and GSA suggesting that both agencies give a high priority status, including the assignment of additional personnel, to all requests for military personnel files and court martial records requested by the PCB. I understand that it was taking from 10 to 14 days for PCB to acquire appropriate personnel records.

Attached is a response from Dwight Ink, Deputy Administrator of GSA, concerning this subject. Mr. Ink indicates that all requests from the PCB receive priority treatment by a special staff established within the center's organizational structure to handle such urgent requests and the records center in question has an average response time of three days.

I would appreciate your staff reviewing Mr. Ink's concerns and report to me whether or not this problem is resolved. If it is no longer a problem, or if it was resolved before I forwarded my memorandum, I think we should so indicate to GSA.

I am puzzled by the points in your memorandum of May 22, 1975, most of which differ greatly from my information concerning the General Services Administration and its handling of requests for records for use by the Presidential Clemency Board. Two of our records centers, the National Personnel Records Center in St. Louis, and the Washington National Records Center in Suitland, Maryland, were mentioned in your memorandum.

My investigation of this matter reveals quite a different situation for the one you have outlined. I believe three examples will make clear why I believe you have been provided with erroneous information.

On May 27, 1975, our St. Louis Center received by regular mail, 171 requests from the Board. Eighty of the requests were dated either May 12 or May 13 -- others in the same package were dated as recently as May 23. Our Center has an average response time of three days. It is not possible to respond in three days to a request that isn't made for 10 or 11 days after it is prepared. All requests from the Board receive priority treatment by a special staff established within the Center's organizational structure to handle such urgent requests.

The actual situation at our Washington National Records Center is even more at variance with your letter. Working closely with the personnel of the Board directly involved in its operation, our Center has provided twenty-four hour service. For example, 600 requests were received on Saturday (May 17) -- the records were pulled on Sunday (May 18) and were picked up the same day. Also on May 21, 670 requests were received. These records were ready on May 22 for pickup by the Board. They were not, however, picked up until May 23.



I regret that you have gained such an erroneous impression of our Center operations. As in the past, all future Presidential Clemency Board cases will continue to receive priority service. If there are some specific cases where our policy of according the Presidential Clemency Board priority has failed, I suggest it might be useful for the Board to advise us of the specifics so we can deal with them.
