MRS. SMITH AITEMPTED TO CALL THE WHITE HOUSE TUESDAY BUT WAS TOLD TO WRITE A LETTER REQUESTING A TELEPHONE TALK WITH THE PRESIDENT.

INSTEAD, SHE SENT A TELEGRAM READING, "MR. PRESIDENT: IN REFERENCE TO MY SON, KENNETH SMITH, STILL BEING HELD HOSTAGE BY MARXIST GUERILLAS FOR TWO MONTHS IN AFRICA, REQUEST IMMEDIATE REPLY FOR PHONE CONVERSATION WITH YOU."

"I KNOW THE PRESIDENT IS A BUSY MAN BUT HE COULD CALL A MOTHER WHO CANNOT UNDERSTAND WHY HER SON MIGHT DIE BECAUSE OF POLITICAL PROBLEMS IN A FAR AWAY LAND," SHE TOLD NEWSMEN.

Q: The Zaire Government requested the US Ambassador there,
Dean Hinton, to leave recently following charges of US
involvement in a plot to overthrow the Zaire Government.
The State Department has said the charges are without foundation,
yet Secretary Kissinger has sent a former Ambassador to Zaire
to Kinshasa to consult with President Mobutu. Did you concur in
Secretary Kissinger's decision?

A: We believe the action against Ambassador Hinton was most unfortunate. Secretary Kissinger and I discussed the matter and thought it would be useful to send Ambassador Vance to Kinshasa in an effort to minimize the effects of this unfortunate episode.

We have longstanding good relations with Zaire which we wish to maintain.

- Q: Why the big increase in military aid for Zaire?
- A: We are proposing a \$19 million FMS credit to help Zaire modernize its forces and meet its legitimate defense needs. Our aid will help meet Zaire's needs as recommended by an American Military

 Technical Advisory Team after careful study and consultation in Zaire.
- Q: Are you sure this equipment will not go to Angola?
- A: The equipment financed with this credit is for the Zairian military, and the normal prohibition against transferring any items to a third country without USG approval will apply.
