This is the story on Herb Klein:

When Klein left the White House in 1973, he was kept on as an unpaid consultant, and was part of the Ron Ziegler roles on the following terms:

Not paid any salary Does not get any government credit for his consultation Does get per diem if he is actually employed, and also travel expenses to place where he is going to work for W.H.

In December 1974 Klein expressed interest to Rumsfeld to be kept on in that capacity. Rumsfeld sent a note to Jerry Jones to have the Personnel office implement this. There was no expiration date mentioned. Now Personnel is required to put a limitation on all consultant appointments. In order to get a expiration date on him, they need you to fill out the attached form.

The technicalities of Klein's agreement:

He is has a "letter of service by agreement". This means that he works when he is asked to work - could be called in for a conference, or for travel.

If he were terminated, he would get a letter saying his assignment has been completed.

You can extend Klein for 90 days maximum - after which you could keep extending him for 90 day periods.

I don't see any harm on keeping him on - at least until after the election, since he doesn't cost us anything, and to terminate him would probably cause unnecessary hurt feelings.
