Dear Mr. Chung:

Thank you for your note. I too enjoyed our brief chat at the party.

One thing puzzles me about your letter, and I am writing you back to correct any misunderstandings you might have. I don't recall the "exchange of information" which you refer to in your letter. We did have a pleasant conversation, but I don't recall saying anything that could be interpreted as "beneficial" to our countries, or that would "further enhance mutual cooperation."

I am making this point because obviously American foreign policy is the responsibility of the State Department and ultimately the President. I don't want you to think that anything said by me in our brief chat in my capacity as Press Secretary represented in any way an authoritative or official comment on relations between our two countries.

I am sure you understand the distinction I am making.

Dear Ron:

You were a gracious host on a busy evening and I am grateful for your thoughtfulness and time. I am impressed with the way you had things in hand for the affair that night; where in this business did you learn to be organized?

I mentioned to you the discussion I had with Helmut Schmidt and his expression that a four-way satellite "conversation" between President Ford, President Giscard d'Estaing, Prime Minister Wilson and the Chancellor himself would have great appeal in Europe and could represent a significant breakthrough in relations between the two sides of the Atlantic. It intrigues me, and the purpose of this letter is formally to ask if President Ford would be agreeable in principle.

Specifically, I am proposing that the one-hour program be a joint production of WNET/13, for whom I produce my weekly series devoted to international affairs, and NPACT in Washington; that it originate from the four capitals; that it be offered to networks around the world (my interview with Secretary Kissinger was used wholly or in part throughout Europe, Canada, Australia, Japan, and the Middle East, and this discussion between these four men would, of course, have even greater interest); and that it be conducted live early in March, if possible.

We can discuss the format, if there is agreement in principle. My tentative thinking is for me to put several questions to the men having to do with common problems, to stimulate discussion



Dear friend, I ask you to make it possible to present, simply for their information, the following text of my "open letter to his excellency the president of the USA" to President Gerald Ford himself and to the distinguished senators and representatives who are members of the US. Congress.

<sup>the</sup> Undersigned Norodom Sihanouk, president of the United National Front of Cambodia of which the government GRUNC controls and administers at this moment 80 percent of the territory of Cambodia and is recognized ~~de jure~~ ~~de facto~~ by 62 states and sovereign government ~~in~~ in the world, have the honor to address you with what follows.

Mr. President, you should be thoroughly convinced that the FUNC is in no way frightened by the prospect that you will be able to obtain from Congress the sum of \$220-million to aid the Phnom Penh Quisling group or rather the ~~U.S.~~ U.S. neo-colonialism established in a ~~10~~ tenth of Cambodia to survive for a few more months.

You yourself, Mr. President, have just ~~publicly~~ stated publicly that without massive new aid from the U.S., the so-called "Khmer Republic" will inevitably disappear in a few weeks. It is then without any complexity and without the slightest doubt about the ultimate victory of our struggle for national liberation, that I courteously request your excellency and the U.S.A. government to re-examine the ~~U.S.~~ "Cambodian problem."

Mr. President, you know perfectly well what has befallen my little Cambodian country after five years of intense ~~war~~ warfare. About a million ~~Khmers~~ Khmers out of seven ~~million~~ million are dead or have become invalids. Three and a half million Khmers out of the six million remaining uninjured are totally ruined, that is to say without homes, without rice paddies or fields, without cattle, without anything else.

This is the result of five years of "aid" from the USA, which has spent, to reach this result, more than seven billion ~~million~~ dollars belonging to the American people.

Placing confidence in your number one collaborator, Mr. Henry Kissinger, your excellency asserts that if the U.S. Congress extends once again to the group of Phnom Penh Quislings several hundreds of millions of dollars, the FUNC and the GRUNC will be led to accept "a compromise".

Mr. President, in ~~my~~ taking such a ~~position~~ position before your parliament and your people, are you sincerely expressing your personal conviction or are you ~~using~~ using Mr. Kissinger's duplicity ~~or~~ ~~duplicité~~ or duplicity?

... the GRUNC the PAPINC and I myself struggle

and will never lie to you and we swear on our honor that we will never accept a compromise of any kind with the Phnom Penh traitors, ~~or with your~~ neo-colonialism.

We do not fight in order to get ministerial ~~seats~~ seats or ~~portfolios~~ portfolios in Phnom Penh nor in order to ~~serve~~ serve the interests of this or that communist power. We are fighting to reconquer national independence, ~~national territorial integrity,~~ national territorial integrity, national unity--in a word national ~~sovereignty,~~ sovereignty.

Our sovereignty is neither ~~capable~~ capable of being shared with the traitors and their foreign masters nor negotiable with them.

You are not sincere, Mr. President, when you ~~assert~~ assert that the USA helps the Lon Nol group defend the national ~~independence~~ independence of Cambodia. The entire world knows that in ~~Phnom Penh~~ Phnom Penh the real "head of state" of the "Kmer Republic" is your ~~ambassador~~ ambassador Mr. John Gunther Dean and not Lon Nol, ~~whose~~ whose position in relation to you resembles that of a dog, with ~~one~~ the difference, that your dog



~~is~~ loves you sincerely and does not steal American contributions, while Lon Nol and his entire clique in Phnom Penh are only to the U.S.A. like vile courtesans and incorrigible thieves.

A very recent cable by UPI from Phnom Penh reveals in this connection that "corruption on a massive scale continues. A former senior government official now out of power estimated that sixty per cent of the 452 million US dollars in American aid is ~~not~~ ripped off and pocketed by corrupt officers and officials."

*not parallel*

You do not cease, Mr. President, to "commiserate" ~~with~~ with the miserable Lon Nol supporters.

~~Yet~~ all the inquiries undertaken by the great American press conclude that the Lon Nol group lacks neither ~~gasoline~~ gasoline which they sell in industrial quantities on the black market, nor rice which flows as contraband to Vietnam and Thailand nor arms and ~~ammunition~~ ammunition which they surrender ~~and~~ and in various ways to our FUEC and to our FALPEC. And you cannot any longer be without knowledge Mr. President of what the students think of "the republicans" of Phnom Penh, of their "independent republic," and of your generous help accorded to Lon Nol supposedly for the defense of "national independence of Cambodia and Cambodian liberty."

The Washington Post in its February 22, 1975 issue, has taken note of the most characteristic words of the students of Phnom Penh. On this subject, James Fenton wrote, "here are two main areas of controversy. The first is the students' claim that through ~~sex~~ corrupt and incompetence the Lon Nol government is responsible for destruction



of American aid. "The students spoke of U.S. aid with undisguised contempt. "We don't want the aid of any poisonous country," they said at one point. "We want to live independently." "Any country that wants to give us aid," said the students, ~~we~~ "we will welcome openly. But any country that gives aid in order to subjugate us we don't want." "Now we have a lot of U.S. aid but the results are bad. Any country that gives a lot of aid does so with an ulterior motive. If the results are bad then both the giver and the receiver must take responsibility." "If the results of the aid are bad," said a student, "then the donor will be punished, destroyed by the Khmer people."

~~Then~~ Mr. President, is what the Khmer youths of Phnom Penh, although of "the right," think of the assistance from the U.S.

Is it believable,

~~in the face of that,~~ in the face of that, that you still have the audacity Mr. President, to ~~insist,~~ insist, with much handwringing, that the U.S. Congress should have pity on people who do not want your poison?

Mr. President, I don't wish to meddle in the affairs of the U.S. but I cannot avoid posing certain questions. Your excellency without doubt wants to ~~resemble~~ resemble the Buddha ~~when~~ when you express your compassion for "a little people who have placed their confidence in the U.S.A." If you are really compassionate like the Buddha why, Mr. President, have you pity for the multimillionaire Lon Nol backers in Phnom Penh more than for your colored countrymen, for example the red skins penned into reservations like animals, the blacks, the Puerto Ricans ~~and~~ others in their ghettos?

Even if you want to be more Asian than the Asians, you could, Mr. President, interest yourself in Bangladesh and other countries where each week thousands and thousands ~~of~~ of people die without food, without medicine despite the laudable efforts of their governments, rather than dispensing billions and billions of ~~your~~ your people's dollars to destroy, ~~more~~ more completely each day, my little ~~country,~~ country, mutilating, starving, assassinating a little more each day my little people.

Imagine, Mr. President, what eight billion dollars could produce in cultural or social terms in our own country or those third world countries other than Cambodia. Cambodia was an exporter of rice, of corn, of meat, of fruit. It never had to beg. In the field of public education, it was one of the most ~~advanced~~ advanced in the third world. It was one of the ~~paradises~~ paradises on earth before the armed U.S. invasion. Between 1953 and 1969, it lived happily and fully independent and developed itself slowly but surely. All of that has been renounced since 1969 by the aid from the U.S. The return of your aid has been enough to make Cambodia the most backward country in the world and its population the most miserable and the most mutilated in the world.



What is the real problem that your conscience, Mr. President, and the conscience of the entire American nation has the duty to address it to today.

It is not for me to decide. You are free to decide. But if you decide to prolong or increase your aid to the ~~Phnom Penh~~ Phnom Penh Quisling group, you should understand that you will only delay a few months or one year ~~the~~ the inevitable date when things come due.

The Cambodian people, the FUNC, the GRUNC and the FAPLNC will win. We ~~swear~~ swear it to you.

In conclusion, permit me to reaffirm ~~me~~ once again to your excellency as well as to the Congress and the people of the U.S.A. that the FUNC, the GRUNC, ~~the~~ the FAPLNC and I do not consider ourselves as your enemies. It is Mr. Kissinger and Mr. ~~Schlesinger~~ Schlesinger who unjustly consider us ~~to~~ to be the enemies of the U.S.A. and of the U.S. empire, "enemies" who must be eliminated at all cost. These two ~~men~~ men pay us the very great honor of considering us the ~~leaders~~ leaders of the entire anti-imperialist revolution in Southeast Asia and in the rest of the world.

We assure you that we will not export our revolution to anyone and, on the other hand, we will remain fervent adherents of non-alignment and of the five principles of peaceful co-existence.

True to those principles, we propose to the U.S.A. a rapid reconciliation to re-establish ~~peace~~ peace and ~~friendship~~ friendship between us. To achieve this ~~noble~~ noble objective, we propose no conditions. We demand of you only that you put an end to all your interference in the affairs of ~~Cambodia~~ Cambodia and leave ~~it~~ it to the Cambodians to ~~handle~~ handle these affairs. That conforms to the spirit of the United Nations charter and to the rules of peaceful co-existence.

Accept the assurances, Mr. President, of my high respect.  
chief of the Kingdom of  
Norodom Sihanouk, ~~King of Cambodia~~ Cambodia, and president of the Cambodian National Unity Front.

SIHANOUK, A LONG-TIME ACQUAINTANCE OF MANSFIELD'S, ASSERTED THAT NO AMOUNT OF FUNDS WHICH CONGRESS MIGHT APPROPRIATE UNDER THE PRODDING OF PRESIDENT FORD COULD STAVE OFF THE INSURGENT TAKEOVER OF ALL CAMBODIA.

SIHANOUK HAS RESIDED IN PEKING SINCE HE WAS OVERTHROWN BY NOL IN MARCH, 1970. EXPERTS IN WASHINGTON BELIEVE THE CAMBODIAN INSURGENTS ARE GREATLY ENCOURAGED BY THEIR CURRENT MILITARY SUCCESSES.

SIHANOUK ASSERTED THE UNITED STATES HAS TURNED DOWN "PROPOSALS FOR PEACE" OFFERED BY THE CAMBODIAN REBELS. HE SAID THESE PROPOSALS WERE:

-- THE UNITED STATES MUST END ITS "INTERFERENCE" IN CAMBODIA AND SUPPORT FOR NOL.

-- THE CAMBODIAN REBEL GROUPS SHOULD ESTABLISH DIPLOMATIC RELATIONS WITH THE UNITED STATES.

-- OFFICIALS OF THE CURRENT REGIME MAY ESCAPE RETRIBUTION BY GOING INTO EXILE, AND PRESIDENT NOL MAY BE PARDONED OR GRANTED AMNESTY IF HE AGREES TO JOIN THE INSURGENT REGIME.

Attached find a copy of a letter proposed by the Customs Service to be sent to all members of the press who made the Vladivostok trip. As you see, the Customs Service requests the journalists to return the whalebone souvenirs they were given by the Russians because they violate the Marine Mammal Protection Act and the Endangered Species Act. The Customs Service raises the possibility of legal action if the whalebone is not returned.

Also attached is a draft re-write of the Customs Office proposal, written by my office, which somewhat softens the tone of the letter.

I would appreciate your guidance on 1) Would the Customs Service's position be considered an insult by the Soviet Union, who presented the whalebone to the reporters, and 2) Is it absolutely necessary, from a legal point of view, that the reporters be forced to return these souvenirs?

It seems to me the best option would be to find a way to let the reporters keep the gifts. The second best option would be to find a way to ask the reporters to return the gifts in a tone that would not bring complaints of harassment and stories about this episode.

May I have your advice on this?

Enclosed is a picture of this souvenir to help you identify what we are talking about. The back or base of the plaque is a product of the Finback Whale called Baleen, a fibrous material found in the mouth of the whale used for filtering plankton, (upon which the whale feeds) from the sea water.

If you have a plaque, it should be turned in to the nearest office of either the U.S. Customs Service or the National Marine Fisheries Service. There will be no legal action taken against anyone who voluntarily turns in his or her whalebone plaque.

Please give this letter (or a copy) to the local Customs or Marine Fisheries office when you turn in the plaque.

It has come to our attention that some members of the press who accompanied President Ford to Vladivostok, Russia in November 1974, returned from the trip with a souvenir which violates the Marine Mammal Protection Act of 1972 and The Endangered Species Act of 1973.

Enclosed is a picture of this souvenir to help you identify what we are talking about. The back or base of the plaque is a product of the Finback Whale called Baleen, a fibrous material found in the mouth of the whale used for filtering plankton, (upon which the whale feeds) from the sea water.

All whaling countries of the world except Japan and Russia have agreed upon a moratorium on the taking of the whale. We feel that there is a possibility that the importation of this plaque could cause an embarrassment to you, the President and the United States, should it become a public issue.

Therefore, it is imperative that you voluntarily give this plaque to the nearest office of either the U.S. Customs Service or the National Marine Fisheries Service. The plaques will then be turned over to the Smithsonian Institution in Washington, D.C.

If you make this voluntary donation, we are able to assure you of no legal repercussions as per proposed Title 50, Code of Federal Regulations, Part 219.

Please give this letter (or a copy) to the local Customs or Marine Fisheries office when you turn in the plaque.
