These proposed budget amendments would provide for the payment of compensation, pensions, and related benefits to eligible veterans and their beneficiaries, and education and training assistance benefits to veterans of post-Korean military service and eligible dependents of deceased and disabled veterans. Increased field office staffing is also provided. The number of veterans now estimated to utilize these benefit programs is significantly larger than those which were forecast in the 1976 budget.

The cost of these benefits is beyond administrative control and cannot be absorbed within available appropriations. The present staffing level is not sufficient to process the increased workload in a timely manner.
