THE WHITE HOUSE

The President today announced his intention to nominate eighteen persons to be members of the Board of Directors of the National Institute of Building Sciences for the terms indicated commencing on the date of incorporation. They are:

The initial appointees shall serve staggered terms as indicated above. Thereafter, they shall serve terms of three years with no member being eligible to serve in excess of three consecutive terms of three years each.

The Institute was established by Title VIII of the Housing and Community Development Act of 1974 (Public Law 93-383 of August 22, 1974) and is to consist of not less than 15 and not more than 21 members appointed by the President.

The purpose of the Institute is to develop and encourage the adoption of performance criteria for building components.
