I am transmitting to the Congress, for the legislative branch, fiscal year 1976 and transition quarter supplemental appropriations and amendments to 1977 appropriations requested in the 1977 budget. Budget authority requests total \$1,400,000 for fiscal year 1976, \$250,000 for the transition quarter, and \$4,504,000 for fiscal year 1977.
