Edith M. McKee, of Winnetka, Illinois, geologist consultant. She succeeds Robert A. Charpie who has resigned.

For the term expiring October 18, 1978.

Werner A. Baum, of Milwaukee, Wisconsin, Chancellor of the University of Wisconsin-Milwaukee, Madison, Wisconsin. He succeeds Arthur Godfrey whose term has expired.

Earnest Hubert Clark, Jr., of Downey, California, President and Executive Officer, Baker International, Orange, California. He succeeds Winona Vernberg whose term has expired.

A. Richard Kassander, Jr., of Tucson, Arizona, Vice President for Research, University of Arizona, Tucson, Arizona. He succeeds Charles Hosler, Jr., whose term has expired.

Leonard J. Langfelder, of Cary, North Carolina, Professor of Civil Engineering and Director of Center for Marine and Coastal Studies, North Carolina State University, Raleigh, North Carolina. He succeeds Perkins Bass whose term has expired.

John A. McWilliam, of Toledo, Ohio, General Manager and Chief Executive Officer, Toledo-Lucas County Port Authority. He succeeds Clement Tillion whose term has expired.

Oliver L. Peacock, Jr., of Ft. Pierce, Florida, President and General Manager, Peacock Fruit and Cattle Corporation and Director, Florida Wildlife Federation. He succeeds Donald B. Rice, Jr., whose term has expired.

Jim Rearden, of Homer, Alaska, Outdoors Editor of Alaska Magazine. He succeeds Elmer P. Wheaton whose term has expired.

Kenneth C. Spengler, of Arlington, Massachusetts, Executive Director American Meteorological Society, Boston, Massachusetts. He will succeed Arthur E. Maxwell whose term has expired.

Warren S. Wooster, of Key Biscayne, Florida, Professor of Marine Studies and Fisheries, Institute for Marine Studies, University of Washington, Seattle, Washington. He will succeed John W. Luhring, whose term has expired.

The Committee consists of 25 members appointed by the President for terms of three years.

The Committee was established by Public Law 92-125 of August 16, 1971, to undertake a continuing review of the progress of the marine and atmospheric science and service programs of the U.S. and advise the Secretary of Commerce with respect to the carrying out of the purposes of the National Oceanic and Atmospheric Administration, Department of Commerce.
