FOR CHARGE

1. THERE WILL BE A PUBLIC ANNOUNCEMENT ON OCTOBER 6 AT NOON, WASHINGTON TIME, THAT THE SECRETARY WILL VISIT PEKING OCTOBER 19 THROUGH 23. THE TRIP WILL BE PREPARATORY TO THE PRESIDENT'S VISIT LATER THIS YEAR. THE SECRETARY INFORMED MIYAZAWA OF THESE DATES DURING THEIR BREAKFAST MEETING ON SEPTEMBER 27, AND ALSO MENTIONED THAT HE INTENDED TO STOP IN JAPAN BOTH ON THE WAY IN AND OUT FROM CHINA.

SUBJECT: ANNOUNCEMENT OF SECRETARY'S TRAVEL TO PEKING  
FOR SHOESMITH FROM HABIB

1. IN RESPONSE TO QUERY FROM JAPANESE EMBASSY WE HAVE TOLD THEM THAT WHEN THE ANNOUNCEMENT OF THE SECRETARY'S TRIP TO PEKING IS MADE ON OCTOBER 6, WE WANT TO BE IN POSITION TO STATE THAT THE SECRETARY WILL STOP IN JAPAN ON THE WAY IN AND ON THE WAY BACK FROM PEKING. WE WILL ALSO MENTION HIS MEETING WITH SENIOR JAPANESE OFFICIALS. WE HAVE ASKED THE JAPANESE TO LET US KNOW PROMPTLY IF THERE IS ANY PROBLEM WITH ANNOUNCING THIS AS PROPOSED.

2. FOR PLANNING PURPOSES, THE SECRETARY INTENDS TO STOP OVER IN JAPAN THE NIGHT OF OCTOBER 18 DEPARTING FOR PEKING THE NEXT DAY AND RETURNING BY WAY OF JAPAN SPENDING TWO NIGHTS, OCTOBER 23 AND 24, IN TOKYO. HE PROPOSES TO MEET WITH MIYAZAWA MORNING OF OCTOBER 19 (AS AGREED WHEN

1. PERSONNEL: EXECUTIVE SECRETARIAT TEAM OF FSU RONALD E. WOODS AND SECRETARY KARLA GEBERT WILL ARRIVE ABOARD THE SECRETARY'S AIRCRAFT. AN S/S ADVANCE TEAM WILL PRECEDE THE SECRETARY'S ARRIVAL. NAMES AND ARRIVAL TIME WILL BE CABLED LATER.

2. ADVANCE TEAM: THE ADVANCE TEAM FUNCTION IS TO ENSURE THAT ALL REQUIREMENTS FOR THE SECRETARY'S VISIT ARE BEING MET. STARTING WITH THE ADVANCE TEAM'S ARRIVAL S/S

### 3. SCHEDULING:

BECOME AVAILABLE.

B. THE FOLLOWING INFORMATION IS PARTICULARLY USEFUL,  
THOUGH POST SHOULD BE PATIENT IN OBTAINING IT:

1. TIME AND LOCATION OF PROPOSED MEETINGS AND OTHER  
EVENTS, INCLUDING SUGGESTED PARTICIPANTS ON BOTH SIDES.

2. ANTICIPATED PRESS ARRANGEMENTS AND COVERAGE FOR ALL  
EVENTS, INCLUDING ARRIVAL AND DEPARTURE PLANS.

C. APPROXIMATELY 36 HOURS BEFORE SECRETARY'S ETA, POST  
SHOULD RECAP ALL SCHEDULING INFORMATION BY IMMEDIATE  
CABLE TO THE SECRETARY'S PARTY.

### 4. MISCELLANEOUS ARRANGEMENTS:

A. PLEASE FURNISH DRAFT THANK-YOU NOTES FROM THE SECRE-
