SUBJECT: WEEKLY REPORT #42 - WEEK ENDING MAY 15, 1976

State Campaign Organizations

Alaska Delegate count is now at: Ford-18; Reagan-1. Reagan forces playing hardball and are out to disrupt convention.

Arizona All activities shut down.

Colorado The President has a slight edge in county convention delegates overall and this should continue at the State Convention. The Reagan organization is playing hardball in challenging delegations, etc., while annoying some of the Party people. A field force headed by Dick Mastrangelo has been formed.

Connecticut The PFC Chairman Bruno is confident of nearly all, if not all, 35 delegates. There is still no Reagan organization, but action is brewing. Delegate contact is progressing well. GOP Chairman Beeble is hedging in his support. The delegate Bar-b-q in June/July requests Rogers Morton.

Hawaii Ford-18, Reagan-1 in uncommitted delegation.

Idaho The PFC Organization is strong, but after the Texas victory, Reagan is expected to win the primary. The Idaho Statesman poll has Ford-32%, Reagan-68%. The headquarters has been switched to Moscow from Boise. A PFC mailing is planned to large GOP precincts.

Massachusetts John Sears announced May 15 as PFC Chairman.

Montana A PFC executive committee has been formed. A mailing is planned to convention delegates. There is little Reagan activity.

Nevada The PFC organization looks good. The youth effort is very active. The two phone centers (Reno and Las Vegas) show: Ford-39%, Reagan-20%, Undecided-40%. Reagan is in the state the same day as the President.

New Jersey Everything points to delegates running uncommitted.

New Mexico The results of the county conventions give Ford 286 delegates, Reagan 488 delegates, with 29 uncommitted. Believe that certain concessions for national delegates will be made depending on national delegate totals at convention time. Domenici, Lujan, Francine Neff, Bob Davidson, Francis Shipman may be acceptable.

Ohio GOP county organizations are planning PFC mailings with our brochures. The Ohio PFC is responsible for phone banks in Canton, Columbus, Cincinnati, Dayton and has home phoning in other areas. The PFC has a radio actuality system borrowed from the Ohio GOP. An advocate schedule has been undertaken by former Governor John Brown. The possibility of setting up a group of challengers (poll watchers) for Democratic cross-over voters in key Wallace areas (especially in Cleveland) has been discussed. With only a \$50,000 budget, mailings to undecideds or an increase in the phoning operation will not be possible. Holt will have a better idea on this by next week.

Oregon The PFC organization is excellent. The Voter ID operation is moving well. Mailings are going out. Volunteer operations are okay, but there is concern about getting out the vote. The Advocate program needs attention. Estimated delegate count is: Ford-17, Reagan-13. Reagan will be in the state May 23 and 24.

Rhode Island Telephone bank lists are completed with a 3-shift schedule all day and evening.

Texas Milburn and Wallace are prioritizing bills. Headquarters closing is being finalized.

Utah Mass meetings begin on May 17th. Zapanta has two staff persons working with the Utah PFC. They key to victory is getting people to the mass meetings, because they endorse only.

Vermont 16 out of 18 delegates are for Ford at the State Convention, barring a Michigan loss.

Virginia District coordinators estimate State Convention delegates at 1241 for Reagan (62%) and 779 for Ford (38%). They estimate 15 Ford delegates will go to Kansas City.

Washington Work is being done to salvage the convention, but there is little hope of successfully challenging slate. The President has 6 to 9 out of the 38 delegates.

Wyoming State Convention results: Ford-6, Reagan-9, 2-uncommitted. Hathaway feels some Reagan delegates are not firm and he will continue to work on them.

Campaign '76

The past week included completion of a new :60 television commercial, "Economic Recovery." This execution features the President discussing the accomplishments of his Administration. Local advocate radio commercials were produced, but will not be scheduled, in Kentucky (Congressman Tim Lee Carter), Tennessee (Congressman Jimmy Quillen and Senator Baker) and Oregon (Vice-President Rockefeller). Five dialogue radio commercials were produced for use in all upcoming primaries. These commercials are currently running in Michigan.

Press

Thirty-seven actualities were prepared and fed to radio stations in Tennessee, Michigan, California, Ohio, Maryland, Nebraska, and West Virginia. There were 487 actual feeds. Individuals fed through the system included The President, Senator Griffin, Congressman VanderJagt, Governor Milliken, Rogers C. B. Morton, Bill Seidman, Secretary Richardson, Senator Curtis, and Secretary Butz.

Special Voter Groups - Ethnic

Thirty-five ethnic leaders, representing Asian, European, Slavic and Hispanic groups, met with Rog and key staffers for an entire afternoon before a White House meeting with the President. They discussed the importance of the meeting as a first step. Only major gripe was Henry Kissinger. They expressed the belief that Ford should tell Kissinger what to do rather than the other way around. Pluses from the meeting included stories in most ethnic papers about the meeting, wires from Ed Derwinski to all ethnic leaders in Michigan urging strong support, many volunteers in Michigan to man phone banks and pledges of support from all. Several have been signed up to to near full-time work for the Committee.

Special Voter Groups - Older Americans

Jim Mills, head of the Older Americans effort, has thorough volunteer recruitment field operations underway in California and is assisting in the development of Presidential drop-bys and/or a major event to take place before the June 8 primary. The appointment of Older American leadership in Ohio is still pending; field coordinator Walter Parker will train when appointment is made. Mills continues to monitor other pending primary and post-primary states in the area of Older Americans volunteer recruitment and brochure distribution and the activities of the sixteen Older Americans chairmen and/or coordinators.

Special Voter Groups - Youth

The President Ford Committee now has twenty-nine states with youth chairmen or co-chairmen. The latest additions are Arkansas, Connecticut, Oregon, Rhode Island, Utah and Wyoming. Plans are underway for bringing 800 to 1,200 young people to Kansas City to work on the President's behalf. The young people will pay their own travel expenses, as well as living costs, while working at the convention.

Treasurer's Report

A total of \$278,480.11 was received in contributions this past week, bringing to \$9,522,234.09 the amount of money received to date. There is currently a balance of \$167,659.13 on hand. A full Treasurer's Report is attached at TAB B.

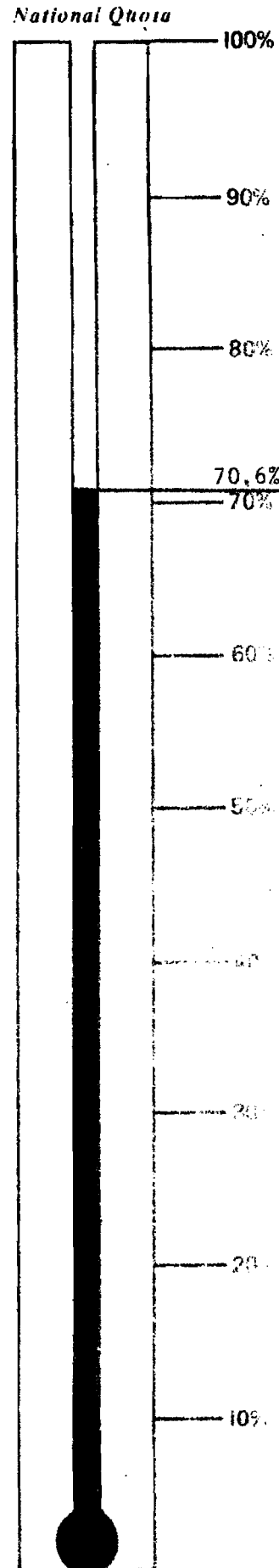
