You asked about the current status of legislation relative to Presidential succession. The Subcommittee on Constitutional Revision of the Senate Committee on the Judiciary has been handling this matter. It recently had two sets of hearings and hopes to close out this aspect of its work on Thursday of this week. At that time among others to testify will be our good friend Dick Nixon.

Following the completion of the hearings the subcommittee will attempt to draft specific legislation a resolution to be submitted to the Senate. Whether any further action will be taken this session we cannot predict, but the subcommittee is working on the problem.

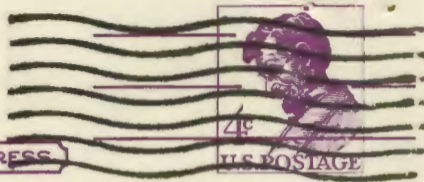
