# **ECONOMICS AND LABOR STAFF FILES**

The Economics and Labor staff was responsible for identifying, recruiting, evaluating, and proposing Presidential appointment candidates for such institutions as Labor, Treasury, and Commerce departments, as well as the Federal Trade Commission (FTC) and the Wage and Price Stability Board.
