ADVISERS REPORTEDLY OPPOSED Ford Building Pool at White House

WASHINGTON (UPI)—Construction started Wednesday on an outdoor White House swimming pool, which President Ford reportedly ordered over the ppposition of his advisers.

The heated pool, measuring roughly 20 by 50 feet, is being built at the edge of the south lawn on a knoll near the Oval Office. It is being paid for with contributions.

Informed sources said Mr. Ford's aides tried to talk him out of the pool. The aides saw it as controversial at a time when Mr. Ford is calling for a tight rein on spending.

Press Secretary Ron Nessen said the pool would cost \$52,417 and an additional \$9,000 would be spent for landscaping. No federal money would be involved.

So far, Nessen said, about \$10,000,

or one-sixth of the total, has been collected by a committee headed by A.J. Seahorn of Hayward, Calif., the vice chairman of the U.S. Olympic Swimming Committee.

Mr. Ford "has laid down very strict guidelines," limiting individual contributions to \$1,000 in cash or \$1,000 worth of services, and no unions will be able to offer assistance, Nessen said.

He said the pool would not be "elaborate" or "posh" but might be "a shade larger" than many backyard pools.

Before moving to the White House last year, Ford, 61, liked to take a dip in the early morning hours and after work at night at his home in Alexandria, Va.

The indoor White House swimming

pool, which was built for Franklin D. Roosevelt with pennies contributed by school children, was covered over to make room for the new press center during the Nixon administration.
