I understand that Tom Andre is currently shipping roses through you for complimentary presentation on behalf of Roses, Inc. to Rusty Young at the White House.

It is Roses, Inc.'s intentions to supply a box of roses on a complimentary basis to the White House through the balance of this year, and through next year becoming a permanent arrangement, hopefully.

As projections go at the moment, however, this would at least be an arrangement that we would extend to the White House for the balance of this year and next.

In order to facilitate this arrangement, we need a local wholesaler in the Washington area who can see that the roses are delivered to Rusty for his use.

I gather from talking with Tom Andre that he may have previously discussed this with you and that you are willing to be designated as the wholesaler contact to service this arrangement.

I want to confirm that this arrangement has been established. I will let the growers know that plan to ship roses so they can plan their schedules accordingly.


