





WASHINGTON—Last August, Travis Reed left behind his sumptuous homes in Los Angeles and Sun Valley and set out for Washington. His goal: to see if the Horatio Alger magic that had brought him sparkling success and a six-figure income as a California entrepreneur might win him similar triumphs in the world of government.

Part of Reed's motivation strategy called for a cocktail party aboard the presidential yacht Sequoia. But the rules do not permit spending federal money on cocktails for government employes. So Reed dug into his own

leagues thought a taxi or personal car might have served as well, but Reed says he was not putting on airs. He could not be sure of getting a taxi when he needed it, and as for driving his own car, he said, "I didn't even know where the British Embassy was, let alone where to park."

In all, Reed estimates, he spent up to \$10,000 of his own money for things he believed necessary, to his job, but which regulations did not make available.



Nebraska and specifically Eugene seem very receptive to a visit from Mrs. Ford. The President will be visiting Portland and thus it seems it would be most helpful for Mrs. Ford to visit Lane County, Eugene. Eugene is a major media center for that part of the state and Lane is the second largest county. The Lane County Chairman is a woman, Margaret Potoine, who is dubbed by the Nebraska PFC Chairman as "a doer, a cultured Bella Abzug." She is 52 years old and has three children.

Craig Berkman, the state chairman, seems to have a good feel for the state, and I gathered it is a good organization. He is very supportive of Margaret Potoine. Financially the state has exceeded its designated proportion.



EUGENE: -Home of University of Oregon, 25,000 students. New, modern student center; new president is from Central Michigan University, Dr. William Boyd; former president was Arthur Fleming. Great basketball town; very athletically oriented; well-known to all are Ronnie Low and Dave Wilcox.

-Lane County Community College is a new campus, I gathered about 10 minutes from center of town. They are having their Bicentennial Essay Contest Award ceremony. Margaret Potoine did not know who was participating in this, children, college community or total community. Might want to have winning essay read at some function BF attends; it did not sound to me like something she would want to attend unless children are involved.

-Ripon Society (liberal Republican group) meets on Friday.

-Many active women groups in Eugene: League of Women Voters, Junior League, AAUW, Women's Political Caucus. Mrs. Potoine sounds very knowledgeable and would love to have a group of them go together and sponsor something for Mrs. Ford.

-Shopping Centers. Apparently downtown area has a nice mall which includes modern city council building and city hall. A shopping center a bit to the north of town is another possibility.

-Chamber of Commerce does not have anything special going on that day per Mrs. Potoine.

-Timber is a big industry in this area. Much trout fishing in the streams.


-Mountains can be seen from Eugene on a clear day.

-Edith Green. Retired, much respected Congresswoman; many times re-elected from generally democratic district; friend of the Fords; lives in Portland.

-Mrs. Elizabeth (Walter) Norblad; Susan's godmother; Salem area.

-Mrs. Marcus Newberger; first woman Senator; filled out her husband's term upon his death some years ago; friend of the Fords; lives in Portland.

-Mrs. Nellie Fox; a democrat, but very independent minded; very active in labor movement, AFL/CIO; Berkman thinks great opportunity for BF to make inroads into labor movement; lives in Eugene.

LABOR: -Good teamster union described as "largest single teamster local in the country" and is headed by L.B. Day of Eugene, a Republican who is also chairman of the Land Commission. It sounds to me as though both Day and Fox should be invited to somehow participate in Mrs. Ford's visit or to meet her. Labor very independent politically in Eugene in its support.

SUGGESTED ACTIVITIES (Some suggested by Margaret Potoine; some by me):

-Walk through downtown mall in area of city hall.

-CB conversation if driving anywhere.

-Informal luncheon with women's page editors, maybe at University of Oregon


-Lane Community College Bicentennial Awards ceremony

## **HERE IS A SECTION BY SECTION ANALYSIS OF WHAT IS IN THE MEASURE.**

### **SECTION 1. This is the definition section of the measure.**

Paragraph (2) says that five unrelated individuals may form a corporation for farming and other purposes so long as 20% of the gross receipts of the corporation do not come from rent, royalties, dividends, interest and annuities.

Paragraph (3) defines farming very broadly but excludes the timber industry and certain services provided to farmers.

Paragraph (4) allows individuals to continue farming.

Paragraph (5) provides that a family farm may incorporate and become as large as it wishes so long as the family remains in control of the business.

### **SECTION 2. This section prohibits every other corporation from farming with certain exceptions.**

Paragraph (1) protects farm financing by allowing mortgages.

Paragraph (3) allows corporations to farm for purposes of research or experimentation.

Paragraph (4) specifically allows corporations to farm not more than 160 acres of breeding stock, seed, nursery plants or sod.

Paragraph (5) says that churches may not acquire more farmland but their present holdings are not affected.

Paragraph (6) says that a corporation may acquire farmland for non farm purposes but may only farm it through leasing it to individuals, a family farm corporation or a corporation with no more than 5 individual shareholders.

Paragraph (7) protects farm financing by allowing a corporate money lender to foreclose on a defaulting farmer and hold the land for 10 years before having to resell it so long as any farming is done under lease to individuals, a family farm corporation or a corporation with no more than 5 individual shareholders.

### **SECTION 3. This section instructs the legislature to require corporate farmers to provide information needed for enforcement of the measure.**

**SECTION 4. This is the enforcement provision. Prohibited corporations in existence on the date of the passage of the measure have 10 years to sell their holdings. Prohibited corporations that start farming after the law goes into effect can be required to sell their land immediately.**

## Oregon Political Background

Although both of Oregon's Senators are Republican (Packwood and Hatfield) the four-man House delegation and the Governor are all Democrats. John Dellenback was one of the surprise GOP losers in 1974. His former district, the 4th, is in the Southwest corner of Oregon, where Eugene is located. This district contains about half of Oregon's rocky Pacific coastline, and most of Oregon's fruit crop is produced in this district. The incumbent is Democrat James Weaver, who is like Dellenback considered a liberal.

Oregon's economy depends primarily on lumber. The state did not experience the post-war boom of California and Washington State, principally because it did not have the major defense industries.


Oregon has had political impact in presidential politics because its primary comes shortly before the important California primary. (Remember McCarthy's 1968 victory over Bobby Kennedy and Rockefeller in 1964.) The state also has pioneered in progressive legislation. This is the state where marijuana was decriminalized and where throwaway bottles and cans were outlawed.

Former Governor Tom McCall (R) urged people to visit Oregon, but not to stay. Despite publicized campaigns encouraging people not to move to Oregon, the state has experienced considerable population growth in the last 15 years.

Some other important political figures from Oregon are Rep. Al Ullman, the late Senator Wayne Morse and former Rep. Edith Green.

The environment protection debate in Oregon is an important one, involving both the lumber industry and those opposed to continued growth.

One of the big Oregon jokes is about the rain. Certain areas of the state, including Portland, like to tell stories about the one day a year the sun shines.






Illustration of the east tower of Deady Hall, completed in 1876.

BYLAWS

REVISED JULY 1975

ARTICLE I

The name of this organization shall be: Petticoat Pollys Republican Club of Salem, Oregon.

ARTICLE II

The objectives of this organization shall be:

- (a) To promote an informed electorate through political education.
- (b) To increase the effectiveness of women in the cause of good government through active political participation.
- (c) To facilitate cooperation among women's Republican Clubs.
- (d) To foster loyalty to the Republican Party and promote its ideals.
- (e) To support objectives and policies of the Republican Party's nominees.
- (f) To use program materials for study that are in accordance with, and germane to, the objectives of this organization.

ARTICLE III

Section 1 - Membership:

This organization shall consist of not less than ten (10) registered Republican women, subject to the control and guidance of the State Federation of Republican Women.

Section 2 - Government:

This club shall operate under the provision of these by-laws.

Section 3 - Dues:

- (a) Dues shall be a minimum of four dollars (\$4.00) for women and fifty cents (50 cents) for men, with one dollar (\$1) of the dues set going to the State Federation promptly on collection.
- (b) Per capita dues for the state federation for the fiscal year must be paid to the state treasurer by January 15th of the following year.
- (c) The fiscal year of this organization shall be from January 1st to and including December 31st.

Section 4 -

No woman may maintain voting membership in more than one member club of the Oregon Federation of Republican Women. Associate membership may be granted by Petticoat Pollys Republican Club to any person interested in the success of the Republican Party. Such membership grants the privilege of attending meetings of Petticoat Pollys Republican Club and speaking, but not voting, nominating, or holding office.

Section 5 - Expulsions

Petticoat Pollys may be removed from membership in the State Federation by a two-thirds (2/3) vote of the executive committee of the State Federation for the following reasons:

- (a) nonpayment of dues.
- (b) failure to comply with the objectives of the State Federation.

ARTICLE IV

Section 1 - The officers of this organization shall be: President, first vice-president, second vice-president, treasurer, secretary, and public relations director.

Section 2 - Term of office: Officers shall be elected for a one-year (1) term commencing January 1 following election, and shall hold office until their successors have been installed.

(a) Officers shall be elected to the same office for no more than two (2) successive terms, and shall not hold that office again until a lapse of two (2) years.

(b) Each officer shall take the following oath of office:  
"I solemnly promise to discharge, to the best of my ability, with fidelity and promptness, the duties of the office to which I have been elected."

The oath shall be administered by the president, or in case of her inability to act, by a retiring officer, at the December meeting.

Section 3 - Duties of the president shall be:

- (a) To preside at all meetings of the organization and the board of directors.
- (b) To appoint all committees except the nominating committee, the appointment of chairmen of standing committees to be approved by the board of directors.
- (c) To be ex-officio member of all committees except the nominating committee.
- (d) To appoint a parliamentarian who shall not have a vote.
- (e) To co-sign checks with the treasurer.
- (f) To represent this organization at all times or, when unable to do so, to designate a member of her club as representative.
- (g) To appoint two persons from the membership at large to audit the books of the treasurer.

Section 4 - Duties of the vice-president shall be: The vice-presidents in their order shall perform the duties of the president in her absence, and such other duties as may be assigned them.

- (a) The first vice-president shall be responsible for having the year-book printed and obtaining the necessary and correct data for it.
- (b) The second vice-president shall be program chairman.

Section 5 - Duties of the secretary shall be:

- (a) To keep the minutes of all meetings of this organization and the board meetings.
- (b) To perform such other duties as may be assigned to her.
- (c) To conduct the correspondence of this organization.

Section 6 - Duties of the treasurer shall be:

- (a) To receive and disburse all funds of this organization and sign checks with the president.
- (b) To keep an accurate account of all receipts and disbursements.
- (c) To give a full, written report at the December meeting and as ordered by the president.
- (d) To submit her books annually for audit.
- (e) To prepare a report for the Secretary of State's Office.

Section 7 - Duties of the parliamentarian shall be: Serve as advisor to the President at all meetings of the organization and board of directors.

Section 8 - All officers shall deliver all records, files, and properties of this organization to the newly installed president within one (1) month after retiring from office unless otherwise directed by the president.

Section 9 - A vacancy in an elective office shall be filled by the board of directors at the next meeting following the vacancy.

#### ARTICLE V

Section 1 - The board of directors shall consist of the elected officers, chairmen of the standing committees, the immediate past president, and two members, one elected and one appointed by the president.

- (a) Duties of the board of directors shall be: To be the governing body of this organization, and to approve the programs of action of the standing committees.
- (b) Regular monthly meetings of the board of directors shall be held at a time and place to be set by the president.
- (c) Five members shall constitute a quorum of all meetings of the board of directors.

#### Section 2 -

- (a) No officer or board member shall be a candidate for a remunerative political office.
- (b) No elected officer or board member shall receive remuneration for services in this organization.
- (c) All officers and committee chairmen must be members in good standing of the organization.

#### ARTICLE VI

#### Section 1 -

- (a) A nominating committee of five (5) members, three (3) from the membership at large and two (2) from the board of directors shall be elected at the October meeting.
- (b) The nominating committee shall meet and shall make its report to the board of directors at the November meeting.
- (c) Further nominations may be made from the floor at the November meeting.
- (d) No one shall be nominated who has not given consent to serve if elected.

Section 2 - Election shall be by ballot at the November meeting, and a majority of all votes cast shall constitute an election. Where there is but one (1) candidate for an office, election may be by voice on the motion.

#### ARTICLE VII

Section 1 - All resolutions proposed for passage must be submitted in writing.

Section 2 - Resolutions, exclusive of courtesy resolutions, may only be presented to the Board of Directors of Petticoat Pollys through the Resolutions Committee, and may not take the form of recommendations or motions from individuals or other committee chairmen.

Section 3 - With the exception of courtesy resolutions, resolutions must be germane to the purpose and aims of this organization.

Section 4 - The Resolutions Committee shall have authority to accept or reject, to combine and to edit resolutions, all such actions to be by majority vote.

Section 5 - An emergency resolution is one which is so declared by a two-thirds (2/3) vote of the total voting membership of the organization.

Section 6 - All resolutions presented must be in proper form and in triplicate.

Section 7 - Courtesy resolutions shall be exempt from these rules.

#### ARTICLE VIII

#### Section 1 -

- (a) There may be the following standing committees and any others created by the board of directors as are necessary to carry out the work of the Petticoat Pollys:
  - 1) Campaign Activities
  - 2) Finance
  - 3) Membership Extension
  - 4) State Legislative
  - 5) National Legislative
  - 6) New Citizens
  - 7) Resolutions
- (b) The chairmen of the standing committees shall be appointed by the president, subject to the approval of the board of directors, and shall be members of the board of directors.
- (c) The standing committees shall outline programs of action in their respective fields for consideration and adoption by the board of directors. Such programs shall be presented at the first meeting of each fiscal year.

#### ARTICLE IX

Robert's Rules of Order, Revised and Robert's Rules of Parliamentary Law, shall govern this organization in all matters of procedure not covered in these bylaws.

#### ARTICLE X

Section 1 - These bylaws may be amended by a 2/3 vote of members present at any regular meeting, provided that notice of the proposed amendment has been sent to all members 30 days prior to the meeting.  
Section 2 - Proposed amendments shall be filed with the board of directors not less than 2 weeks prior to the meeting at which it will be presented.



## Razor Blade Radio Receiver

If you'd like to kill some time, or give your CB minded children a little project let them build a receiver that actually works and costs practically nothing.

The actual design of the receiver is on the opposite page. If you follow the simple layout you should have no trouble getting it fired-up in an hour or so.

The longest antenna possible and a cold water pipe ground is best. If a long antenna isn't possible, try hooking the antenna lead to the chrome finger-stop on a telephone dial.

The detector is the piece of pencil lead wrapped with copper wire, resting







### CB Radio Owners to get Temporary Licenses Now

WASHINGTON (AP) - New Citizens' band radio owners will be able to obtain a temporary license to use their sets immediately under a new Federal Communications Commission plan.

An FCC official said that the new licensing procedure should take effect in a month. At the same time, he revealed that the agency has delayed expansion of the 23-channel band on which the sets operate pending solution of a serious interference problem.

Charles A. Higginbotham, chief of the FCC's Safety and Special Radio

Services Bureau, said the commission would formally announce both actions later this week.

He said the temporary permit is intended to end the current licensing logjam that has been created by a nationwide craze for CB radios.

The new system will allow the buyer of a CB set to obtain a temporary license form from a radio store or from the FCC. The 60 day temporary license will be valid as soon as the form is sent to the FCC by certified mail.

Then, pending solution of the jammed-channel problem, all the new owner has to worry about is getting on the air.

Sales of CB radios have soared from 300,000 in fiscal 1974 to 1.1 million in 1975 and are expected to reach 3.8 million this year.

The popularity of the sets for use in business and the family auto has caused chronic jamming on the 23 channels assigned by the FCC to citizen broadcasters. To solve the jamming problem, it was proposed to expand the CB band to 50-plus channels.

"We were all set to go with 50-plus channels," Higginbotham said, "but we got a flood of comments in opposition."

Industry representatives warned that because of the design of the receiving sets, there would be serious interference with anything over 40 channels, he said.

Higginbotham said the FCC will propose several alternate solutions that will allow splitting some channels to one or two sidebands.

Five seldom-used channels now assigned mainly to fliers of model aircraft may be switched to the citizens' band. Higginbotham said this should achieve a minimum of 44 channels and 44 sidebands.

Higginbotham said he expects the channel-expansion question to be set-

tled in about 75 days, allowing 60 days for comment and 15 days for replies.

In the meantime, he said, the current 70-day waiting time for perma-

nent licenses should be reduced by a new system of opening license mail within two or three days instead of 30.

- Channel 9- Emergency channel, not for use between stations. Restricted to emergency use only.
- Channel 10- Truckers. It is still being used, but in a short time vacated to alternate channels.
- Channel 11- National Call channel. Calls being originated and then after establishing contact, switching to another suitable channel. For AM usage.
- Channel 13- Commonly used by marine units.
- Channel 16- National Call channel for Single Sideband usage. Establishing contact and switching to alternate SSB mode channels.
- Channel 17- Alternate Single Sideband mode usage. National truckers SSB mode channel. This channel is being used to give longer range communications between truck and base.
- Channel 18- Alternate SSB channel.
- Channel 19- Truckers (this channel is replacing Channel 10 in many areas in an effort to eliminate interference with Channel 9, the emergency channel).

All C.B. communications are restricted to no more than 5 consecutive minutes, at the conclusion of which you must remain silent for at least one minute.


Independence residents are preparing to doff their hats to the man who put their community on the map.



The Fords then will travel by motorcade to Independence Square to participate in the dedication of the Harry S Truman statue.


