PLATE No. XIV

Man deliberately sets forest fires for this bird! It is probably the rarest warbler in America. His main diet during the breeding season is a worm peculiar to the young Jack pine forests from six to eighteen feet tall. As a consequence this bird is known to breed only in the north central Michigan Jack Pine woods. These stands are periodically burned so there is always a section within that particular height for the birds to feed in.

They nest in thickets at the base of any large tree in such areas. Three to four dull white eggs are lain which are spotted and blotched mostly around the larger end in hues of brown and grey.

One of the very few tail wagging warblers, it is also quite robin like in many of its mannerisms such as walking and its peculiar pose when singing in the treetops.

We are grateful indeed to the people of Michigan for their efforts to preserve this bird.

#### CARE OF REPRODUCTIONS

Frame House Gallery reproductions are of the highest quality that modern printing methods can produce. Two national premier awards-of-excellence have been granted them by the printing industry.

Certain precautions are necessary, however, to preserve these fine reproductions through the years.

Matting and Framing. No print or reproduction should be glued or pasted to a stiffer paper or board. Such dry mounting depreciates the value of the work from the collector standpoint. This applies equally to trimming an art print to fit a frame or mat.

A framer should be willing to guarantee such service, although many will offer differing opinions. "Fast hinging" and "dry mounting" practices are widespread. Regardless, knowledgeable collectors are extremely sensitive to proper matting and framing methods in order to safeguard the value and preserve the reproduction in ideal condition.

#### CARE OF SILK SCREEN PRINTS

Silk screen prints are easily damaged by scratching or rubbing. Sliding one print over another can result in damage. For this reason it is wise to avoid touching the picture surface. If dirt falls on a print, blow it away. Framed silk screen prints should be covered with glass for protection, but should not be dry mounted. When a silk screen print is stored, it is best to keep a protective sheet of paper over it.

#### THE EFFECT OF LIGHT

All paper stocks deteriorate, to some degree, upon exposure to intense light and/or high temperature. Few pigments or inks can withstand the direct, or even indirect or reflected, rays of sunlight. Accordingly, it is strongly recommended that such exposure to a print or reproduction be avoided. A picture so exposed will quickly fade. The paper may become brittle and mottled in a short time.

In effect, quality reproductions and prints should be given the same care as original art.

Additional precautions and information may be obtained from written matter regarding the care and handling of art pictures, or from a reputable framer or dealer.



First of all let me congratulate the Ford White House for its honesty concerning autopen signatures of the President. As a dealer I have never objected to the use of the autopen by any extremely busy executive, but rather I have always objected to the dishonesty of previous administrations concerning the machine. The Ford policy of honesty even in this small matter reflects well on the man himself. He will certainly get my vote next year.

Would it be possible for me to have copies of all the autopen signatures used by Mr. and Mrs. Ford? I have to be on guard for these for the protection of my customers, and I don't believe I have more than one autopen pattern, and that a very early one. I would certainly appreciate any help you can give me in this matter.

I call to your attention a minor international crisis.

It appears that Dr. Mildred Scheel, wife of the President of the Federal Republic of Germany, requested the help of Wendi von Staden, wife of the Ambassador to the U. S. from the Federal Republic, to obtain a personal autograph of the President and of Secretary Kissinger.

She wrote to Henry Catto (copy attached) and was assured there would be no difficulty. More recently, Henry has advised Mrs. von Staden that he cannot obtain the President's autograph; and it has been our policy not to bother the President with requests of this type which come in frequently from domestic organizations. While we do furnish autopenned signatures liberally, we advise the recipients that the President's name has been inscribed by an autopen and that, therefore, it probably has little value for auction purposes.

Although the signature is sought on a savings booklet, Mrs. von Staden said that a signature on a piece of White House stationery would suffice. If you think this is important enough to oblige Dr. Scheel, I suggest getting the President's personal signature on a piece of his stationery the next time you are meeting with him.

Please see below copy of my note to the President and his reply to me.

Mr. President:

May I have a ruling from you regarding whether or not we should autopen U. S. currency.

In July of 1975 I asked Mr. Buchen if it was against the law and received a memo from him saying it was not and therefore we might do it. However, the individual who has charge of the autopen has never been convinced and she has finally persuaded Mr. Buchen to change his mind.

So now, after sending out countless dollar and two-dollar bills autopenned, we are told to discontinue doing so. We have fifty dollars which has been sent in and we have been holding them because of this latest ruling by Mr. Buchen. He now says "it isn't a question of law but a question of policy."

To me, it will be embarrassing to return two-dollar bills to individuals whose neighbors have had theirs signed and tell them now that "it is not White House policy."

Autographing of currency by the President does not raise a legal problem. 18 U.S.C. 333 prohibits the mutilation, defacement or disfiguration of currency with "the intent to render such bank bill, draft, note, or other evidence of debt, unfit to be reissued.... The Secret Service legal counsel has confirmed that neither this nor any other statute prohibits the autographing of currency. The same is true with respect to savings bonds.

In terms of whether this practice is appropriate, it is my understanding that while a member of Congress, the President adopted a policy to autograph currency. Additionally, the attached bills indicate that the Secretary of the Treasury and the Treasurer of the United States apparently feel that this is not a problem. While I agree with you that we should not encourage cash to be sent to the White House, we do not assume the risk when people send it through the mails. In terms of the risk, it is unlikely that people will send in bills of large denominations. Finally, I see no difference between using the autopen on a dollar bill or a picture.

While I appreciate your concerns, I, therefore, defer to Mildred Leonard as to what policy the President wishes to adopt in this area.

#### MEMORANDUM FOR MR. BUCHEN

Phil, to my knowledge paper money sent to the White House in previous administrations for autographing by the President has always been returned to the sender with a note that it is not appropriate for the President to do this.

I note that the attached memo from Mildred says that your office has informed her that it is absolutely not illegal. My question to you is whether it is appropriate. There are many requests of this type. So far the number has been somewhat kept down because the response has always been negative. If we start doing this, however, many individuals will start sending in not just one dollar bills, but bills of higher denomination. We risk problems of lost or misplaced money, complaints by people that the signature is not real, etc. I think that, before the long-standing policy we have followed is reversed, we should think about some of these potential problems and see if it is really worth it. Couldn't we instead return the money and send them an autographed photo?



• Newport got into a tizzy when it learned who Louis de Vautourneaux really was. The slender, well-dressed 17-year-old French lad kept his true identity a secret until his American hosts Bruce and Joy Sundlun took him a week ago Saturday from the Dunes Club at Narragansett to see Newport. That's when Diane Brown, French wife of Captain Nicholas Brown, glimpsed him and called him by his right name — Louis Giscard d'Estaing. Janet Auchincloss invited him over to Hammersmith Farm that afternoon and dinner invitations

began to pour in.

It all came about when French Ambassador Jacques Kosciusko-Morizet called Bruce and told him the French president's son wanted to come to America for a month, was crary about racehorses, wanted to work in a bank and see something of the U.S. The Sundiuns invited him to their Salamander farm at The Plains, Va. and he worked with racehorses at Paul Fout's nearby place, going to Delaware Park with Paul Fout and Virginia Guest van Alen. 
