Please let me know if you require any further information.





Dear Mr. Casselman:

In connection with the file search to locate materials relevant to the Special Prosecutor's investigations, we request that the description of the Townhouse investigation be modified so that request number one reads: "The solicitation, receipt and/or disbursement of funds by individuals working at the White House, by Jack Gleason or by Herbert Kalmbach for use in a program whereby the White House would cause the distribution of funds to candidates in the 1970 Senatorial or Congressional elections." Request number two should be eliminated from the description of that investigation. We are making this modification because we were informed on April 2, 1975, by counsel for Mr. Nixon that the original phrasing of this request was causing documents obviously not relevant to our investigations to be pulled by the archivists.

As we have previously stated, if specific problems such as this one develop with any of our requests, upon being advised of the difficulty, we will make every attempt to clarify them.


Dear Mr. Buchen:






Dear Mr. Ruth:

This is in reference to a copy of the tape recording of a February 16, 1973 conversation between former President Nixon and Messrs. Ehrlichman and Gray, which was turned over to representatives of your office on this date.

Please be advised that the staff of the National Security Council, after reviewing the recording, has recommended that it be classified SECRET, under the authority of Executive Order 11652 (March 8, 1972), as amended, on the basis that certain limited portions of the recording concern intelligence activities relating to foreign governments and matters relating to decision making on military policy. The staff has further advised that if the recording, or a transcription thereof, is to be used in any forum in which the above-described information would be publicly disclosed, that such information be deleted, as part of the declassification and disclosure of the recording. This office and the NSC staff will be pleased to be of any assistance to you in this regard.





Please be advised that the staff of the National Security Council, after reviewing this document, has recommended that the last paragraph on page 7 thereof be classified CONFIDENTIAL under the authority of Executive Order 11652 (March 8, 1972), as amended.

This recommendation is based on a determination that the paragraph in question references sensitive diplomatic exchanges with a foreign government the unauthorized disclosure of which could reasonably be expected to damage our relations with that government and thereby cause damage to the national security. (Note that identical information is contained on page 5 of the document marked "B-227" in envelope C:4/11/75(a). Page 5 was apparently classified "CONFIDENTIAL/EYES ONLY" by the originator of that document. Hence, the classification of document D-142 would be made on the basis of the initial classification given to document B-227.)

This is in reference to the recording of a July 20, 1972, Oval Office conversation between President Nixon and Armand Hammer, a copy of which has been turned over to representatives of your office.

Please be advised that the staff of the National Security Council (NSC), after reviewing this recording, has recommended that it be classified SECRET under the authority of Executive Order 11652 (March 8, 1972), as amended. This recommendation is based on the determination that certain limited portions of the recording contain information concerning foreign nations, the unauthorized disclosure of which could reasonably be expected to cause serious damage to our foreign relations, thus affecting the national security.

The staff has further advised that if the recording, or a transcription thereof, is to be used in any form in which the above-described information would be disclosed publicly, or to unauthorized persons, that such information be deleted as part of any declassification and disclosure of the recording. This office and the NSC staff will be pleased to be of any assistance to you in this regard.

This is to confirm our telephone conversation of last Friday.

As we discussed, the Research Project conducted under the direction of this office is nearing conclusion. Accordingly, it is the intention of the Department of Justice to file appropriate motions in the United States Court of Appeals for the District of Columbia, and, subsequently, in the United States District Court for the District of Columbia, seeking modification and/or amendment of outstanding court orders to permit the transfer of a substantial portion of the "Presidential materials of the Nixon Administration" from the Old Executive Office Building to the Federal Records Center at Suitland, Maryland. These materials have been in the custody of the Administrator of General Services since August 9, 1974, and are subject to the access procedures provided in the Order of the United States District Court for the District of Columbia, entered October 21, 1974, as amended, in Nixon v. Sampson, et al. (C.A. No. 74-1518).

Upon motion of the Government in the above-cited case, both the Court of Appeals and the District Court previously entered orders on May 13 and May 22, 1975, respectively, permitting the transfer of materials of the lowest sensitivity from the OEOB and the National Archives to the Federal Records Center. This transfer was completed on June 9.

We are now seeking to transfer a second installment of materials of limited sensitivity, in which your Office has to date expressed no interest in reviewing. Attached hereto is an inventory list of the materials in question. These materials are identified as the "White House Central Files" and constitute 168 pallets of approximately 24 cubic feet each (4,000 cubic feet). They are currently located in nine rooms (approximately 3,200 sq. ft.) on the 4th floor of the Old Executive Office Building. Removal of these materials will make available much needed office space for assignment to White House Office functions.



The materials would be maintained in an area of the Federal Records Center having security equivalent to that under which they were maintained within the EOB. They would continue to be under the custody and control of the Administrator and would be subject to standing access procedures in accordance with outstanding court orders. If required, and under normal conditions, any or all of these materials can be returned to downtown Washington within 24 hours.

For purposes of filing the appropriate motions, your approval or other views regarding the proposed transfer is respectfully requested.

Your continued cooperation is appreciated.
