Executive Order Establishing the President's Economic Policy Board Log No.: 617

The membership on the board contains no representation of the two government agencies responsible for the competitive aspects of economic policy--the Assistant Attorney General in charge of the Antitrust Division and the Chairman of the Federal Trade Commission.

Both of these officials play important policy roles. The head of the Antitrust Division is required by Justice Department regulations to act as the spokesman for competition within the executive branch. For this purpose it is recommended that the Attorney General be added to membership, for whom the head of the Antitrust Division would customarily sit as his designate. Since the Board is not limited to executive branch officials, there would also be reason to include the FTC chairman.

As pointed out in the OMB memorandum, the FEA administrator is another logical candidate if the board is to exercise comprehensive economic policy authority.

Attached is a proposed Executive order which we have prepared to implement the staff press release, dated September 9, 1974, which, among other things, provides for the establishment of the President's Economic Policy Board.

Since we understand that the proposed press release reflects decisions that have already been made, We have not circulated this proposed Order for comment by interested agencies pursuant to the provisions of Executive Order No. 11030, as amended, relating to the processing of proposed Executive orders. Furthermore, we have not submitted it for the consideration of the Attorney General as to form and legality. If you wish, we can informally submit it to the Department of Justice for a quick legal review.

We note that the Administrator of the Federal Energy Administration was not listed as a member of the Board. We mention this omission because we are not sure whether it was intentional or inadvertent.

## EXECUTIVE ORDER

ESTABLISHING THE PRESIDENT'S ECONOMIC POLICY BOARD, AND FOR OTHER PURPOSES

By virtue of the authority vested in me by the Constitution and laws of the United States, it is hereby ordered as follows:

Section 1. There is hereby established the President's Economic Policy Board (hereinafter referred to as the Board).

Sec. 2. The Board shall consist of the Secretary of the Treasury, who shall be its Chairman, the Assistant to the President for Economic Affairs, the Secretary of State, the Secretary of the Interior, the Secretary of Agriculture, the Secretary of Commerce, the Secretary of Labor, the Secretary of Health, Education, and Welfare, the Secretary of Housing and Urban Development, the Secretary of Transportation, the Director of the Office of Management and Budget, the Chairman of the Council of Economic Advisers, and the Executive Director of the Council on International Economic Policy. The Chairman of the Board of Governors of the Federal Reserve System is invited to attend meetings of the Board.

Sec. 3. The Economic Policy Board shall provide advice to the President concerning all aspects of national and international economic policy, will oversee the formulation, coordination, and implementation of all economic policy of the United States, and will serve as the focal point for economic policy decision-making. The Chairman of the Board shall act as the principal spokesman for the spokesman for Sec. 4. (a) There is hereby established the Executive Committee of the Board. The Executive Committee shall consist of the Secretary of the Treasury, who shall be its Chairman, the Assistant to the President for Economic Affairs, the Director of the Office of Management and Budget, the Chairman of the Council of Economic Advisers, and the Executive Director of the Council on International Economic Policy. The Chairman of the Board of Governors of the Federal Reserve System is invited to attend meetings of the Executive Committee.

(b) The Executive Committee shall meet daily to consider matters involving responsibilities of the Board.

Sec. 5. The Assistant to the President for Economic Affairs shall be the Executive Director of the Board and of the Executive Committee, and, as such, shall be responsible for coordinating the implementation of economic policy and providing liaison with the Presidential staff and with other Governmental activities.

Sec. 6. (a) The Secretary of the Treasury shall be a member of the Council on Wage and Price Stability and be its Chairman (Public Law 93-387). The Assistant to the President for Economic Affairs shall be a member of the Council and be its Deputy Chairman.

(b) The Secretary of the Treasury shall be the Chairman of the Council on International Economic Policy. The Assistant to the President for Economic Affairs shall be a member of that Council and be its Deputy Chairman.

(c) Section 1(b) of Executive Order No. 11269, as amended (prescribing the composition of the National Advisory Council on International Monetary and Financial Policies),

is further amended by inserting after "the Secretary of the Treasury, who shall be Chairman of the Council," the following "the Assistant to the President for Economic Affairs, who shall be Deputy Chairman of the Council,".

(d) (1) Section 1 of Executive Order No. 11789(prescribing the composition of the President's Committee on East-West Trade Policy) is amended to read as follows:

"(1) The Assistant to the President for Economic Affairs."

(2) Section 2 of that Order is amended to read as follows:

"Sec. 2. The Secretary of the Treasury shall be the Chairman of the Committee, and the Assistant to the President for Economic Affairs shall be its Deputy Chairman."

Sec. 7. All departments and agencies shall cooperate with the Board, including the Executive Committee thereof, and shall, to the extent permitted by law, provide it with such assistance and information as the Chairman or the Executive Director of the Board may request.

You have asked my advice concerning the legality of two courses of action concerning NTSB:

Can the President remove the chairman. from the Board?
 Can the President remover the chairman from the position of chairman but have him continue as a member of the Board?

Regarding the first question, 49 U.S.C. 1654(h) provides that the members of the Board shall be appointed by the President, by and with the advice and consent of the Senate, and that they "may be removed by the President for inefficiency, neglect of duty, or malfeasance in office." Because the NTSE has some quasi-judicial functions, I construe this provision as containing the only justifications for removal of a member from the Board. Accordingly, removal from the Board may only be for the reasons set forth above.

I perceive no legal difficulty in removing the chairman from that position for any reason whatseever as long as he is kept on the Board, since the President designates one of the members "from time to time" to be chairman. 49 U.S.C. 1654(j).

At least once in each of the past several years, this Conference's Committee on the Federal-State Relationship has met in Washington with people who are active in the area of intergovernmental relations. Thus, I solicit your selection of a representative whom we may designate as an Advisory Member of the National Conference of Commissioners on Uniform State Laws. Upon his appointment, I would contemplate sending him a list of our active committees so as to determine whether there are any in which he has a particular interest and, if so, to request that he serve on one or more of those committees. I have recently been told that William E. Casselman has indicated a special interest in our Conference.

I will look forward to hearing from you, and I also solicit your thoughts as to the ways in which we may make the advisory membership more meaningful and effective.

A three day meeting of the Advisory Commission on Intergovernmental Relations will begin on Thursday, February 20.

The President has decided to appoint (Senate confirmation not required) the following individuals to this panel:

John H. Altorfer, of Peoria, Illinois. He succeeds Howard H. Callaway.

James T. Lynn, Director of the Office of Management and Budget. He succeeds George P. Shultz.

Governor Richard F. Kneip, of Salem, South Dakota. This is a <u>reappointment</u>.

Governor Philip W. Noel, of Warwick, Rhode Island. He succeeds Dale Bumpers who has resigned.

Robert P. Knowles, of Richmond, Wisconsin, State Senator of Wisconsin. This is a reappointment.

Full field FBI clearances are traditionally required for these appointments.

It would be advisable that the two reappointees and three new appointees attend the meetings. The program this year consists of 350 participants in plenary and round-table discussions. There will be no classified information presented or discussed as most of the participants are members of the public. Essentially, the meetings are a discussion of the theoretic role of the various levels of government with certain case studies. These appointments are for two years and the future effective performance of these members would be greatly enhanced by their attendance at these sessions. As an announcement to the Press was made on February 18, I recommend your approval of a waiver of clearances as a precondition to Presidential signature commissioning the above individuals. The clearance procedure would go forward in any event.

Mr. HUGH SCOTT. Mr. President, I send a joint resolution to the desk, on behalf of myself and the distinguished majority leader, the Senator from Montana (Mr. MANSFIELD), and ask for its

immediate consideration. This resolution has been passed on an annual basis, and I hope that it will be agreed to once again.

The PRESIDING OFFICER. Is there objection to the request of the Senator from Pennsylvania?

There being no objection, the Senate proceeded to consider the joint resolution (S.J. Res. 92) to honor America, which was read the first time by title and the second time at length.

Mr. RHODES. " 'r. Speaker, nearly two centuries ago, in 1790, George Washington expressed in a letter his feelings about the new Government of the United States. He said:

This Government, though not absolutely perfect, is one of the best in the world, of that I have little doubt.

Perhaps, in these days of national stress, we all should stop and think a bit about America-the heritage of freedom we have been charged to maintain. and the advantages of living in a land of opportunity.

We have just such an observance at hand. The 21 days between Flag Day, June 14, and Indepedence Day, July 4, have been designated as "Honor America Days." This is the sixth annual ob199th birthday. Honor America Days is a program that

is nonpolitical, nonpartisan, just simply, purely patriotic. It is a time when Americans should pause to count the blessings that only our freedoms can give, to be grateful to those whose courage and foresight established this great Nation, and to rededicate ourselves to the principles of our Republic, a Government unique in today's world.

I urge that all Americans use this opportunity to honor our great land, and to attend or take part in the festivals, concerts, folklore and craft exhibitions that will be reminders of the rich heritage nearly two centuries of Americanism have produced.

It is with great pleasure that I join the leadership in Congress in recognizing this period—Honor America Days—as a time of gratitude for what we have, and renewal of the spirit, faith, and ambitions that brought forth this Government and its blessings for us, and the freedomloving peoples of the world.

I want to confirm our discussion in which I outlined our tentative plans for the celebration on July 4, 1976. As I told you, we are keeping John Warner informed and as our plans develop, we shall let your offices know.

The American Historical and Cultural Society, sponsors of the Honor America Day, was formed as a non-profit organization in 1969 primarily to encourage a wider observance of our national day and to commemorate our heritage of liberty and freedom. Our efforts in the past have met with considerable praise by the President, Cabinet officers and numerous civic organizations. We regard the bicentennial year as a climax of our planning and sincerely believe it will be a high point in the Year 1976.

As part of our plans for the bicentennial program, I would like to urge upon you an idea which I have considered carefully and which I enthusiastically endorse - having President Ford inaugurate a new national custom by conferring the highest civilian award - the Medal of Freedom - on that day to those Americans who have distinguished themselves in private and governmental careers. The events included in the programs consist of historic commemorative ceremonies, parades, erection of monuments, band concerts, festivals of American folklife, viewing of historic documents in public buildings, contemporary musical entertainment and fireworks displays. The entire program is non-political and non-partisan.

#### I. PURPOSE

- A. Under the terms of the governing statute, the Commission on Revision of the Federal Court Appellate System (the "Hruska Commission" after its Chairman) is required to present its Final Report to the President, the Congress and the Chief Justice by June 20, 1975.
- B. This meeting will allow the Commission to discharge its reportorial responsibilities and permit a review of their principal findings and recommendations.

#### II. BACKGROUND

- A. The Commission was created by Act of Congress in 1972 to study the Federal court appellate system. Members were appointed in early 1973 -- 4 appointed by President; 4 appointed by the Chief Justice; 4 appointed from the Senate; 4 appointed from the House. Senator Hruska was elected Chairman.
- B. The first phase of the study, to make recommendations on circuit realignment, was completed in December, 1974 and resulted in the recommendation that two new realized circuits be created by dividing the present Fifth and Ninth Circuits.

- C. The second phase of the study, to consider the structure and internal procedures of the Federal court of appeals system, resulted in a number of recommendations on subjects such as oral argument, opinion writing, central staff and eased requirements for taking senior status.
- D. The major recommendation contained in the Commission's Final Report calls for the creation of a National Court of Appeals. (The phrase "Mini Supreme Court", which has been used by the press, is objectionable to members of the Commission.)

#### STATEMENT BY THE PRESIDENT

I am pleased to have received today the Final Report of the Commission on Revision of the Federal Court Appellate System. The members of the Commission deserve the genuine appreciation of the country for the wisdom and the energy which they have devoted to this report.

One could not ask for a more dedicated chairman than Senator Roman L. Hruska. His able leadership during the entire life of the Commission is to be commended. The Commission itself is noteworthy, not only because of the superior quality of each of the members, but because it includes leading members of both Houses of Congress, distinguished judges, practitioners and members of the academic branch of the legal profession, thus bringing to bear a wide variety of viewpoints on the important problems which it considered.

It is significant that the Commission heard from individuals and organizations from all parts of the country. This process, and the resultant reports, have served to vividly portray the problems of the courts of appeals, and indeed of the Supreme Court as well.

Certainly, the importance of the Supreme Court, the Circuit Courts, and the Federal judicial system to our society -- and to our people -- cannot be overestimated. We owe these courts the fullest measure of support to assure that they function effectively to meet the ever-increasing demands which our society makes of them.

In the final analysis, our courts function for the well-being of the citizenry. The effective, efficient operation of the judicial system is essential to safeguard our rights and our liberties.

After extensive study, thoroughly documented in its report, the Commission has published its thoughtful and imaginative recommendations for change.

The major proposal calls for creation of a National Court of Appeals designed to increase the capacity of the Federal judicial system, to assure greater uniformity and less uncertainty in the law and to provide some measure of relief to the Supreme Court without impairing its function as our one Supreme Court.

I urge the Congress to give the Commission's recommendations serious study. Because of the importance of these proposals, I pledge the cooperation of the Executive Branch in the course of that review by the Congress.
