
The National Committee for a Two Party System is the outgrowth of '72 campaign efforts. This organization, while inactive, could provide future results for the Party.







"We are losing people and these people are untrained when they go to the city and there is no place for them, so, if we are really talking about solving the problems of the cities and trying to solve the problems of the minorities who go to the cities and fight the problems of race, then you have to start at the roots of the problems."

"We might not be primarily a Utopia, but we do have a concept at Soul City that can be a prime means to revitalize blighted rural areas and stem migration to the large urban areas."

"It's not going to come out an all-black thing and never was an all-black thing and never was intended to be an all-black thing. Among job applications, you'll find that we have a tremendous number of white persons who apply for jobs here, who want to work here, who want to move here period." With the groundbreaking of Soul City, Floyd Bixler McKissick takes a major step in realizing a twenty-five year-old ambition-to create a community in which all individuals can participate equally. This community will be located in the state of his birth, North Carolina.


Born on March 9, 1922, in Asheville, he attended first Morehouse College in Atlanta, Georgia, and then (following an interruption for military service in World War II) North Carolina Central University in Durham. Before departing for Europe and the war, he married Evelyn Williams, also of Asheville. The McKissicks now have four children.


Mr. McKissick studied law at the University of North Carolina Law School (having successfully sued for admittance) and was admitted to the North Carolina bar in 1952 and to the United States Supreme Court in 1955. During his career as a constitutional lawyer he has handled a record number of civil rights cases, including as his clients businessmen, labor unions, and individuals of all races.

In 1963 Mr. McKissick was elected National Chairman of the Congress of Racial Equality by acclamation and in March, 1966, was appointed National Director. During his tenure at CORE, he raised more than three-million dollars for the debt-stricken organization through the application of his considerable skills and experience in the fields of financial and title law.

In the summer of 1968, Mr. McKissick resigned as CORE's National Director in order to devote his full time to helping build the black economy he had first advocated years previously. For this purpose he created McKissick Enterprises, of which he is currently President.

Mr. McKissick is the author of many articles and essays, published in numerous journals, and he was a Columnist for The New York Amsterdam News. He is also a reknowned lecturer and speaker and his first book, *Three-Fifths of a Man*, published by Macmillan, is now in its second printing.

#### SAMUEL C. JACKSON






Soul City's history to-date is the history of ideas and ambitions. The idea came about twenty-five years ago when Floyd B. McKissick first encountered the "universal capitalism" theory of Louis O. Kelso and realized that real equality would be possible only through a position of economic strength. The ambition to build a new town that would embody this principle began to take form when a site in Warren County was found and the first land purchases took place. Significantly, the site that was located is a former slave-holding plantation.

In 1969 the first proposals for funding were submitted and the Soul City Foundation was incorporated to provide social planning for the town. Early the following year the staff of McKissick Enterprises began to move to the site and the new town had its first inhabitants. In the period following, a number of organizations were set up to deal with specific phases of the planning. Health, education, industrial development, physical planning, and many others were, and still are, the subject of intensive study.

In July, 1972, a major breakthrough occurred when Soul City was granted a \$14 million bond guarantee by the United States Department of Housing and Urban Development. The guarantee came under Title VII of the United States Urban Growth and New Communities Act of 1968 (as amended in 1970), the purpose of which was to encourage new town development. Of the 13 projects receiving guarantees under Title VII, however, Soul City is the only one that will be free-standing and not associated with an existing metropolitan area, and it is the only project under the control of a minority-owned developer, McKissick

Enterprises.

A second major step in the growing political reality of Soul City came less than a year after the HUD guarantee, when in May, 1973, the Soul City Sanitary District was formed. A sanitary district is a unit of local government, voter-controlled, with functions similar to those of a municipality or County. The Soul City Sanitary District has the power to proceed with water, sewerage, garbage disposal, and fire prevention facilities, and can levy taxes and issue bonds to support its activities.

For over 13 years Jerry Butler has been creating music; over 15 million in sales for the singles and four million for the albums. Songs like "I Stand Accused," "For Your Precious Love," "Western Union Man," "Never Going to Give You Up," "Brand New Me" and others testify to his outstanding talents. Born in Mississippi, a Chicagoan by choice (he moved there at six and remained a resident ever since). At the age of 16, Butler became-after the death of his father-the sole support for the family. After working as an ice sculpter and a gourmet cook, a meeting with two other young Chicagoans, Curtis Mayfield and Sam Goodin at the Traveling Souls Spiritualists Church, returned Butler permanently to music.

With Mayfield and Goodin, Jerry formed a trio called Butler and the Impressions and began to record for the Chicago based Vee-Jay Records. At eighteen years of age, Jerry, along with Arthur and Richard Brooks, wrote his first hit record, "For Your Precious Love," which he recorded with the Impressions.

Jerry has been involved in every area of music, from publishing to producing, from movie scoring to title song voices-overs (remember it's Jerry singing "Moon River" in "Breakfast at Tiffany's"). He's won Grammies for his hit singles and topped record publication charts as male vocalist. He's started groups and given breaks. Says Jerry, "music is rather a selfish indulgence; if people like my music great, but if they don't that's also cool."

"I've always sung about love because it's the one thing that raises you above the fears of life and death. But although everybody is touched by love, a love song, like preaching can only touch people who want to be touched. A great part of my success is that I have been fortunate to have people in my audience who wanted to be touched."

#### THE SOUL CITY FOUNDATION, INC.

The Soul City Foundation has the responsibility for all social planning for the new community. This responsibility extends from the development of industrial protential to create new jobs to programs for the cultural enrichment of the area's inhabitants. To deal with these various needs, many specific projects have been planned and several are operational. Programs for Cultural Arts, Education, Social Advocacy, and Soultech 1 are underway, and one program, HealthCo Inc., has been spun-off. In addition, the Foundation has plans for legal services and drug abuse programs, and has engaged a consultant to consider the religious life of the new community.

During the summer of 1973, the Foundation, in cooperation with the Neighborhood Youth Corp., offered on-site training and job experience to a number of local young people. Studies of communications necessities, historic preservation of the site, and creation of an Afro-American Park have also been developed.

Soul City is a unique project-the first free-standing new community in the United States. The fact that it will be free-standing raises unique problems in planning. It is the goal of the Soul City Foundation to develop solutions before the problems occur, so that the new town will not only be equipped for the future, but free of the mistakes of the past.

#### THE SOCIAL ADVOCACY PROJECT

Under a Social Advocacy (Planning) Grant, the Foundation planning staff is developing programs and services to meet the needs of the early residents of the new town in the first 1-3 years, with special emphasis on needs of the poor.

Areas of planning are: Job Training, Education, Health, Housing, Historic Preservation, Religious Life, Child Care, Communications, Legal Services, Economic Development, and Cultural Arts.

The project is coordinating its planning activities with State, Federal, Regional, and local agencies as well as with the community-at-large planning groups.

#### THE LEARNING LAB

Soul City's Learning Lab was funded on July 1, 1973. The objectives of the project are to compensate for past cultural and educational disadvantages of minority and low-income white vouth and, through intensive instruction and intellectual and cultural enrichment programs, to prepare these students to succeed academically. Through these supplementary programs for students who are presently failing to achieve their full academic potential, the project aims at creating an atmosphere in the schools in which it will become easier for these students to achieve and for their teachers to teach.

The target population for the intensive instruction and enrichment program is 100 Hawkins Jr. High School students. A broader population for John Hawkins Jr. High will be included in some enrichment activities.








#### THE CULTURAL ARTS PROGRAM

Cultural planning is an essential part of the overall program of the Foundation. Through its activities the Cultural Arts Program hopes to promote self-awareness, expose and affirm the aesthetic expression of the culturally ignored, magnify every condition of human life, and form bridges that will span differences

A Cultural Arts Council, made up of member of the existing community, has been formed to develop various arts programs. Included among the activities being considered are the formation of a choir, dance troop, and instrumental group, the original production of a Broadway show, and an arts and crafts fair. In addition, the Council has held oral communications sessions to further its awareness of the state of the arts in the area.



#### HEALTHCO, INC.

Important in the survival and growth of any community, and of particular significance in a developing new town, is the organization of its health facilities. With this in mind HealthCo, Inc., was originally funded by an Office of Economic Opportunity Grant in June, 1972, to provide health services to the residents of Vance and Warren Counties as well as to the new residents of Soul City.

It is our objective to provide the highest quality of care. Our emphasis is not on crisis care but on the maintenance of "health." To meet our goal we must provide health education, disease prevention, medical care, and dental care-all of which must be coordinated to the needs of individual patients and their families. These services will be housed in a three-quarter million dollar facility that will be completed in the summer of 1974. Even in its design this facility will reflect the HealthCo principle of health with dignity.

The programs of HealthCo, Inc., will be dedicated to the philosophy that health care can be provided efficiently, with the highest quality and dignity, and at a cost that presents no barriers to patients.





#### THE SOUL CITY INVESTMENT CORPORATION

One of the basic premises built into the planning of Soul City is that all inhabitants of the town should have a piece of the economic action. In time this idea will result in industrial profit-sharing plans that will contribute directly to increased productivity and job stability.

We are not waiting for industry to arrive, however, to put into effect this innovative principle. In April, 1971, the Soul City Investment Corporation was formed and since that time has been raising capital, investigating, and carrying out investment ventures. Currently capitalized at about \$25,000, the SCIC now has over 50 stock-holding members, including residents of the area from all walks of life and members of the Soul City Staff.

The corporation's first venture is the development of interim housing for the Soul City project. It has now acquired 9 mobile units and has plans for purchasing 10 more. Future plans for the SCIC include the provision of extended housing, assistance with the incubator factory facilities, a restaurant/motel complex, auto franchise, and many more.

#### THE SOUL CITY SANITARY DISTRICT

On May 23, 1973, the Soul City Sanitary District was established as the first unit of local government for the new town. The sanitary district is voter-controlled and has many of the same powers as a municipality or a county. It is able, for example, to build and operate sewerage and water treatment plants, as well as handle garbage and solid waste and establish a fire department. It can also levy taxes and issue bonds to support its operations.

The Soul City Sanitary District is governed by three Commissioners-Mrs. Evelyn W. McKissick, Mr. Lewis H. Myers, and Mr. James Groom. With funding and funding committments from HUD, the Sanitary District will soon begin construction and operation of facilities, including a water system capable of supplying Soul City for the first five years and a sewerage plant.

# THE WARREN REGIONAL PLANNING CORPORATION

Soul City will be the catalytic force that thrusts an entire region of North Carolina into the economic and industrial mainstream. The task of developing and expanding the industrial potential of Soul City falls to the Warren Regional Planning Corporation, a four-year old non-profit organization.

Since its inception the WRPC has successfully completed a contract, funded by HUD and the State of North Carolina, to develop a comprehensive general plan for the new community and to study the impact of Soul City on the region. WRPC, with funds provided by the Office of Minority Business Enterprise (OMBE) U. S. Dept. of Commerce, has also made a long-range industrial development plan for the area. Currently it is engaged, again with the assistance of OMBE, in developing the legal, financial, and engineering materials needed for HUD approval of Soul City.

After many years of preparation, the WRPC now stands ready to assist the developers in realizing the economic goals of Soul City. Major projects scheduled for the next years include the development of industrial tracts, banks and recreational facilities, housing, health facilities, and a commerical center. As Soul City grows, minority-owned businesses will find ample opportunity to flourish, unhampered by entrenched competition.



Soul City is a tribute to man s ability to dream new dreams and to put those dreams to work, "Governor Jim Holshouser told a crowd of more than 1000 persons gathered at Soul City's industrial park last Friday morning for groundbreaking ceremonies.

Governor Holshouser was one of the many dignitaries present at the park to assist in groundbreaking ceremonies and to pay tribute to Floyd McKissick who in creating Soul City put his dream to work. "Sometimes dreams do work," the governor said in reference to his own dream of becoming governor.

Friday's groundbreaking and the ceremonies surrounding it marked the first step towards. completion of the first construction at Soul City. Long on the drawing boards and in the planning stages, Soultech I is becoming a reality.

Soultech I will be a contemporary structure of steel, precast concrete and solar gray glass. It will include 40,000 square feet of manufacturing and processing space, plus 12,000 square feet of office space. The new facility will house cafeteria and private dining areas, in addition to conference and personnel training facilities. It will be served by a parking area capable of accommodating 200 cars.

Soultech I is the first industrial facility to be developed in a proposed 928 acre industrial park. The park will ultimately provide some 8,300 jobs, according to announced plans.

Among those on the platform with Governor Holshouser were Mrs. Eva Clayton, executive director of Soul City Foundation, who acted as mistress of ceremonies; Dr. Grady D. Davis, who pronounced the invocation; Honorable Johnny Ford, Mayor of Tuskegee, Alabama; Lawrence T. Toal, vice president of Chase Manhattan Bank; the Honorable Howard Lee. Mayor of Chapel Hill; Honorable Claude T. Bowers, chairman of the Board of Warren County Commissioners, Mayor W. A. Taking note of a passing train, Holshouser said: "These trains used to carry people from places in Warren County out to other cities where opportunities seemed greater. Often they found disillusionment and unhappiness. I think Soul City will begin to reverse that trend and soon trains will be carrying people back to Warren County."

Warren County." In his remarks Lawrence J. Toal, vice president of Chase Manhattan Bank, told of how his bank became interested in Floyd McKissick and Soul City, and said its building is the work of black, white and green.

McKissick, in his reply to Governor Holshouser, stressed the fact that Soul City will not be an all-black city, but a place where all people, black, white, Indian, can work toward the progress of all races.

Groundbreaking ceremonies began at 9:30 with a parade from Soul City's administrative section to the proposed industrial park, and ended with exercises at a recreational linner in Durham on Friday night. Among units in the parade were North Carolina A & T Army and Air Force Drill Team; North Carolina A & T Band, Oxford Central Orphanage Band; Norlina High Schools and John Graham High Schools Bands; St. Augustine's College Drill Team, Soul City Foundation, Inc., Learning Lab Float, and Elizabeth City State University Band.

INTRODUCTION A bold new undertaking has been launched by former National Director of The Congress of Racial Equality (CORE) and the Durham Constitutional lawyer, Floyd B. McKissick. He is currently involved in the most ambitious economic development program ever seriously attempted by a Black American -- the development of a new "free standing" community called Soul City.

Currently he serves as President of Floyd B. McKissick Enterprises, Inc., a national company formed to help organize and finance substantial black businesses across the nation, and is President of Warren Regional Planning Corporation, Inc., the technical planning arm of McKissick Enterprises, Inc., Soul City. One of the major projects of the Company is the development of Soul City, a new town in North Carolina. The total development cost for this project alone is now estimated at 90 million dollars.

He is founding father and chairman of the National Committee for a Two-Party System Inc.; a bi-partisan organization composed of all ethnic groups and concerned with effective voting practices.

Mr. McKissick is also past chairman of the National Conference of Black Lawyers; an organization which is composed of Black lawyers and law students who through litigation and monitoring of various agencies deal with local and national policies that directly affect the Black community.

EDUCATION AND BACKGROUND

During his youth, he was an enterprising young man who always managed to find some source of income from self-employment.

He worked while attending Morehouse College in Atlanta, Georgia. In December, 1941, shortly after the bombing of Pearl Harbor, he interrupted his education to enlist in the Army. Before departing to Europe he married Evelyn Williams. They have four children. During World War II on the battlefields of Europe, soldier Floyd B. McKissick looked around and saw the United States Government rebuilding war-torn towns. He observed the engineers, planners, and scores of other techniques at work on this enormous project. The sight was inspiring -- never to be forgotten! After returning to the United States, he completed his education. Years later after practicing constitutional law and being National Director of CORE, his involvements once again led him to seriously think about economic development. Thinking along these lines, he came full circle. This time, however, he acted. And on January 13, 1969, in the office of Secretary of Agriculture, Orville Freeman, he announced his intention to build "Soul City", a new town in rural North Carolina.

Upon returning to civilian life, Mr. McKissick resumed and completed his undergraduate studies at North Carolina Central University, and was the first Black man to attend the University of North Carolina Law School. Having sued for admittance to the UNC Law School the case was decided in his favor in June, 1951; and while enrolled there, led the first group of law students to picket the North Carolina State Legislature demanding that the Law School be accredited. Also, while still in school, he advocated the overthrow of trepass statues which were used to frustrate non-violent direct action campaigns against segregation. (A case he fought to the Supreme Court resulted in a decision which voided hundreds of trepass convictions.)

Mr. McKissick was admitted to the North Carolina bar in 1952 and the United States Supreme Court in 1955. He is a constitutional lawyer licensed to practice law in both the District of Columbia and North Carolina. He is also licensed to practice before the Federal Communications Commission, the Federal District Court of Appeals, the United States Court of Appeals and the United States Customs Courts.

During his career he has handled a record number of civil rights cases. His clients have included businessmen, labor unions, blacks and whites. He directed the affairs of the Durham CORE Chapter and the Durham Business League and Professional Chain, and was State Advisor of the NAACP Youth groups.

CORE In 1963, Mr. McKissick was elected National Chairman of the Congress of Racial Equality by acclamation, and in March, 1966, was appointed National Director. As National Director, he assumed the responsibility for reorganizing CORE both from a business and philosophical point of view. The organization's debt exceeded four million dollars. McKissick, who had served as Receiver and Trustee in bankruptcy, found ample opportunity to use his past experience in revamping the organization. In North Carolina, he had been real estate developer and an approved attorney for three land title companies: The Lawyer's Title Company of Richmond, Virginia; The Commerical Title Company of Dallas, Texas; and The Kansas City Title Company of Kansas.

In the Summer of 1968, Mr. McKissick resigned as CORE's National Director in order to spend full-time helping to build the black economy which he first advanced twentyfive years ago. During his tenure of two-and-one-half years at CORE, Mr. McKissick raised more than three million dollars of which revolved around the Soul City Concept. In August of 1968, McKissick Enterprises was created and incorporated, and thus began the most ambitious land development program ever by a Black American -- the planning and development of a new town.

#### CURRENT ACTIVITIES AND INTERESTS

TS In July, 1972, Governor Robert Scott of North Carolina, Floyd B. McKissick of Soul City, and Former HUD Secretary George

Romney jointly announced a \$14 million guarantee for Soul City bonds. This guarantee was a first in two respects (1) It is the only one of <u>11</u> HUD guaranteed new towns that is "free standing" not the satellite of a major urban area. (2) The first guarantee given to a new town whose principal sponsor is a black owned enterprise.

Being a multi-talented gentleman, a former Visiting Professor at State University of New York, he has written many articles and essays which have been published in numerous journals and was a Columnist for The New York Amsterdam News. He is also a renowned lecturer and speaker, his first book, Three Fifths of a Man, published by Macmillan, is now in its second printing.





### What is Soul City?

A new planned multi-racial community, being built to provide unique economic and social opportunities for the disenfranchised and to bring new solutions to bear on the crises facing American cities.

## The Builder

Soul City will be built by those who will live in it, as well as people of good will from every walk of life. Floyd B. McKissick Enterprises, Inc., a Blackowned and managed company, is the developer and prime mover.

## A Total Community

Soul City is being built so that Black people can participate in capital ownership and control their own destinies. The town will be self-reliant and open to all. It will include shopping, recreation, housing, all municipal facilities, and a sound, diversified economic base.

### Fraternity

All people who so desire, and who respect the rights and customs of others, will be welcomed as citizens and as equals in Soul City. Warren County is approximately 70% Black, but is politically and economically controled by the white minority.

This non-profit organization has been created to deal with problems of education, training, health, and recreation. It will investigate such areas as low-income housing and community participation in economic development. It will assist in planning and developing solutions to the economic and social needs of Soul City and surrounding areas. The Foundation is now feeding daily, one hundred pre-school-age children who live near the Soul City site.

## **U.S. Puts \$14 Million Behind Black Capitalism Project**

#### By Austin Scott Washington Post Staff Writer

The federal government has decided to put up to \$14 million in a black capitalism project, Floyd McKissick's new town called "Soul City" in rural North Carolina.

Housing and Urban Development Secretary George Romney announced jointly with North Carolina Gov. Robert Scott Friday a \$14 million guarantee for Soul City bonds, the first such guarantee given to a new town whose principal sponsor is a black-owned enterprise.

It won't necessarily cost the government anything. Only if Soul City defaults in the bonds it plans to sell to raise development money will HUD step in with funds.

Romney praised the new town in rural Warren County, the only one of 11 HUD-guaranteed new towns that is "free standing"-not the satellite of a major urban area.

It will mean "new hope for people of all races in a county which has suffered severely from a decline in agricultural production and experienced the largest rate of out-migration of any county in the state," he said.

Scott pledged North Carolina's full cooperation in providing manpower training for jobs to be created by industry locating in the new town.

According to McKissick, money raised under the \$14 million guarantee will go toward land development, the first step on the way to building a city out of what is now little more than two red dirt roads crossing in the middle of a farm.

There isn't much to see in Soul City right now except land of North Carolina's fertile Piedmont region.

Three mobile-home offices, a red barn and a guest cabin stand at the intersection of those roads to form the administrative center of Soul City.

A quarter-mile away, past the fre-

almost entirely in terms of preliminary work-shelves of statistical projections, volumes of fund-raising materials, working agreements with surrounding towns and counties.

Warren and Vance Counties, the home McKissick returned to in 1968 after a decade of activity in the Congress of Racial Equality fit many of the patterns of declining rural economies.

They are poor. They have no substantial industrial base, despite a slow trend toward more manufacturing plants. They have no large, medium size, or even small cities. Henderson, the largest town, has 14,000 people.

One hundred years ago cotton and tobacco were the major income sources. "Twelve to fifteen share- only 60 to 70 per cent of its cropping families used to housing projections, but work Soul City land," commented a resident.

But now, as Bernard Thompson, the white adminstrator of the nonprofit Soul City Foundation, put it, "the tractor has done away with the mule, and cotton pickers have done away with cotton pickers."

"A successful small farmer today has got to have a good tractor, a big family with some boys, and about 200 acres," said Mc-Kissick.

So for several generations, the children who grew up in Warren and Vance Counties Bush township Democratic have been leaving in search of opportunity. They go to Richmond, Washington, New and his associates, the old

Now pulpwood is the big- outnumbered the six whites gest industrial empolver in the region, an industry that traditionally requires relatively little labor and drains a county's resources.

Amos Capps, who runs the Amos Capps Lumber Co., the region's largest, was chairman of the Warren County commissioners for 16 years, until he was voted out a year ago.

And from this McKissick hopes to create, in 20 more years, a way of keeping them "down on the farm."

An independent study by California's Urban Interface Group said he could do it, it might take a little longer than the 20 years McKissick, plans on. And it might cost a little more.

But UIG, hired by HUD to determine the soundness of any possible HUD guarantee, said Soul City would "break even" if it "meets maintains all other growth projections."

There are dramatic changes around Soul City. Not in the land, but in political and economic relationship that will ultimately affect a five-county area.

Take the Democratic Party township meetings recently for example. In Nut Bush Township, which contains most of Soul City, 16 Democrats met to elect officers, winding up with, a black chairman, and a white vice-chairman.

It was the first black Nut chairman within memory, and according to McKissick

already there.

After a little parliamentary maneuvering-which included successfully challenging the old township chairman's claim that the meeting was called to fill one vacancy, rather than elect a full new slate of officers, Lewis Myers, Mc-Kissick's son-in-law, was chosen chairman.

The old chairman, a woman, was elected vicechairman.

A similar coup was pulled two years ago, when Warren County became the only North Carolina county to have a black Republican county organization.

There was no Republican party organized in Warren County, Myers explained. A group of prominent blacks. recognizing the potential, changed their registration from Democratic to Republican, quietly organized a slate of officers, held an organizing meeting with their names well publicized which resulted in no whites attending-then presented themselves for certification to the state Republican chairman.

There are so few Republicans in Warren County that "by being a Republican you get cut off from local politics," said McKissick, But the move had other advantages.

The party in power in Washington gets to appoint census takers, for example. In 1970, all but two of Warren County's 15 or so were black.

The party in power gets to appoint poll watchers. For

The result is the Kerr Lake Co., run by a 10-man board of directors, three named by the county government, one each by Henderson and Oxford, and five by Soul City.

Although it's mostly on paper so far, Kerr Lake does have "a commitment from EPA for a \$1.5 million grant." Carey said, and is now negotiating with HUD and the Department of Agriculture for an additional

"We hope for \$5 million,"

He proudly points out that whites and blacks are working together to create the town. But, as has always been the case in the civil rights movement and the black communities that McKissick is a product of, consciousness of race and the history of black America are very high.

Visitors are proudly shown through "the big house," the old plantation house built in the late 1700's which is now a day care and Head Start center.

Because of its history, Soul City wants to preserve it as a reminder of the legacy most of those connected with Soul City have been fighting against most of their lives.

## **Soul City Gets Aid** From U.S.

#### Journal Washington Bureau

WASHINGTON - The federal government has pledged up to \$14 million in loan guarantees for the development of Soul City, a free-standing new community to be built in Warren County, N. C.

The federal aid, announced yesterday by Gov. Robert Scott and George Romney, secretary Housing and Urban Development, is about \$4 million more than HUD officials Greensboro, N. C., and Atlanta had recommended for the project last year.

Soul City is the first rural. 'new town" project to receive federal assistance. Others, like Reston, Va., and Columbia, Md., are on the fringes of big cities.

Soul City is also the first new town project in which the principal sponsor is a blackowned enterprise. Floyd B. McKissick, a Durham lawyer who was once national director of the Congress for Racial Equality (CORE), is the developer.

#### North of Raleigh

McKissick intends to build Soul City on 5,180 acres about 45 miles north of Raleigh, in one of the poorest areas of the state. Warren County is about 68 per cent black.

Romney said development of Soul City would mean "new hope for people of all races" in a county which "has suffered severely from a decline in agriculture production" and 'experienced the largest rate of out-migration of any county in the state.

McKissick hopes to improve the area's economy and slow the migration rate by bringing industry and commerce into Soul City, providing employment and a tax base. The federal aid is contingent on his success in attracting industry to the town. According to HUD, 'major emphasis during the first few years of development will be upon industrial rather than residential construction."

#### New Industry

Scott said the state would provide manpower training for the 18,000 or so jobs that would be created by the new industry. He also said development of Soul City is consistent with the state's over-all economic development plans and is a model of intergovernmental cooperation.

The project was launched in 1969 by Floyd B. McKissick Enterprises, a corporation organized in New York in 1968 to encourage minority-owned businesses. McKissick is president and chief executive officer.

With the help of bank loans and planning grants from the state and federal government, McKissick gradually added property to the original 1810 acres until the present 5,000 acres was acquired.

The community is expected to house 44,000 people in 12,096 homes by the year 2000. There will be garden and medium-rise apartments, townhouses, and single-family homes grouped near stores, schools and recreation areas. Bicycle paths and walkways will be kept separate from roads.

The town center will contain retail stores, offices, hotels and restaurants. Plans call for an educational park to encompass all public schools above the elementary school level.

The plans set aside 1,495 acres for recreation and open space. Included are a 180-acre municipal park next to the town center, five community parks of 33 acres each, and a 160-acre, 18-hole golf course. Three manmade lakes totalling 120 acres will be created in stream valleys, and 700 acres will be left undeveloped as permanent open space.

The Soul City Foundation, a nonprofit organization, is working with North Carolina Memorial Hospital on a prepaid, comprehensive group medical program for residents of the city. The U.S. Office of Economic Opportunity has contributed \$99,000 toward the program.

#### Nonprofit Organization


Water and sewer lines to serve industries, homes and stores during the first four years of development will be provided by Kerr Lake Utilities Co., a private nonprofit firm. Water will be supplied from Kerr Lake Reservoir on the Virginia border.

Eventually the state hopes to create a multicounty water authority to serve Soul City, Henderson, Oxford and other nearby communities.

#### Sewage Treatment

Three stages of sewage treatment will be required. Industries locating in Soul City will have to pretreat all industrial waste and follow strict environmental control standards.

Soul City is billed as a multiracial community, although many white residents of Warren County have expressed fears that it would be an all-black city






## A Not Impossible Dream

A projected new town to be called "Soul City" may have the sound of still another utopian community, but Floyd McKissick's enterprise in black capitalism is intended as no such thing. On the contrary, it is a sane and practical as well as imaginative concept.

The purpose of the project in Warren County, N. C., which for several years has engaged the former head of the Congress for Racial Equality, is to provide neither a commune for the poor nor a scene for devotees of black power. It is rather to create a viable community for black and white alike who have been victimized by the failing agricultural economy of the surrounding area, an attempt to provide them with an alternative to the usually futile drift to the big cities of the North and South.

Mr. McKissick's hope of bringing in small industries and of training people to work in them is well beyond

the dream stage. Gov. Robert Scott has pledged the state's aid in providing manpower training. George Romney, Secretary of Housing and Urban Development, has announced a \$14-million Federal guarantee for Soul City bonds. And James W. Rouse, who developed the new town of Columbia, Md., has helped to work out the details of the planned community.

Credit is due to all these forward-looking men, but most of all to Mr. McKissick for taking the lead. Soul City will take time to develop-twenty years, its founder realistically expects. But long before it is finished and flourishing, its future should be clear enough to arouse the hopes and emulation of other Americans for whom the answer to a sharecropper's poverty is neither the urban ghetto nor Tobacco Road, but rather a new start at a new skill in a new town.



Soul City, North Carolina, a new, planned, multi-racial community represents a bold new alternative to the overcrowded, problem-ridden urban centers of America.

Located in the relatively undeveloped section of eastern North Carolina, the developers of Soul City are creating an entirely new economic complex that will provide jobs and income for a large underdeveloped economy. It will provide economic opportunity for thousands of people who have been denied them in the past.

Soul City, truly representative of the innovative spirit which built America is to be a new community built by the people who will live in it, by the business and industrial organizations who will create its vital economic base, and by a community dedicated to developing an environment with the full range of facilities and services for the good life — an open society in which all people regardless of race, color, or economic status — will not only be welcome but also find opportunities for self-development and freedom.



Soul City represents a major move by private enterprise to solve public problems (the congestion of urban centers, the lack of opportunity for the poor and disadvantaged) by private means.

But while the private sector is moving to develop this new community, the final result will come from the unified efforts of both public and private institutions: from all levels of government, business and industry, finance and banking, educational institutions, and associations.



The Soul City Company has been formed to build the new town. The President is Floyd B. McKissick, a prominent constitutional lawyer and head of Floyd B. McKissick Enterprises, Inc., a firm formed in 1968 to foster minority-owned and controlled businesses.

In addition to the McKissick firm, the development company will consist of the National Corporation for Housing Partnerships, a federally-chartered corporation authorized under the 1968 Housing Act to promote development of low and moderate income housing, and Building Systems Housing Corporation, an affiliate of Building Systems Incorporated, a Cleveland, Ohio based land development and construction firm.

## INDUSTRIAL OPPORTUNITY GITI

#### THE INDUSTRIAL SOUTHEAST

The emergence in the past three decades of the industrial Southeast has been one of the most significant developments in U.S. economic history. Traditionally dependent upon agriculture and the initial processing of raw materials, a major transformation has taken place. 
## THE STRATEGIC LOCATION CALO

Soul City's key asset from the standpoint of economic potential is its strategic location. Through a network of interstate and other major highways and a trunkline railroad system, Soul City is linked directly with three major economic areas:

- The Industrial Piedmont
- The Coastal Plains
- The Mid-Atlantic Northeast Megalopolis

Important aspects in the potential relationship between Soul City's new economy and these regional centers include:

- Access to wide-ranging consumer and industrial markets. Most of the major markets of the East fall within a 500-mile radius of Soul City.
- Industrial inputs for the new plants in Soul City: machinery, tools and dies, basic chemicals and required services.
- Technical support from the research and development facilities associated with the Research Triangle located in the Raleigh, Durham, Chapel Hill area.



Soul City lies directly, therefore, in the path of the major and necessary economic growth pattern of the eastern United States.

## ECONOMIC RESOURCES GITI

#### LABOR

- The Soul City area has a vast reservoir of underutilized labor which is trainable and of great economic potential.
- The Soul City area has a wide diversity of various labor skills.
- Wage rates are among the lowest in the U.S.
- North Carolina has more employment, pays more wages (despite low wage rates), and has more value added by manufacture than any other state south of the Mason-Dixon line and east of the Mississippi.

#### MANPOWER TRAINING

The State of North Carolina has one of the nation's best and most comprehensive programs for vocational training. Two of its Institutes are near Soul City. These programs will be supplemented by job training, provided by training facilities to be established by the Soul City Foundation.

#### WATER

Water is in almost unlimited supply. The Kerr Lake Reservoir (within three miles of Soul City at its nearest point) and Lake Gaston (within 9 miles) provide a capability for delivering over 1 billion gallons of water a day. Plans are underway for the development of a regional water authority to serve Soul City.

The water supply initially will be provided by the developer and the Kerr Lake Utility Company.



## FLOYD B. MCKISSICK FORMS COMMITTEE FOR NATIONAL 2 PARTY SYSTEM POLITICS

KICK-OFF DINNER OCTOBER 12

A nation-wide campaign to advance the cause of the masses of black people has been initiated by Floyd Mc-Kissick, former director of the Congress of Racial Equality (CORE).

"For 40 years, black people have participated in only 50 per cent of the American Political System," the former civil rights activist said recently.

"What did it give us?" he asked.

Answering his own question, he explained that it was far less than what such loyal support had warranted.

As an example, he pointed out that the number of black generals and flag officers had tripled under the Nixon Administration.

"Ninety-four per cent of registered black voters in the nation belong to the Democratic Party," he said. "When Democrats ignore the political needs of black voters, the only recourse we have is to go in the corner and sulk. We need a twoparty allegiance, because a one party alligiance leaves blacks with no alternatives when Democrats ignore the political needs of black voters."

For this reason, McKissick said he is forming a

black organization called the National Committee for a Two Party System.

"Without black support of Republicans, blacks will not be in a position to pressure a Republican Administration to aid their political objectives," he explained.

McKissick said the new organization would officially kick off its drive with a dinner at the New York Hilton in New York City on Oct. 12.

He said the primary goal of the committee is to make the "American Dream" a reality for all Americans, using social and political

progress through economic development its by-word. "This is the real meaning of

Black Power," he contended. Blacks and other minorities must continue the process of integrating American society," he declared.

"But we can only do so by the development of power. The fight of the blacks and other minorities must continue during the 1970's on a level far more sophisticated than the confrontation struggle of the 1960's. It must continue and penetrate the economic and political realm."

McKissick, the developer of Soul City, N.C., said actions of his committee are


aimed at putting Americans on notice that blacks will never again be "herded into one political party or confined to one part of the economic structure."

"It will put Americans on notice that their interests will be pursued through all parts of the economic-poli-

tical system. It will notify the Democratic Party that their captives are free. Free to bargain as men should in our society."



A proponent of "green power." marketing specialist Chuck Smith of Arizona, Friday urged Escambia County minority leaders to pool hard cash resources as an economic leverage for equality.

Smith, board chairman of the National Association of Market Developers for minorities, suggested a "Pensacola 10-36 Plan" to which a viable coalition would pledge \$10 for 36 months as a treasury to develop new economic enterprises and to expand job opportunities.

Such a plan was conceived by the Rev. Lean Smith and set the wheels in motion for "political and economic emancipation of numerities" in Philadelphia, Pa., he said.

Smith, who resides in Phoenix, Ariz., and serves as assistant to the vice president of The Greyhound Corp., spoke from the speaker's platform at a Unity Eanquet sponsored by the Escambia County Coalition in the Municipal Auditorium. The National Association of Marketing Developers (NAMD) offered the coalition a charter for a county association to aid blacks in achieving employment and other economic goals.

In a speech titled "Realities of Ghetto Economics in Pensacola," Smith termed the picture of black economic status in Pensacola as "far from rosy."

"If there is one bright aspect," he said, "it is in the area of home ownership. Blacks in 1960 occupied 5,660 of the city's housing units of which 50.9 per cent were owned by occupants."

However, the medium income of families in Pensacola in 1969 was \$8,305. The medium for blacks here was \$4,533.

In the 1960 census, 90 per cent of the black population resided in racially-identifiable areas. This distribution, according to Smith, remained virtually unchanged in a 1970 census that showed some residential tracts as having no black occupancy, and others with total black populations.

In the 1970 report, 19,674 blacks represented 33.1 per cent of the city's population and 17.4 per cent of "what the Bureau of the Census defines as the Standard Metropolitan Statistical Areas," Smith said.

In interpreting these statistics, Smith said: "The realities of ghetto economics in Pensacola translated into a viable segment of the marketplace comprised of real live people black people — who buy a lot of pork chops, ham, soap, beer cereal, wide brim hats, brand name shoes, hard liquor, bus and airline transportation, automobiles, fried chicken, deodorant, you name it."

He cited as an illustration the soft drink market. "The black family," he said, "spends an average of \$90 a year for soft drinks as compared with \$22 per year by white families."

Smith calculated that Pensacola's 4.366 black families spend \$3,847.40 at the retail level for soft drinks annually. Pensacola's 10,723 white families, according to his figures, spend \$2,359.06. "Thus, blacks in Pensacola hardly constitute a 'special market,' he concluded. "I'd say they are the market."

Unity Day activities are not endorsed by Escambia County National Association for the Advancement of Colored People.




