To emphasize the significance of regulatory reform legislation, of which this bill is an important example.

This bill would repeal the current antitrust exemption which permits States to authorize agreements between manufacturers and retailers to fix the prices at which certain goods are sold to consumers. You have publicly supported this legislation on several occasions as an important part of your regulatory reform program. Its passage was facilitated by excellent bipartisan cooperation within the Congress.
