Response to Mayor Tanzle

In response to my May 24 memorandum to you (see attachment A), you asked what I would specifically like to see the President propose or accept. Frankly, I think the existing proposals toward the unemployment problems of our cities are inadequate. The continued policies of supporting broad economic recovery, General Revenue Sharing and financial incentives for providing private sector jobs in urban areas simply do not respond to the short term employment problems faced in many large urban areas

The President's actions on Title II and the Summer Youth Employment program have responded in part to the Mayor's request. However, the absence of a compromise or alternative proposal on countercyclical and public works legislation leaves us vulnerable to the attack that we are insensitive to the real problems of urban areas, and gives the Democrats the opportunity to continue to lay the blame for inaction on our door step.

By proposing a compromise at a lower funding level than recently passed by the Senate, or an alternative, we could put the ball back in their court and protect ourselves from the criticism that we have taken no initiative to address the near-term unemployment problems. Moreover, I feel some type of short term program has merit.

I think these issues merit review for possible inclusion in an urban policy statement.

In reference to the recent interest in new policy initiatives, I would like to resurrect comments offered by Mayor Tanzler of Jacksonville. As you may recall, Mayor Tanzler and other officials of the NLC met with the President to discuss the Administration's proposals affecting the cities. In response to the President's proposals for job creation, Mayor Tanzler sent the attached letter.

The thrust of this letter is that despite his support for the President's program in the long range, this proposal fails to meet the real problems that cities face in the short term. This letter may well identify some issues that we need to address in a new policy revision as well as any statement we make on the Administration's urban strategy.
