

After our discussion of the Domestic Council staff last Wednesday, the Vice President and I visited with Senator Montoya and Bellmon and provided both with my letter explaining the proposal (attached).

Today the Vice President and I also discussed the staff proposal with Chairman Tom Steed, Representative Clarence Miller and Tex Gunnels. They agree to support the increase in conference if the Senate will include it in the Senate bill, which the Senate is marking up tomorrow.

I talked with Senator Bellmon this afternoon, and he and I believe it would be very helpful if you could telephone Senator Montoya before his subcommittee markup tomorrow, and ask him to include the additional \$920,000 for Domestic Council staff at the Senate Subcommittee markup.

Dear Senator Montoya:

The purpose of this letter is to follow up on the brief meeting yesterday with you and the Vice President, Paul O'Neill and me on the budget of the Domestic Council, and to comply with your request that I submit to you my specific requests, and the justification for the proposed changes.

As we discussed, we are respectfully asking for an appropriation increase in the budget request for the Domestic Council in the Treasury, Post Office and General Government appropriation bill now before the Senate Appropriations Committee. As I also mentioned to you, I have discussed this with the President and he concurs in this request.

More specifically, we are asking for an increase in the President's original recommendation of \$1,320,000 to \$2,240,000, an increase of \$920,000. The purpose of this request is to permit a staff increase from the present level of 30 to a maximum of 59.

As you will recall, the President asked me to assume the responsibility for directing the work of the Domestic Council on February 13, 1975, and at the same time outlined the responsibilities that he asked the Domestic Council to undertake. The President's Executive Budget had by then been submitted to Congress and, of course, it was difficult for me until recently to evaluate the staff needs of the Domestic Council in the light of the tasks assigned to the Council by the President.

Essentially, there are three major areas of responsibility that the President has asked the Council to undertake, all cf which are extremely important to him, and in my opinion, cannot be adequately and responsibly performed within existing staff levels. These three major areas are:

### 1) Day to Day Operations

This responsibility consists of staff work for the President on domestic issues, such as on Presidential meetings, papers on subjects of a relatively short term nature which relate to two or more departments and agencies and which require coordination and resolution; reviewing and helping in the preparation of messages for the Congress, statements, speeches and public statements, etc.; consulting with the Members of Congress; public contacts and intergovernmental relations with the governors, mayors, county executives and other local officials.

#### 2) Review Groups

This task involves setting up, participating in and supervising interdepartmental task forces on a variety of specific subjects of a longer term nature -designed to get the facts, assess them, and coordinate the development of policy options for Presidential decision, and then to work with the Congress in advancing the resolution of important national issues.

The President has approved the establishment of four of these groups in the areas of Social Assistance Programs, Regulatory Reform, Drug Abuse, and Environmental Problems. We anticipate establishing additional review groups.

#### 3) Program Formulation

In the domestic area, the President has asked the Council to prepare, staff and coordinate the formulation of options for his legislative messages and program.

After four and one half months on the job, it has become clear to me that we cannot meet these major responsibilities with the present staff level of 15 professional and 15 support staff.

You will recall also that when the Domestic Council was created in 1970, a staff of 52 was authorized and subsequently increased to 79 in FY 73.

When the former President established the Counselor system, the Domestic Council staff was cut to 30 and the balance of its staff was assigned to the Counselors. When the Counselor system was abolished, the functions, largely operational, were returned to the Domestic Council staff; but the positions were abolished and Domestic Council staff levels were not increased.

It is for these reasons that we feel we need up to an additional 29 persons to assist in our work in the three important areas mentioned above.

Approval of the increase in funds of \$920,000 would permit the addition of sufficient staff to enable the Council to perform much more adequately and responsibly the tasks assigned to it by the President.

I urge your serious consideration of this request and, of course, my staff and I will be available to discuss this with you at any time at your convenience.
