I have discussed the situation with Secretary Simon this afternoon and in light of the arguments presented by Senator Curtis and his obvious personal hesitancy about such a vote, I concur with Secretary Simon's recommendation that we not seek a vote on the deepened tax cuts at this time.

Max Friedersdorf has also reviewed Secretary Simon's memorandum and strongly concurs with his recommendation.

<u>Recommendation</u>: That you approve Secretary Simon's recommendation that we not seek a vote on the deepened tax cuts at this time.

MEMORANDUM FOR THE PRESIDENT

Subject: Proposed Amendment to Tax Reform Act re Deepened Tax Cuts

Last week you requested that we arrange for Senator Curtis to introduce an amendment to the Tax Reform Act now being debated in the Senate designed to implement your deepened tax cut proposal - i.e., your original \$28 billion package. Senator Curtis at first agreed but now believes that offering this amendment at this time would be unwise for the following reasons:

(1) it would be in direct opposition to Senator Long,
who Curtis believes has been doing a good job holding the
tax bill together and preserving the interests of the business
community;

(2) it would put the Republican members of Congress on the spot;

(3) it would raise the entire budget issue again and perhaps produce further extended debate; and

(4) it will lose badly when the vote is taken.

Notwithstanding the foregoing, Senator Curtis offered to call a meeting of the Republicans on the Finance Committee tomorrow morning to discuss strategy and seek a volunteer to offer the amendment if you persist in your decision to have the amendment introduced.

I recommend that you follow Senator Curtis' advice and abandon the idea to seek a vote on deepened tax cuts at this time.
