Dear Mr. President:

This letter is an expression of gratitude tinged with regret on the one hand, and with eager anticipation on the other.

First, Mr. President, let me again thank you profoundly for having given me the opportunity to serve our country as the American Ambassador in Buda-Every callow vice consul aspires to become a Chief of Mission one day. There follow countless hours of drudgery, years of study and more than a few familial sacrifices that test one's resolution and firmness of purpose; but it was well worth every moment of physical and mental and moral effort expended. stern training administered in bygone years by an older generation of Foreign Service Officers served me in good stead. The words of advice and counsel you gave me in the Oval Room on March 31, 1975, have been the source of encouragement and guidance amid the welter of day-to-day events. And I have faithfully executed in letter and in spirit your own personal instructions and those that I received subsequently through the Department of State.

During my service in Budapest the Embassy received magnificent and never-failing support from the Department of Commerce and the Department of Agriculture. Secretary Morton, Secretary Butz, Deputy Secretary of Agriculture Campbell and Deputy Secretary of State Ingersoll made official visits to Hungary. Each helped enormously to expedite the process of normalizing bilateral relations. And only an ingrate could fail to express gratitude for the total support and the comprehensive guidance which Secretary Kissinger, Counselor Sonnenfeldt and Assistant Secretary of State Hartman have always provided with welcome promptness.

The President,

U.S.-Hungarian bilateral relations have flourished moderately but steadily during the past year; and there is good reason to believe that they will, given astute leadership in Washington and cooperation from Budapest, continue that progress in the months and years to come.



After 34 years in the United States Government, I feel that the time has come for me to move out of public life. I pick this date to communicate my decision to you, because I do not want my resignation construed as having political overtones of any kind or as being affected in any way by the outcome of the Presidential Election in November. As for timing, my preference would be to stay on in Tehran until the period between Christmas and the New Year. This would leave only three weeks of vacancy at the post before a new Presidential term begins. I trust that you will find this satisfactory.

It has been a privilege to serve as your Ambassador at the Imperial Court of Iran. May I extend warmest greetings and best wishes for your continued good health and success in the great office you hold.



#### I. PURPOSE

This courtesy call, prior to Ambassador Curley's departure for Dublin, will serve to underscore the great importance you attach to maintaining the United States' traditionally close and friendly ties with Ireland.

## II. BACKGROUND, PARTICIPANTS AND PRESS ARRANGEMENTS

A. <u>Background</u>: Ambassador-designate Curley (biographic sketch at Tab A) will be sworn into office on September 3 at 4:00 p.m. He and Mrs. Curley will arrive in Dublin on September 16. He will present his credentials to President O'Dalaigh on September 18.

US-Irish relations are excellent and devoid of any major bilateral problems. Both countries agree that we should endeavor to develop the relationship beyond our traditionally strong ties of friendship and kinship. An excellent beginning in intensifying the US-Irish dialogue was made during Ireland's first six-month EC presidency from January to June 1975. We intend to continue close consultations with the Irish on matters of mutual concern.

The Irish Government. Prime Minister Cosgrave and Foreign Minister FitzGerald have been in office since March 1973, when the Fine Gael/Labour coalition Government took over from Jack Lynch's Fianna Fail party. The Government's political position is strong; it has yet to face a serious challenge in the Parliament.

The Irish Government, however, faces serious economic problems. Inflation is currently running at an annual rate of 24 percent, and seasonally-corrected unemployment is approximately 10 percent.

Northern Ireland. The continuing problem of Northern Ireland remains the key political issue in Ireland today. US policy is to avoid involvement in Northern Ireland. We believe there is no useful role we could play, and that the issue must be settled by the parties directly involved.

The six counties of Northern Ireland, an integral part of the United Kingdom, contain about one million Protestants and a half-million Catholics. Conflicting aspirations and traditions make the search for a solution acceptable to both communities difficult. A Northern Ireland constitutional convention is now discussing the situation. It has yet to tackle contentious issues, however, and there is considerable doubt that it will produce an organic law for the province which would permit "power-sharing" between the Protestant and Catholic communities -- a prerequisite for acceptance by the British Government. A recent increase in violent incidents has heightened tensions. If the convention fails, immediate prospects are for continuation of direct rule by Britain.

The Irish Government seeks reunification of Ireland through peaceful means, "power-sharing" in the North and an all-Ireland Council to deal with common problems. It is following the convention proceedings closely, but is generally unable to influence the situation in the North.

Your meeting with Ambassador Curley comes on the day of the funeral of the former President of Ireland, Eamon de Valera.

#### III. TALKING POINTS

- 1. You are taking on a very important assignment, and you, Mrs. Curley and your family have my very best wishes as you prepare to depart for Dublin.
- 2. I attach great importance to maintaining and building on the traditionally close and friendly ties the United States has with Ireland -- ties so greatly reinforced by kinship.
- 3. The funeral of former President de Valera today reminds us of the special character of this relationship -- born as he was in New York City and, subsequently, the father of modern Ireland.
- 4. Please convey my best wishes to President O'Dalaigh (O-DALEY) and Prime Minister Cosgrave. As you know, the Prime Minister and I both participated in the CSCE summit in Helsinki just a few weeks ago.
- 5. I have every confidence that you will do an excellent job at your new post in Dublin.



## BIOGRAPHIC SKETCH

## AMBASSADOR WALTER J. P. CURLEY, JR.

President Ford's nomination of Walter J. P. Curley, Jr. as United States Ambassador to Ireland was confirmed by the US Senate on July 23. The new Ambassador was sworn into office on September 3, 1975.

Ambassador Curley's appointment follows a distinguished career in business. After executive positions with the California Texas Oil Company and with the San Jacinto Petroleum Company, he in 1961 became a partner in the private investment banking firm of J. H. Whitney and Company. Ambassador Curley has also been active in public affairs. He is a Trustée and President of the Board of the Buckley School, Trustee of Barnard College, and Trustee of the New York Public Library. In 1973-74 he was Commissioner of Public Events and Chief of Protocol for the City of New York. Ambassador Curley has travelled extensively to and within Ireland, and has had several articles published in Irish newspapers. He is the author of the book Monarchs-in-Waiting, published in the United States in 1973.

Born in Pittsburgh, Pennsylvania on September 17, 1922, Ambassador Curley received a B.A. Degree from Yale University in 1944, and a Master's Degree in Business Administration from the Harvard Business School in 1948. During World War II he was an officer in the U.S. Marine Corps, and received several decorations and citations.

Ambassador Curley is married to the former Mary Taylor Walton of Pittsburgh. They are the parents of a daughter, Margaret, and three sons, Patrick, John and James.
