


## LOS ANGELES AND VICINITY

SCALE: ONE INCH EQUALS APPROX. 5.1 MILES







**DISNEYLAND** — Exit from the airport on Century Blvd. to the San Diego Frwy ... go south on the San Diego Frwy to the Garden Grove Frwy (Highway 22) ... go east on the Garden Grove Frwy to the Harbor Blvd. off-ramp ... turn right on Harbor Blvd. (north) and continue approx. 2-1/2 miles to Disneyland.

Funds raised over the \$3.2 million which the RNC may use to support the President's campaign will be designated for key Congressional and Senatorial campaigns.





**Meany and Carter wave to supporters before Carter's address to union leaders**

Later Carter received a roaring welcome and another pledge of all-out assistance from AFL-CIO President George Meany and other leaders of the labor group.

Meany said that the AFL-CIO and other union organizations had put together "the best political machine in the country" and were now "ready for the big push" to elect Carter and his running mate, Sen. Walter F. Mondale of Minnesota.

The union leaders approved an elaborate program to register voters, "educate" them about the differences between Ford and Carter, and get them to the polls in November.

Meany said that labor would provide "millions of volunteer hours, millions of telephone calls and massive mailings," all paid for by the unions and not charged to Carter's \$25 million campaign fund. (Both Carter and Ford get \$25 million from the federal government to run their campaigns, and can accept no other direct contributions.)

In a speech to the General Board of the AFL-CIO, Carter set out the main lines of the basic economic argument he will be making during the fall campaign.

Noting that Ford wants to run on his record, Carter said the record included the worst combination of inflation and unemployment in the 20th century.

He repeated his bold claim that, if elected, he can achieve full employment and stable prices, balance the budget and meet the country's needs

—all without expanding the government's share of the national output.

He also criticized Ford as a President who is "limited in ability, timid in leadership, afraid of the future."

Carter spent part of the day previewing some of his campaign plans for state Democratic chairmen.

He made it clear that he intended to run a populist campaign, staying away as much as possible from party "big shots" and wealthy contributors. Instead, he said, he wants to spend his time with "the average voter — in factory shift lines and shopping centers, barber shops and beauty parlors."

"I spent too much of my time in the last few days going to receptions with maybe 60 people who could afford to give \$1,000 each," Carter said. "I'm going to break away from that as much as I can."

Democratic National Chairman Robert Strauss said that Carter would ride a voter-registration train that will leave New York City on Sept. 20 and travel through New Jersey and Pennsylvania, ending with a rally in Pittsburgh that night.

The train will continue through Ohio and Indiana to Chicago the next day, with Mondale aboard in place of Carter.

**THE NEW RULERS OF THE AMERICAN POLITICAL SYSTEM**

Mr. GOLDWATER. Mr. President, on August 31, the same day that I presented to the Senate a statement describing big labor's effort to gain control of the American political system, Jimmy Carter, the Democratic Presidential candidate, was huddled in Washington, D.C., with the bosses of big labor. When Mr. Carter left the Capital City, he took with him what a Washington Post staff writer called a ringing endorsement from organized labor.

According to news reports, AFL-CIO president, George Meany introduced Mr. Carter to a gathering of several hundred union leaders as "our candidate." The Washington Star reported that after speaking to the labor audience, Mr. Carter "had a private luncheon with some of the labor leaders." What went on at that closed meeting is unknown.

What the public does know, the Star indicated, is that Mr. Meany disclosed that he was setting up a steering committee of labor leaders to meet every 2 weeks to make sure that "our machinery is working to promote Mr. Carter." The story in the next morning's Washington Post revealed that Mr. Meany had also promised "an intensive campaign" on behalf of Mr. Carter by labor's political organization, which Mr. Meany proclaimed is "the best political machine in the country."

As the Carter-labor dialog was described in the New York Times of September 1:

Top labor leaders promised Jimmy Carter today that they would stage "the strongest most effective get-out-the-vote campaign ever conducted by the labor movement" this autumn.

The same article disclosed:

After [Mr. Carter's] speech before the general board of the A.F.L.-C.I.O., the board adopted a resolution of support that said victory in November would "require millions of volunteer hours, millions of telephone calls, massive mailings and the personal commitment that trade unionists bring to politics."

We also know that Mr. Carter welcomed these pledges of help from big labor. He is quoted in the Washington Star as telling union bosses:

That they could make the difference between his winning or losing the election Labor's help was badly needed.

Mr. President, big labor itself has openly confirmed exactly what I claimed in my speech of August 31. Union bosses are intent upon controlling this year's elections—will make greater efforts than ever before—and have enormous resources of the very kind required to get around the restrictions of the new election law.

Mr. President, among the evidence of organized labor's attempt to capture the American political system that appears in my earlier statement is a listing of union contributions to candidates for the U.S. Senate. An additional item has come to my attention since then, and in order to keep the list as current as possible, I am today revealing the updated figures, as follows:

Now, there is a very interesting fact hidden among all this data. Note that nearly all labor contributions to Senate campaigns have gone to Democrat candidates. The respective totals are \$1,590,267 given to the Democrats compared with only \$58,928 contributed to Republicans. The Republican share of union largess is a barely visible 3 percent.

Mr. President, in the interest of further updating information which I compiled in my original remarks, I can state with assurance today that the true amount of total contributions by big labor, both in direct cash payments and in-kind efforts, to try to put their candidates in office by the 1976 elections will be an astounding \$70 to \$100 million. This will be the greatest attempt ever made by labor bosses in America to gain control over Government and the future of the Nation.

**CORRECTION OF THE RECORD**

Mr. GOLDWATER. Mr. President, on August 31, I placed in the Record a lengthy statement concerning the influence which labor unions are attempting to wield in the forthcoming political campaign. In my list of contributions made by organized labor to incumbent Senators seeking reelection and to other candidates for the U.S. Senate in 1976, a contribution of \$4,500 to Senator LOWELL WEICKER, Republican, of Connecticut, and a \$2,500 contribution to Gloria Schaffer, his Democrat opponent, were inadvertently omitted. The Senate total should be \$1,649,195.

### THE MOOD AND SPIRIT OF GENERAL CONVENTION

On September 26, Canon Chapman's sermon focused on the Spirit of God moving through the mood and process of the recent General Convention of our Church, and at the discussion group a panel of those who attended the Convention spoke in the same vein, seeking to convey a sense of the tone in which our fellow Episcopalians sought to deal with issues which were potentially divisive.

At last Sunday's services we distributed copies of the final issue of the General Convention daily, which summarized not only the main events and decisions in Minneapolis, but also sought to communicate the mood and spirit of that historic meeting. (Extra copies of this paper are available in the Church Narthex and the Church office.)

The House of Bishops' Pastoral Letter, issued immediately after the Convention, seeks to convey the urgency of maintaining that commitment to unity in the Spirit. It states:

... "At Minneapolis we accepted the Proposed Book of Common Prayer as a companion to our present Prayer Book for the next three years. We also voted to open the priesthood and episcopate in the Episcopal Church to women. We cannot yet begin to see in all their

far-reaching effects the consequences of these decisions. All we know is that the future belongs to the Lord as does the present and as does the past.

"The actions taken by the General Convention at Minneapolis—and our response to them—require that we look anew at the source of our unity. We plead that no hasty actions be taken by any person or group which would even appear to breach our oneness in Jesus Christ or our fellowship with one another in the Church.

... "Continuity in the apostolic church does not reside solely in a continuous repetition of customs unchanged, be they worship, order or service. Apostolic continuity is preserved in spirit and substance, not merely in forms and structures. Where love and unity, where worship and outreach are evident, there is the Spirit . . ."

Here at St. Paul's, whatever our convictions may be on individual issues, we have an opportunity to respond to that call by our Bishops to demonstrate in our life here the same kind of prayerful response to the Spirit which seemed to be so manifest in Minneapolis.


Anyone interested may come to this first meeting free of charge. At the end of the meeting a period of registration will be offered.

Any people who are shut in and cannot get down to the Cathedral will be visited in their homes.

We have ordered 600 doses of the vaccine, so that we can handle everyone who wants to receive a Swine Flu shot. The program, of course, is under the supervision of a physician. Mrs. Tigges will also administer the vaccine to residents of Brent Manor.



Background on Pulaski Parade

Casimir Pulaski, a Polish cavalry officer, was under thirty when Benjamin Franklin advanced him funds to sail to America. Pulaski was given the top cavalry command under General Benjamin Lincoln in the Southern Campaign. He was killed while charging British lines at the head of his troops before the battle of Savannah in 1779.

Pulaski is honored by one of the four corner statues in Lafayette Square along with Thaddeus Kosciuszko, another Polish officer who served with great distinction in the American Revolution.



## Buffalo

Buffalo, the second largest city in New York and one of the most important industrial centers on the Great Lakes, has financial problems and high unemployment. The city is one of the Nation's leading steel producers and grain millers.

The city has a black population of 21 percent and an ethnic population of 28 percent. The two largest ethnic groups are the Poles and the Italians. The mix of blacks and ethnics has produced racial tensions. The city also has a large Catholic population.

Buffalo teachers recently went back to the classroom after a four-week strike, which delayed implementation of a school desegregation plan. There is busing, and it is not being well-received.

One of the major reasons for Buffalo's financial problems is a heavy welfare load. The city is trying legal methods to try to get more state and federal money to help with welfare. The welfare tally also includes the unemployment payments.



## Politics

Senator Jim Buckley is trying for a second term against Patrick Moynihan, who won a hotly contested Democratic primary. This is a tight race with Moynihan favored. The attached article tells about a recent Moynihan incident in Buffalo.

Four Congressional districts involve sections of Buffalo. The 36th includes Niagara Falls and parts of suburb Erie County and a few blocks of Buffalo. The District, formerly represented by Republican Henry Smith, is considered a basically Republican area, but the Democratic incumbent, John LaFalce won comfortably in 1974. Dr. Ralph Argen, an internist, is the Republican candidate. He has raised lots of money, is considered a good candidate, and may have a good chance of defeating LaFalce.

The 37th is the main Buffalo district, and it is heavily Democratic. The incumbent, Henry Nowak, was first

elected like LaFalce in 1974. Since the district even voted for McGovern, he's a solid favorite to be re-elected. His GOP opponent, Calvin Kimbrough, is a black, who works in a Federal training program.

The 38th, which is primarily suburban Erie County, is Jack Kemp's district. He made the best showing of any Republican in New York State in 1974, and is not expected to have problems with his Democratic opponent.

The 39th, formerly Republican Jim Hastings' district, is now represented by Stanley Lundeen, who won the special in March, 1976. Lundeen isn't expected to have problems defeating his young GOP opponent, Richard Snowden, an insurance agent.

Carter had a noticeably cool reception in Buffalo recently despite the unemployment problem. A recent poll in the Buffalo newspaper showed the President within two percentage points of Carter!

SYRACUSE—As Daniel Patrick Moynihan was stilling a gossipy crowd of Democrats at a highly successful fundraiser in the Syracuse Hotel here last Wednesday, a leading Democratic officeholder whispered to his companion:

"Pat's got it locked up—unless he makes another bad boo-boo."

Moynihan squeaked out a grimace.

He forgot that most municipal unions are viewed even by labor-oriented Democrats as tax-devouring evils, a switch in political thinking that has converted tax-paid unions with swollen pension plans and extravagant fringe benefits into a social issue with highly negative ramifications.


