THE BOLD NEW ALTERNATIVE

The "new town" of Soul City is planned as a totally open community providing opportunity to all of its residents. Over a 30-year period 5,287 acres will be developed to create an urban environment in a rural setting that will attract and hold a youthful population from both rural and urban areas. It is expected that Soul City's residents will be younger than those of the surrounding region, with household heads primarily in the 25-44 age bracket.

Preparation of Soul City's master development plan is based upon three factors: the free-standing concept, the features of the land, and Soul City's orientation to human goals.

Soul City's free-standing location will substantially affect the pattern of development. Since Soul City cannot depend upon major existing population to consume its services, the prime developer—The Soul City Company—has given industry first priority in development, for creating job opportunities is basic to the success of Soul City. It is projected to have 24,000 jobs by the year 2000.

As the number of industries grows, the town will expand its residential and commercial areas, eventually allotting a third of its land for housing, about 18 percent for industry, 5 percent for commercial development, 11 percent for institutional use, and a sizable 28 percent for community parks and recreation and for natural open spaces.

Soul City will eventually have 8 villages or communities with approximately 6,000 residents in each village. Each of the villages, which will be built one at a time, will include one or more elementary schools, an activity center, and other facilities.

Much of the basic physical planning for this new community has been completed, and road construction has been started, underground utilities will soon be under construction, and a regional water system (with neighboring towns of Oxford and Henderson) will be operative within three years. Construction of HealthCo's facilities for a comprehensive health delivery system for the area and construction of Soultech I, an industrial incubator to encourage business and industrial development, is scheduled to begin in the near future. Negotiations with several industries planning to locate in Soul City will be completed soon. Plans for economic development are now being coordinated with housing plans, so that upon completion of the first industrial facility, housing will be completed, and municipal and other services will be available to residents.

While the development of Soul City is occurring, the advantages for development are great. The terrain is low and rolling, with streams, small ponds and evergreens interspersed in the landscape; the soil is sound, and weather mild. The mean temperature is 59.9°. Transportation is excellent. The Seaboard Coastline Railway runs through the Industrial Park. Interstate I-85 (N.S.) is one mile from the site and I-95 (N.S.) is approximately 35 miles to the east. I-40 (E.W.) links between Raleigh and Durham, via I-85. U.S. 1 and 158 form the Northern boundary of the site. Thus, Soul City is connected with the major metropolitan markets in the Industrial Piedmont, the Eastern Seaboard, and the Midwest and Pacific Coast. Strategically Soul City is located within a 500 mile radius of one-third of the population of the United States.

Kerr Lake gives the area abundant water and an important outdoor recreation center. Numerous major universities are in easy driving distance. Among them are the University of North Carolina, Duke, North Carolina State University, North Carolina Central University, Shaw, St. Augustine's and East Carolina University. In close proximity is the State Capitol, many cultural centers and historic sites. The Duke-Green House, an original antebellum mansion is listed in the National Register and on site. The area offers great opportunity for continued and diversified growth.

These advantages, combined with the trend of manufacturers to locate in small towns and communities to reduce expenses, give Soul City a great potential for development as an industrial urban center. The continued national demand for products currently manufactured in the region—textiles, apparel, wood furniture components, and processed agricultural products—makes the industrial outlook positive.

One of the goals of Soul City is to improve the quality of life for the residents of rural North Carolina counties which make up its environs; to offer a life of opportunity and fulfillment to those who wish to return to rural North Carolina from an equally deprived if different existence in the cities.

Three dominant land use areas will give the town a distinct urban-type character in a rural setting: 1) the industrial area, 2) the Soul City Plaza, and 3) the Educational Park. The Industrial Park has been concentrated at the northern border of the site because of its accessibility to major transportation corridors and because of the flatness of the land. Conceived as a series of industrial parks this area will be the major employment center in Soul City.

Directly south of the Industrial Park is the Soul City Plaza, the Town Center, which is designed as a major regional shopping, office, government, entertainment complex; the melting pot and meeting place for Soul City residents and non-residents.

The third major special land use area anchors the southern end of the main street. This is the Educational Park, which will provide all educational services from junior high level to the university level. Elementary schools will be located in each residential village.

Other major elements of the thirty year plan are: the Activity Centers, residential development plans, community parks and recreation facilities. Approximately 13,200 housing units will be built. The eight distinct residential villages will be comprised of a planned mix of single family detached, townhouses, garden apartments to mid-rise elevator apartments grouped near the activity centers and adjacent to elementary schools.

Pedestrian walkways and a Bikepath system will connect major activity points in the town. The traffic pattern will also eliminate truck traffic inside the residential areas.

Nearly 1,500 acres of land within Soul City are designated for recreational and open space use. Five community parks will be scattered throughout the new town in addition to the major municipal park of 150 acres. The remaining areas, over 900 acres, which are characterized by heavy tree cover and stream valleys, 120 acres of man-made lakes, including a boathouse, will be retained as permanent natural forest and wildlife areas.

# BE Halts Soul City Contract Talks

By PAT STITH

A federal agency has broken off negotiations on a \$320,000 contract to Soul City's planning agency because of questions of conflict of interest on the part of Floyd B. McKissick, founder of the Warren County development, The News and Observer has learned.

Alex Armendaris, director of the Office of Minority Business Enterprise (OMBE), on March 19 ordered negotiations halted ending a study by the agency's attorneys of alleged past, current and potential conflicts of interest involving McKissick.

daris took the action because of a recent series of stories in The N&O. These articles raised questions of possible conflicts of interest on McKissick's part because of his roles with forprofit and nonprofit organizations connected with the Soul City project. He heads the forprofit development firm and the federally funded planning agency that is assisting his development.

The OMBE halted negotiations with Warren Regional Planning Corp. on the new twoyear contract but allowed the firm to continue to operate under a two-month extension of its present contract. No addi-A federal source said Armentional funds were allocated.

The agency has given the planning corporation \$864,640 in contracts since 1972, with most of the money used to plan aspects of McKissick's Soul City real estate development and to provide "technical assistance" to one of McKissick's for-profit firms.

McKissick told The N&O in January that the federal government had approved and in some cases encouraged his associations with Soul City organizations, both profit-making and nonprofit.

For example, McKissick drew a salary from Warren Regional Planning Corp, in 1972 to direct a government-funded project to promote an industrial program for his real estate development.

He said he didn't think the government would have contracted with the planning agency "unless I agreed to be the project manager."

The Soul City project, announced in 1969 by McKissick, has received about \$19.5 million in federal funds and loan guarantees to support McKissick's plan for a "new town" in the rural area. So far, there are no completed permanent buildings and no industries. The few residents live and work in mobile home structures.

On three occasions, dating back to 1972, federal auditors who reviewed OMBE contracts have raised questions about potential conflicts of interest on the part of McKissick, but the auditors have been all but ignored by the OMBE, according to federal documents obtained by The N&O.

After the series of stores, Armendaris ordered the inquiry by the agency's chief counsel, but the inquiry has not been completed, according to an agency official.

Warren Regional Planning Corp.'s current \$333,140 contract was to have expired March 31, according to Harold B. Jones, deputy director of the OMBE regional office in Atlan-

Jones said the planning agen-

cy would operate for the next two months on money left over from that contract.

It was learned that Armendaris also considered a 1973 federal audit in his decision to hold up the new contract.

The Department of Commerce, which audits OMBE contracts, has not resolved financial questions raised in an August 1973 audit of expenditures of \$65,264 by the planning corporation.

John I. Hickman, vice president and executive director of Warren Regional Planning Corp, said Monday he had not been told the contract negotia-

tions had been terminated because of potential conflicts of interest involving McKissick. He said the new contract was not signed because of "a backlog of work" in the Department of Commerce.

The N&O obtained copies of federal documents raising questions about McKissick's relationship with the Warren Regional Planning Corp. The documents said:

The planning agency used federal funds to make loans totaling \$27,486 to McKissick Enterprises, a for-profit corporation founded by McKissick. The loans were repaid in March of

- OMBE gave the planning agency a \$257,500 contract to plan an industrial program and recruit industries to McKissick's real estate development in 1972-73. In 1973, OMBE gave the planning agency another \$274,000 to provide "technical assistance" to McKissick Enterprises.

-The planning agency used federal funds to pay more than \$2,000 in premiums on a \$200,000 insurance policy on McKissick's life. McKissick's wife was the primary beneficiary of the policy.

-Federal auditors found in

August 1973 that McKissick Enterprises had overcharged the planning agency for rental of office space. The agency was charged \$4925, but the rent should have been \$866.

OMBE records obtained by The N&O also showed that auditors from the Department of Commerce warned the agency on at least three occasions of potential conflicts of interest involving McKissick.

In an audit evaluation issued in May 1972, the auditors said, "Since McKissick Enterprises Inc. will apparently benefit from the work to be performed under the Office of Minority Business Enterprise contract, we recommend that the Office of Minority Business Enterprise's legal representatives review this situation prior to contract definitization in order to avoid any potential conflict of interest.

Another audit report issued in August 1973 said McKissick "has or expects to have an interest in each corporation concerned with the development of Soul City.

The report said, "It is quite evident that he could personally benefit financially from each of the corporations which exist or will be established to build

Soul City."

OMBE officials decided in May 1972, one day after the first warning, that "there is nothing in the nature of the relationship between McKissick Enterprises and the Warren Regional Planning Corp. that would lead to a conflict of interest situation."

A General Accounting Office audit, requested last month by Sen. Jesse A Helms, R-N.C., and Rep. L. H. Fountain, D-N.C., is almost certain to in-

## Funds Curtailed For Soul City

WASHINGTON (AP) - A Commerce Department official said Thursday that the department would not spend any more money on Soul City pending an investigation of possible conflicts of interest in development of the North Carolina "new town."

The planned community is headed by former civil rights leader Floyd B. McKissick.

(The News and Observer, quoting government sources, had reported the government's actions in its Thursday morning editions.)

Edward McDonald, a spokesman for the Commerce Department's Office of Minority Business Enterprise, said no new funds would be committed pending an investigation prompted by "questions raised by Department of Commerce audits and allegations raised in recent newspaper articles."

McDonald said the Commerce agency is continuing to negotiate a tentative contract with the Warren Regional Planning Corp. — the nonprofit organization in charge of overall development of Soul City to replace one that expired per said.

March 31. But no new contract will be signed until the investigation is completed, he said.

In the meantime, Smith said, the planning organization is working under a temporary 60day extension of its old con-

That means that the agency can provide no new money for Soul City, but that \$121,000 left over from the old contract is still available for expenses run up during the extension period.

McKissick, who is the former national director of the Congress of Racial Equality, (CORE), announced in 1969 that he would develop a new town in North Carolina controlled by blacks but open to

The News and Observer, in a series of investigative reports on Soul City, traced \$5 million paid out so far by six federal agencies under various programs designed to spur regional economic development or the growth of planned communities.

Dear Alex:

I read in the morning newspaper of April 10, of the fact that OMBE has on March 19, 1975, halted its contract negotiation with Warren Regional Planning Corporation (WRPC). The story seems highly unlikely since not only was I not informed of it (I was then serving as Chairman of the Board of WRPC), but Mr. Hickman was in fact negotiating on the proposed two-year contract after that date.

Furthermore, I read with even greater interest the allegation that the reason for the alleged halt was a conflict of interest in regard to myself. This is very curious indeed since WRPC works in Soul City, but does not provide services for The Soul City Company, the development company of which I serve as President and General Partner.

It seems clear to me that this press attack is nothing more than one newspaper's attempt to halt the successful movement of blacks into profit-making enterprises. This is the same newspaper which consistently branded this project as all-black even when it knew better. The editor personally told me nearly five years ago that he considered Soul City to be a case of "benign segregation" because blacks were in the majority.

This newspaper, as you know, has been on an anti-Soul City campaign for quite some time. Their main reporter on our case is a master of presenting certain facts correctly and obfuscating the truth by innuendo. He has alleged that we have spent \$5,000,000 in developing the new town. He knows better since he has all the facts. Furthermore, of the subject \$5,000,000 he can find only \$65,000 of questioned cost. And, you of course, are aware that the auditors here already accepted more than half of these expenditures. Most of the remaining questions relate to technical deficiencies only.



The News and Observer's real complaint is that I am a Republican and our good liberal democratic friends can't stand to see us leave the fold.

On the matter of conflict of interest neither I nor OMBE have anything to hide. Every transaction has been done openly and without personal gain. Every federal agency has procedures for approving interested party transactions. So far as I can see there have been only a few potential conflicts and each of these has been approved and found not to constitute a conflict.

The first instance was when we received our initial contract and I served both as paid staff and an officer. This was suggested and approved by your predecessor, however. The second instance was when your office approved the assistance to Floyd B. McKissick Enterprises, Inc., (MKE) in closing the HUD new town guarantee. At that time I served as chief executive officer of both MKE and WRPC although I received no compensation from WRPC. This arrangement was carefully coordinated with HUD and as you are aware MKE was not permitted to make one penny of profit from the HUD Closing. In fact, in the seven years since I created MKE, not one dollar of profit has ever been distributed. Furthermore, the possibility of profit in the foreseeable future is remote. MKE's only function now is as a General Partner in The Soul City Company. The Company has projected annual deficits until 1986 and does not project a surplus on a cummulative basis until 1996.

Based on these facts, where is the conflict of interest? As I understand the role of OMBE it is to assist profit-making minority businesses. Soul City will in fact, if successful, during the next two decades be one of the major vehicles for creating new and expanded minority enterprises in this nation. One newspaper is apparently attempting to thwart that goal because it doesn't like our politics.

On March 24, incidentally I tendered my resignation as Chairman of the Board of WRPC, and the resignation was accepted on April 9, 1975, by the Executive Committee. John Hickman has, I believe, done an excellent job and has grown considerably during his year with us. I am hoping that the Board will now give him the full authority to run the operation under its direction.



I understand from John that he will be meeting with the Atlanta office to negotiate the new contract. So far as I know those negotiations are proceeding well. I will continue to keep in touch.

#### B. Financial Interests

Neither the Warren Regional Planning Corporation (WRPC), its officers or staff have any substantial financial interest in a minority business enterprise, with the exception of Mr. McKissick. Mr. McKissick, the President and Project Director for the WRPC, is of course a major stockholder and President of McKissick Enterprises, Inc., the developer of the new community of Soul City.

#### C. Affiliation

The WRPC has no corporate affiliates, subsidiaries, or branches. It was formed by principals of McKissick Enterprises, Inc. to serve as a technical and planning arm of Soul City. It is controlled solely by an independent Board of Directors.

D. The Warren Regional Planning Corporation was incorporated December 4, 1969, in Warren County, State of North Carolina, for the purpose of engaging in the activity of planning the orderly economic and physical development of Warren County, North Carolina and adjacent areas.

WRPC received funding from the North Carolina State Planning Division in 1970 to plan Soul City and its potential impact on a two-county area. The corporation has completed all work under contract to the State and is now ready to enter into a second-year planning contract with the North Carolina State Planning Division.

Our goal is to insure a high level of competency in the area of physical planning for Soul City and surrounding areas.

This letter is in partial response to your request of November 8, 1973 regarding business activities of myself, other Staff and Board members of the Warren Regional Planning Corporation (WRPC).

The only current staff member with any significant interest in any minority owned enterprise is myself. While I do not have any major holdings in any such company I do own five (5) shares of McKissick Enterprise stock and have a very modest interest in the Soul City Investment Corporation. I also serve as Vice President of McKissick Enterprises without compensation. Additionally I will have a interest in the Madison-McKissick Development Company, a corporation which has been chartered but has not yet been organized and no stock has been distributed to date. Madison-McKissick Development Company does have a contract to develop a health facility in Soul City for HealthCo, Inc. a non-profit corporation.

It was nice talking with you by phone today in regard to the above named matter. As I advised, we need the assistance of Senator Javits in securing the above funding for the Soul City Foundation. Senator Javits has been more than helpful to me personally, to CORE and to the Soul City project throughout the years, and we are indeed grateful for the support he has given us.

The Community Services Administration advises that funds are not now available for funding of the project. As you know, OEO agreed with HUD and OMBE to assist in our industrial development at Soul City.

This proposal is designed to expand the Foundation's efforts to develop a comprehensive program of human and economic planning for the residents of the new town of Soul City and the surrounding counties of Vance and Warren. The program builds on the achievements of earlier OEO grants to the Foundation, notably grant #40475-F-73-01, dated June 11, 1973, for the construction of the first industrial facility, Soultech I, in Soul City. (For your information, attached please find the grant correspondence of June 11, Statement of OEO Grant and Budget Summary.) Through this Special Impact Grant, totaling \$568,875, the Foundation has constructed a building valued at \$1,500,000 upon completion (July 15, 1975). Construction has acted as a catalyst for other construction at Soul City and provided 87 jobs to area residents (in a period

when unemployment is nearly 30% in Warren County); and when leased the building will provide a sizable number of manufacturing jobs. The Foundation is now creating a CDC to own and operate the facility; this new CDC will begin with a viable undertaking and a resource base from which to plan and develop other ventures.

It is on the basis of this kind of achievement that I am requesting your help in assuring the continuation of the Foundation's work. The objectives of the current proposal are as follows:

- Develop detailed short and long-range plans for services in the area of manpower, social and special services, education and recreation.
- 2. Provide administrative and technical assistance to a community development corporation which will own and operate Soultech I, and to provide additional equity (\$80,000) to cover Soultech's overrun and to provide the CDC an adequate financial base.
- 3. Undertake research to facilitate the Foundation's development of coordinated social, human and economic programs for the residents of Soul City and the contiguous area.
- 4. Provide administrative support to all personnel hired through funding from sources other than this grant.
- 5. Develop further methods and means for assuring long-term economic self-sufficiency of the Foundation itself.

It is my understanding that the Community Services Administration has funds available and is currently making grants. The merits of this proposed program and the achievements it is based on eminently qualify the Foundation to receive a continuing grant.

This is to follow up my telegram requesting a conference in regard to the Soul City Foundation's proposal to the Community Services Administration, in the amount of \$291,328, submitted January 1975.

The proposal is designed to allow the Foundation to expand its efforts to develop a comprehensive program of human and economic planning for the residents of Soul City and the surrounding counties of Warren and Vance. The program builds on the achievements of earlier OEO grants to the Foundation, notably a one-year grant for Social Advocacy Planning and a Special Impact Grant for the construction of the industrial facility Soultech I. With this latter grant (#40475-F), totaling \$568,875, the Foundation has constructed a building valued at \$1,500,000 upon completion (July 15, 1975). Construction has acted as a catalyst for other construction at Soul City and provided 87 jobs to area residents (in a period when unemployment is nearly 30% in Warren County); when leased the building will provide a sizable number of manufacturing jobs. The Foundation is now creating a CDC to own and operate the facility; this new CDC will begin with a viable, economic undertaking and a resource base from which to plan and develop other ventures.

One of the objectives of the Foundation's current proposal is to provide administrative and technical assistance to this new CDC, while also providing additional equity (\$80,000) to cover Soultech I cost overrun and give the CDC an adequate financial base.

The other objectives of the program are to:

- Develop detailed short and long-range plans for services in the areas of manpower, social and special services, education and recreation.
- Undertake research to facilitate the Foundation's development of coordinated social, human and economic programs for the residents of Soul City and the contiguous area.
- 3. Provide administrative support to all personnel hired through funding from sources other than this grant.
- 4. Develop further methods and means for assuring long-term economic self-sufficiency of the Foundation staff.

In January 1975, Mrs. Eva Clayton, Executive Director of the Soul City Foundation and I met with you in regard to this proposal and submitted a draft for discussion. We were given every encouragement to expect funding and were informed that we had given your staff sufficient lead time to examine ways in which the program might need refining.

In the intervening months, we have had no feedback whatsoever from the national office. Letters from regional OEO officials stating objections to funding through their office have focused almost entirely on fear of duplication with the local CAP agency, Franklin-Vance-Warren Opportunity. Though these objections have been answered, the position of the regional office has remained that funding should come through the national office.

As you know, the Foundation's present grant ends June 30. Without further funding, continuation of its work will be almost impossible. I cannot too greatly stress the urgency of need for this organization's efforts, both for Soul City and the surrounding area. The Soultech I grant has allowed the Foundation to lay the basis for creating a successful CDC; it is my understanding that under recent legislation, the Community Services Administration can make grants for CDC's specifically to develop industrial parks. Certainly this new CDC falls within this area. It is my further understanding that the Community Services Administration has funds available and is currently awarding grants.

# Soul City Audit Publicity Sought

The Interfaith Committee of Soul City has asked that a General Accounting Office (GAO) audit of Soul City be made pub-

The GAO audit was requested in March by Sen. Jesse A. Helms, R-N.C., and Rep. L. H. Fountain, D-N.C., following a series of articles about Soul Eity in The News and Observ-

Spoksmen for Helms and Fountain said Monday that both men had planned to re-Jease copies of the GAO audit report, which is expected to be completed in August or September.

The Interfaith Committee of Soul City said in a press release Monday that it stood "solidly esie and with Soul City and Floyd McKissick." McKissick is president of the for-profit firm that is developing Soul City, a "new town" in Warren

County. The News and Observer reported in March that Soul City organization formed by McKis-sick and his partners had spent more than \$5.2 million in federal grants, contracts, loans and loan guarantees but, so far, there no industries, no shops,

and no houses at Soul City.

Most of the federal assistance to Soul City ame after McKissick, a former nationa director of the Congress of Racial Equality, (CRE) switched his party registration to Republican and headed a national committee to re-elect then-President Richard M. Nixon.

The press release said the committeepassed a resoluton on May 22 stating "there is literaly no person, agency or in-stitution which has verified any of the serious charges" made by The N&O.

The committee's resolution

said the development of Soul City was "on schedule" and that "private and government audits have continually af-firmed the finances and prog-ress of the project."

The committee's release did not mention a House Appropriations Committee report, which states that McKissick's Soul City project is not on schedule. Nor did the press release mention government and private audits which question expenditures by Warren Regional Planning Corp., a federally funded Soul City planning agency headed by McKissick.

The Interfaith Committee was organized in March 1974 to develor religious ministry for

develop religious ministry for Soul City and to support human and social service programs, accordning to the press release.

Members of the committee national and state church officials, residents of Vance and Warren counties and employes of various Soul Ciity organizations formed by McKissick and his partners, according to a spokesman for the committee.





Dear Otto:

Today is Monday, August 18, 1975, and again we are faced with the inability to get decisions vital to the success of our project from your office. We, therefore, request the following actions from HUD in order to speed the project along, which in effect saves money for the government. I will enumerate our major concerns so that a reply can be made according to the number and subject matter.

- 1. We need approval of our Title I Discretionary Grant in the amount of \$750,000 to \$1,000,000 as you have promised. You are certainly aware that our sewer program depends on this grant and thus the fate of our development.
- 2. We need immediate approval of the Covenants. We cannot at this time make a sale of any properties to any persons as the Covenants run with the land. Do not forget that we are required to have 300 basic jobs during our first three years and more than a year has expired. We now have two companies seeking to lease all of the manufacturing space in Soultech and a third possible one. We are now in a position to choose one of these companies to locate in Soultech. Either of them will satisfy the 300 job requirement. The lease agreement, however, is dependent upon approval of the Covenants. Industries are hard to get. The condition of the economy speaks for itself. You demand that we get industries and yet you place us in a position of being unable to contract and complete our negotiations because of your inability to make speedy decisions.

- 3. The Soul City Foundation Social Planning Contract: We are requesting immediate approval of the contract which we wish to enter into to provide social service planning for the project. The terms and conditions have been thoroughly investigated by us and we know of no other party which can perform the services for us at the price that we have agreed to pay. In our original papers to HUD, we agreed to create the Soul City Foundation for the express purpose of doing the work that we now seek to have them perform for The Soul City Company.
- 4. We have been seeking for more than a year approval for 25 units of 236 housing for this project. To date this approval has not been given us. We would appreciate your efforts to secure immediate approval in this regard within the next two weeks. We have a list of numerous persons, non-affiliated with Soul City, who seek to purchase or rent in Soul City and we do not have the ability to absorb them. Again, this is occasioned by the lack of approval of the Covenants and the 236 housing.
- 5. We seek immediate approval of the contract for The Soul City
  Company to occupy office space in Soultech I. We must pay
  \$6.00 per square foot in order to execute a lease. You had
  indicated that a letter was on its way, but to date we have not
  received same. Presently, Soultech stands completed, but vacant
  except for the exhibits which we cannot set up because we do
  not have an agreement. The process of continuing to delay
  decisions is unfair to the use of our intelligence in saving
  ourselves money which would inure to the benefit of the government.
  This brings about criticisms from the Congress which could easily
  be avoided.
- 6. We also need approval to purchase the Peete tract, which matter has been in your office for sometime now. Remember that we have acquired our initial industrial base if we can contract with the companies. All of our consultants and Partners concur that we should buy this tract and your own consultant also agreed.

In addition to the companies seeking to lease Soultech, we now have two major blue chip and nationally known companies interested in locating in Soul City—one would purchase up to 500 acres of land, the second one approximately 100 acres. To meet our industrial marketing goals we need to buy more land, build a new spec building, and obviously be able to sell.

We are in the unique position of being unable to talk on a sound business basis with these companies, or with anyone else for that matter. It is for the above reasons that I request that urgent approval be given to each of the matters listed above.
